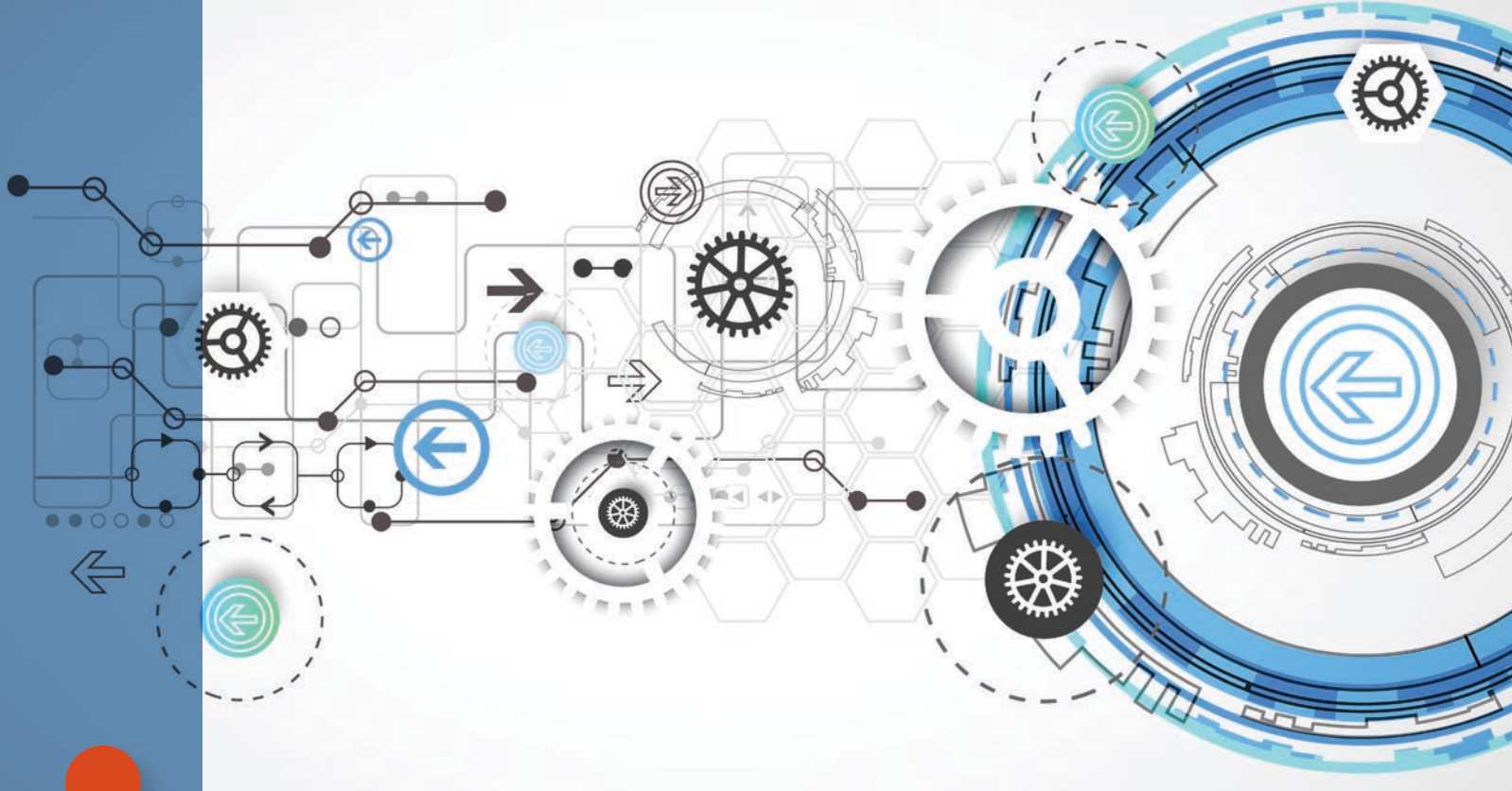

# Foreword

In the rising tide of bad news about climate change, it is easy to feel pessimistic. The task of halving emissions by 2030 seems insurmountable. The stakes are high, the threat to global development is serious, and the road to success is murky, at best.

This book provides a ray of hope for the global effort to tackle climate change. It shows that decades of rapid innovation and targeted investment in low-carbon technology (LCT) are paying off. The tools we need to curb most emissions are at our fingertips—in the form of commercially proven LCT that is becoming less expensive and more widely available each year. In fact, two-thirds of the emissions reductions needed by 2030 can be achieved through the mass deployment of existing technology in just four sectors: energy, industry, transport, and buildings.

Yet this book also highlights the degree to which the world's most vulnerable economies are excluded from the promise of these technological solutions. Huge swaths of the globe—especially the poorest countries—are almost completely absent from the LCT market as buyers, sellers, or innovators. Low-income countries accounted for just 0.01 percent of global LCT exports and 0.3 percent of global LCT imports in 2015–16. High-income countries produced 80 percent of all LCT innovations between 2010 and 2015.

Most future emissions are expected to come from developing countries. People in the poorest countries already are at the highest risk for climate-related disasters. With so much at stake, this raises an obvious question: Why aren't more low-income countries adopting readily available LCT solutions?

The answer involves the most fundamental challenges of development. Transferring technology is a process of collaboration and learning that requires human, physical, financial, and organizational capital—inputs that are scarce in developing countries, particularly in low-income economies. To boost LCT to the necessary scale, developing countries encounter several obstacles. The up-front costs of LCT are high. Using them effectively requires complementary investment in infrastructure, such as power grids and transmission lines. And their success ultimately requires governments to create policies that displace entrenched firms and fossil-fuel based technology while providing long-term incentives for decarbonization.

Given these obstacles, there is an urgent need to facilitate the transfer of technology to developing countries. This requires getting energy prices right, building human and institutional capital, supporting LCT investment through de-risking mechanisms, and introducing policies that support the uptake of LCT. This is the central message of this book: It is technically feasible to contain global warming to 1.5 degrees Celsius by using existing LCT—but only if it is deployed on a massive scale in developing countries.

Achieving the Paris Agreement goals is perhaps the greatest challenge of our time. To solve it, national and international strategies for low-carbon development should be strategic, comprehensive, and bold. The recommendations in this volume can help governments design smart, equitable, and politically feasible policies that put countries on the fastest path to a low-carbon future.

# Executive Summary

## INTRODUCTION

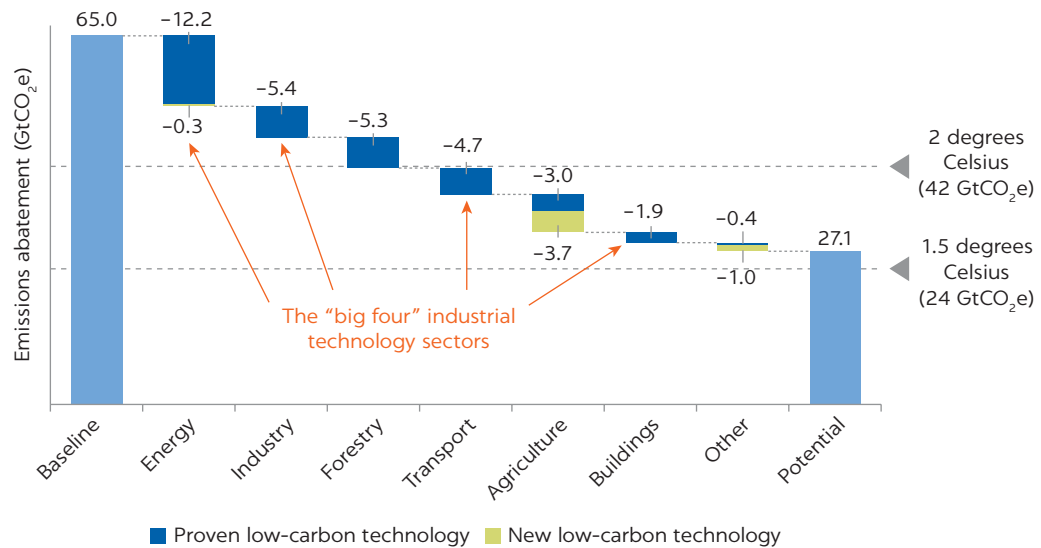
*This report is a call to action. It argues that most of the emissions reductions required to achieve the Paris Agreement goals can be reached through the global deployment of existing and commercially proven low-carbon technologies (LCTs). Deploying them at the necessary scale will not be easy, but the evidence clearly indicates that it can be done, and this report describes how.*

Technological revolutions have increased the world's wealth to a level that was once unimaginable but at the cost of accelerating climate change and ecological devastation.<sup>1</sup> To limit global warming to between 1.5 and 2.0 degrees Celsius, in line with the Paris Agreement, the world's greenhouse gas (GHG) emissions must decline to net zero by 2050 and become negative in the second half of this century. Achieving this target will require a rapid and systemic transformation of the energy sector, starting with energy conservation and efficiency and the progressive replacement of fossil fuels with renewable energy. It will also require the widespread deployment and mass-scale transfer of low-carbon technologies<sup>2</sup> from high-income countries to the developing world, which this report refers to as the North and South, respectively.<sup>3</sup> Although countries in the North have produced the bulk of global GHG emissions, most of future emissions are expected to occur in the South, underscoring the urgency of accelerating North-South LCT transfer.

Without new mitigation policies, emissions are likely to increase to about 65 gigatons of carbon dioxide equivalent (GtCO<sub>2</sub>e) by 2030. This amount is roughly 41 GtCO<sub>2</sub>e higher than the maximum level—24 GtCO<sub>2</sub>e—necessary to contain global warming to 1.5 degrees (UNEP 2017). However, most of the necessary emissions reductions can be achieved by deploying existing, commercially proven LCTs globally, while stopping deforestation. Expanding the use of existing LCT in four major sectors—energy, industry, transportation, and construction—could narrow the emission gap by almost two-thirds (figure ES.1).

Like other forms of technology, the process of developing, adapting, and deploying LCT requires large up-front capital investment, but the returns to that investment are influenced by the presence of complementary infrastructure and the conduciveness of the policy framework. Moreover, the capital sunk into the incumbent fossil-fuel value chains and established high-carbon industries creates both economic incentives and political pressure to maintain the carbon-intensive status quo. The uncertainty regarding prospective policy changes, such as the introduction of carbon pricing or the elimination of fossil-fuel subsidies creates disincentives to invest in LCTs. Without access to adequate policy support and long-term financing, investments will continue to be biased toward conventional, high-carbon technologies.

Historically, energy transitions have been gradual processes that take at least 50 years. However, several examples of faster transitions create hope for the swift deployment of LCT. These include the rapid adoption of nuclear power in France and the spread of combined heat and power plants in Denmark in the late 1970s and early 1980s. Well-designed policies and investments have helped reduce the cost of renewable-energy technologies: between 2010 and 2018, the costs per gigawatt of installed capacity fell by almost 80 percent for utility solar photovoltaic, 54 percent for energy storage, and 22 percent for onshore wind (IEA 2019). Estimates of the unsubsidized cost of renewable energy technologies relative to existing coal generation suggest that renewable-energy technologies are among the least expensive in the United States—and the cost of wind and solar may be even lower when explicit or implicit subsidies are included (Gillingham and Stock 2018). Meanwhile, the average time taken to install one gigawatt of renewable energy dropped from 2.6 years in 2013 to 1.9 in 2018. While further reductions in capital and time costs will be necessary to speed the deployment of LCT across the South, these trends are encouraging.

## Beyond combatting climate change, the global transfer of LCT represents a major development opportunity for low- and middle-income countries

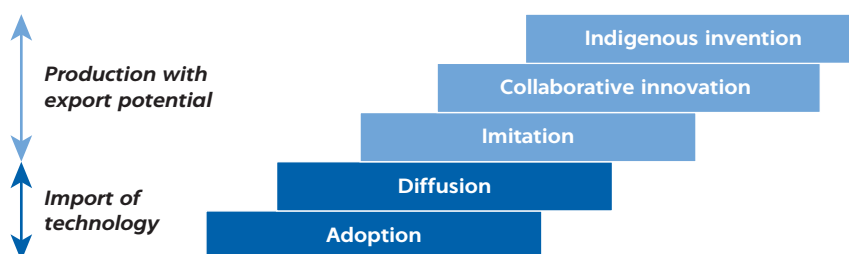
Over the past two centuries, cross-national differences in the adoption rate of new technologies have accounted for as much as 75 percent of the divergence in per capita incomes between developed and developing economies (Comin and Mestieri 2018). Policies to accelerate the deployment and adoption of LCT can expand energy supply and improve energy security, enhancing economic prospects by accelerating productivity growth while improving the public welfare through gains in utility access and environmental quality. Fast-growing LCT sectors also provide opportunities for firms in developing countries to integrate into global value chains, creating new drivers of economic growth and job creation. Countries with the absorptive capacity and competencies to adopt LCT and innovate are more likely to attract foreign direct investment (FDI), accelerate technological advancement, boost productivity through spillovers, and capitalize on increased export competitiveness.

### Transferring LCT is a process of collaboration, learning, and adaptation

Effective technology transfer encompasses not only physical hardware (e.g., solar panels and wind turbines) but also the technical know-how and capabilities necessary to understand, operate, and maintain new technologies, as well as institutional and policy arrangements that facilitate technological uptake and encourage local innovation (Lema and Lema 2012; Sampath and Roffe 2012; Cirera and Maloney 2017). Thus, LCT transfer is a process of learning and interactive collaboration. To be sustainable, it requires the capabilities to deploy, operate, maintain, adapt, improve, and reproduce the transferred technology and, ultimately, the capacity to invent new technologies. This process can be visualized as the “technology-transfer staircase” (figure ES.2), which shows the different stages of technology transfer, from the importation of foreign technologies by firms and households (adoption and diffusion) to the adaptation of those technologies to the local context (imitation and collaborative innovation) to the domestic creation of new technologies (indigenous invention). The first two steps of the ladder rely on imports, but the next three offer the possibility of developing and producing technologies for export.

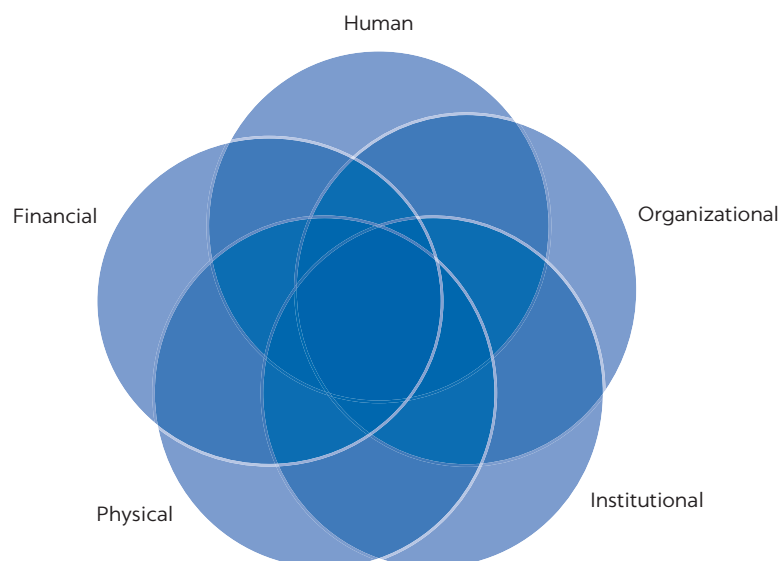
Firms and households benefit from imported technology, but local firms initially lack the ability to significantly modify or reproduce it. As domestic capabilities develop, countries become able to diffuse imported technology more widely across economic sectors. Eventually, domestic firms acquire the capacity to imitate foreign products and production methods, but they still rely on intellectual property developed and owned abroad. Collaborative innovation between domestic and foreign firms (for example, through joint ventures) begins to create the domestic capacity to develop original technologies, conferring some degree of local control and ownership over the technological upgrading process. Ultimately, the country's domestic research and development capacity evolves to the point that it can produce, commercialize, and potentially export technologies based largely or entirely on locally owned intellectual property. However, progression up the technology staircase is not automatic, and countries can languish for years or even decades at the lower steps.

### **Climbing the technology staircase requires an increasingly complex system of capabilities**

Progressing to higher levels of technological sophistication requires complementary inputs, including human, physical, financial, institutional, and organizational capital, which are often scarce in developing countries. This scarcity largely explains why so many countries in the South underinvest in importing and diffusing foreign technologies. As a country progresses up the staircase, firms and workers require ever-increasing skill levels, culminating in the capacity to develop new and original products. Meanwhile, governments must provide the institutional and administrative framework necessary to support the economy's growing technological complexity, including public investment in education and physical capital (figure ES.3).

Reaching the last step of the staircase presents significant challenges for both public and private sectors. This report finds that, across countries, human capital is the strongest predictor of high performance in LCT trade and innovation, followed by institutional and physical capital.<sup>4</sup> Economies with greater endowments of human, institutional and physical capital tend to import and export more LCTs and to innovate more. Human capital also appears to be among the most important factors for accelerating LCT transfer *within* countries. Moreover, countries that have growing economies, large markets, and a deep base of productive capital are better positioned to make the large upfront capital investments required to diffuse, produce, and export LCT. Organizational and institutional capital appear to matter more for importing than for exporting LCT. Finally, financial-sector development marginally encourages LCT imports, but the observed effect is surprisingly small. This finding indicates that strategies to improve educational outcomes, increase the infrastructure stock, or build institutional capacity may be more effective in accelerating LCT transfer than efforts to deepen the financial sector.

Recognizing the pivotal role of North-South LCT transfer in reducing GHG emissions, this report is designed to assist client governments in defining national strategies to facilitate LCT adoption, absorption, and innovation. The next section of this executive summary describes evolving trends in international LCT transfer, as proxied by trade, FDI, and patent data. The analysis is complemented by a case study on the rise of the electric vehicle (EV) industry in China, which has successfully leveraged domestic policies to produce, and export LCT. This example and other cases from the international literature offer lessons for how policymakers can help adopt, deploy, and produce LCT in the context of their capacity constraints and development objectives. The final section concludes the executive summary with a concise review of policy options for accelerating North-South LCT transfer.

## KEY FINDINGS

### **LCT represents a growing share of global trade, but the world's poorest countries are the least able to benefit from trade in LCT**

This report finds that LCT represented roughly 4 percent of global trade in 2016, but its growth rate has outpaced the growth rate of global trade over the past several decades. LCT exports grew at a compound annual growth rate of 11.1 percent from 1990–2016, exceeding the growth rates of total exports (9.7 percent), merchandise exports (6.0 percent), and all high-technology exports (3.4 percent). The North accounted for more than 70 percent of total LCT exports and 62 percent of imports by value in 2016.

Within the South, low-income countries accounted for just 0.01 percent and 0.3 percent of total LCT exports and imports respectively in 2015–16. South–South trade in LCT has increased, but it has yet to have a transformational effect on low-income economies. Moreover, although the South has become more integrated into LCT trade networks, the world's poorest countries remain on the periphery. South–North LCT trade flows have also grown, albeit from a negligible base, but only a few countries participate in this trade pattern.

China is the world's largest importer and exporter of LCT. In 2016, China accounted for 15.9 percent of total LCT imports, ranking ahead of the United States (13.2 percent) and Germany (6.9 percent). China also accounted for 16.8 percent of LCT exports in 2016, (table ES.1) and 56 percent of the total value of South–North LCT exports. By contrast, Brazil, India, and South Africa accounted for a combined 4.3 percent of South–North LCT exports.

With the notable exception of India, LCT exports from countries in the South tend to be concentrated in a small number of goods and markets. For example, South Africa's top LCT exports consistently account for over half its total LCT exports, most of which are destined for Germany. Similarly, China and Mexico's top-five LCT exports accounted for over half of their total LCT exports in 2017. In terms of imports, India is the only country to import more LCT from the South—primarily China and other upper-middle-income countries—than from the North. This pattern appears to indicate the India is not importing the most advanced technologies from high-income countries, but is instead importing more suitable or affordable technologies from its peers in developing countries.

### **FDI is a critical channel for technology transfer to developing countries, and countries with larger markets and more sophisticated capabilities attract greater FDI in renewable energy**

After growing steadily before the 2008–09 financial crisis, FDI in renewable energy has become highly volatile.<sup>5</sup> FDI in renewable energy totaled US\$82.5 billion in 2018, with one-third of investments originating from countries in the South.<sup>6</sup> China has quietly emerged as the global leader in renewable energy investment, and in 2018 it overtook Germany as the top foreign direct investor in renewable energy. China accounts for 45 percent of total global investment in renewable energy, and its total investments in the sector (including both FDI and domestic projects) exceeded the combined total investment of all other

countries in 2017 (REN21 2018). South–South investment accounted for 14.1 percent of all renewable energy investment between 2003 and 2018. Most of this investment has gone toward large hydropower projects, and many developing countries—notably China—have cultivated expertise in hydroelectric technologies.

Countries with large domestic markets and more sophisticated capabilities tend to attract more FDI in renewable energy while the poorest countries have attracted much less investment and had fewer opportunities to benefit from technological spillovers. Between 2003 and 2018, India was the largest recipient of FDI in renewable energy, followed by Brazil and Mexico (table ES.2).

Only 13.2 percent of renewable energy investment in the top three countries went to manufacturing, and most was focused on electricity production. These three countries are not major exporters of LCT, suggesting that inbound FDI has not yet transformed their production and export dynamics. Notably, China received relatively little FDI in renewable energy over the period.

### **Innovation in LCT is growing faster than innovation in other technologies, but almost no new LCT is being transferred to low-income countries**

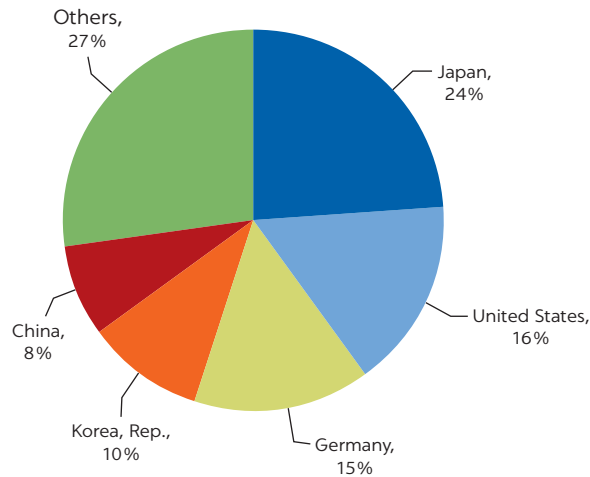
Between 1990 and 2015, the annual growth rate of LCT patents averaged about 8 percent per year, twice the average growth rate for all technologies.<sup>7</sup> High-income countries produced at least 80 percent of LCT innovations in all technological fields over the period. Japan produced the largest share, followed by the United States, Germany, the Republic of Korea, and China (figure ES.4). This order was broadly similar across technological fields. However, lower-middle-income and low-income countries produced almost no LCT innovations during the period.

China has become a global leader in LCT innovation, but China's share of LCT inventions remains small relative to its share of global carbon emissions. Moreover, only a small percentage of China's LCT patents is transferred abroad,<sup>8</sup> raising questions about the quality of these inventions.

Between 2010 and 2015, roughly 71 percent of all patent transfers occurred between countries in the North. Only 23 percent of LCT patent transfers went from high-income to middle-income countries, and only 4 percent went from middle-income to high-income countries. Almost no patents were transferred

to or from low-income countries. Within countries in the South, China received the largest number of inbound LCT patents. Between 2010 and 2015, firms from the North filed more than 90 percent of the inbound LCT patents in China.

### **Restrictive FDI policies and tariffs inhibit LCT transfer—but nontariff barriers may encourage it**

Econometric analysis of patent data from 75 countries observed during 2006–15<sup>2</sup> suggests that restrictive trade and FDI policies unequivocally discourage technology transfer. However, nontariff barriers tend to *increase* technology transfer by encouraging firms to interact with foreign markets through FDI rather than trade. Nontariff barriers—such as import quotas—set a limit on the goods that can be imported. When the import quota is met, FDI becomes the only way to further exploit the technology that produces those goods. Subsidies that encourage foreign firms to enter the domestic market have a similar effect. By contrast, controls on the movement of capital and people have a substantial negative impact on LCT patents transferred by both high-income and developing countries.

Because FDI tends to be more knowledge-intensive than trade in capital goods, the positive effect of nontariff barriers on FDI more than compensates for the negative effect of nontariff barriers on trade. Nontariff barriers tend to be most effective in promoting technology transfer through an increase in FDI in countries that have large domestic markets, which make FDI in domestic production more profitable. In addition, countries with growing populations tend to receive more patent transfers from the South, whereas wealthier countries receive more transfers from both the North and the South.

The influence of other policy variables is more ambiguous. In principle, strong protections for intellectual property rights (IPR) can encourage market entry by foreign firms, whose intellectual assets are shielded from imitation by

domestic competitors. IPR protections, however, can also enhance the market power of patent holders, creating monopolistic price distortions that disadvantage local competitors. The analysis presented in this report finds that strong IPR protections have no significant effect on LCT transfer from either high-income or developing countries.

Local technological capacity has similarly complex implications for patent transfer. Although some local capacity is necessary to exploit transferred technology, a very high degree of local capacity can increase the risk of imitation, potentially deterring foreign patent holders from transferring their technologies. Strong IPR protections can mitigate this risk, but only partially. Likewise, stringent environmental protections can encourage innovation and boost LCT transfer, but they can also increase public investment in research and development, which may crowd out private investment and discourage technology transfer.

### **China's success in the electric vehicles market illustrates both the challenges and the rewards of reaching the final step on the technology-transfer staircase**

China's initial push into the electric vehicle (EV) market was driven by a combination of domestic objectives targeting pollution control, energy security, and economic growth. Building on a decade-long process of investing in research and development, the government launched an ambitious pilot program in 2009 designed to promote the development of EVs in several cities and regions. This program, known as "Ten Cities, Thousand Vehicles," was centralized, but the pilot cities had significant leeway to establish rollout models that reflected their circumstances, with variation in models yielding important lessons to guide national rollout.

Multiple structural, technical, and market constraints prevented the program from achieving its anticipated outcomes. For example, firms realized that the creation of a national EV industry would require developing uniform industrial standards for battery types and designs for public buses, all of which were missing. It also became clear that the transition from conventional vehicles to EVs would require better incentives, as well as close coordination among auto manufacturers, battery developers, infrastructure providers, and consumers. Reacting quickly to the program's initial failure, the government significantly increased subsidies to EV manufacturers and developed a network of charging facilities and services based on unified standards. Working closely with the government and local authorities, the EV firms focused on producing cheaper, better-designed models tailored to the preferences of Chinese consumers. This time the program succeeded and, by 2015, China had become the world's largest EV market. In 2007, only 100 EVs were sold worldwide; by 2018, this figure had reached 2 million, with China accounting for half of the total.

Several lessons can be gleaned from this experience. First, the Chinese government's vision and support—including the construction of infrastructure networks—were essential to enable EV producers to overcome the entrenched dominance of conventional vehicles. Second, industrial policies were vital to support EV development and deployment. For example, China's strategy of encouraging municipal governments to invest in charging facilities and applying favorable tax and regulatory treatment to EVs played a

major role in accelerating EV uptake. Third, contrary to China’s traditional automotive market, which is dominated by joint ventures between foreign and domestic companies, the EV market was dominated by wholly domestic firms. China’s EV industry was not a product of the “Trade Technology for Market” policy. Under this policy, foreign companies in strategic sectors are required to share their technology as a condition to gain access to the Chinese consumer market, which Chinese critics have long argued encourages Chinese firms to rely on outdated imported technologies instead of investing in domestic research. By contrast, the growth of the EV industry was driven by the capacity of domestic firms to innovate and to tailor their products to the specific circumstances of the Chinese market.

China’s success in the EV market ultimately hinged on the government’s ability to learn from failure and persevere until it found an approach that worked, but the costs of sustaining the creation of the EV industry were astronomical. In 2016, subsidies for battery-powered vehicle models were about US\$2,000 per vehicle in California, US\$4,500 in Sweden, and US\$8,000 in China (Yang et al. 2016). China was able to afford this level of subsidization, but most countries cannot. Moreover, even China eventually changed course again: After realizing that its EV subsidies were excessive and untargeted, it decided to phase them out almost entirely by 2020 and to replace them with several targeted regulatory initiatives.

China’s EV experience provides some insights into the challenges of delivering EVs to a mass market through centralized leadership and industrial policies. Other countries—such as the United States, Germany, India, and Sweden—have adopted different models, with various degrees of success. Markets are driven by the interaction of individual firms within the context of national regulatory frameworks, and box ES.1 analyzes the experience of two comparably successful EV companies, one in China and one in the United States. These two companies employed two very different strategies, highlighting the ongoing process of experimentation that characterizes the EV market.

## BOX ES.1

### Two paths to leadership in the global electric vehicle market

Electric vehicle (EV) manufacturers Build Your Dreams (BYD), a Chinese company, and Tesla, a U.S. company, provide a case study of how two different business strategies enabled these firms to become leaders in the global EV market.

Founded in Shenzhen in the mid-1990s, BYD embraced the Chinese government’s vision of transitioning to low-carbon energy, which entailed

promoting a massive increase in EV production and sales. BYD currently owns 30 percent of China’s EV market and is the largest producer of plug-in vehicles globally. Tesla’s mission is “to accelerate the world’s transition to a sustainable energy future.” Tesla currently dominates the U.S. EV market, and its Model 3 was the best-selling electric car in the world in 2018.

Although the leaders of BYD and Tesla are both innovators capable of influencing entire industries, the differences between their business strategies during the past decade are striking. BYD closely guarded its technology, whereas Tesla made its patents publicly available. BYD initially positioned itself in the low-end market; Tesla began at the high end. BYD imitated foreign technologies and exploited a niche market that foreign automakers were exiting; Tesla partnered with established conventional vehicle manufacturers to alleviate the constraints imposed by its limited automotive experience. Whereas Tesla has been criticized for overpromising and underdelivering and has suffered serious

financial problems, BYD has overdelivered on its objectives and expanded rapidly in both the domestic and international markets. BYD's profitability, however, has hinged on its access to Chinese government subsidies, which have been far more generous than those available to Tesla.

Although both companies were successful, Tesla may contribute more than BYD to the development of a global EV market with its "open innovation" approach to intellectual property rights. Open innovation—coupled with a strategic focus on alliances and partnerships—appears to offer EV firms a means to thrive in a world of global competition and rapid technological change.

**POLICY IMPLICATIONS**

The five chapters of this report yield multiple recommendations for facilitating the transfer, adoption, production and creation of LCT. Each country has its own development objectives and faces its own unique constraints. Countries with limited capabilities may prefer to focus on leveraging LCT to expand energy access, improve energy efficiency, or help domestic firms become more cost-competitive. Countries with higher levels of capability may be more willing to assimilate imported technology and eventually develop their own LCT industries. The global transfer of LCT is not only a necessity to achieve climate objectives but also an opportunity to achieve development goals. The policies needed to deploy LCT could also raise output, employment and competitiveness while yielding ancillary welfare benefits, such as reduced air and water pollution. Moreover, adopting LCT offers an opportunity for economies seeking export-led growth to become LCT producers and exporters.

**Establish effective policies to get energy prices right while building human, physical, and institutional capital**

Across countries, the policy environment for LCT must be aligned with their overall development objectives. For example, by reducing or eliminating fossil fuel subsidies and implementing carbon pricing, governments can systematically shift the incentives faced by firms and households toward low-carbon energy. But carbon pricing often faces significant political opposition, and other measures may be needed to accelerate the deployment and production of LCT. Investing in human capital and in low-carbon infrastructure—including public transportation and energy infrastructure—is vital to boost the capabilities of firms and households to embrace LCT.

### **Support private investment in LCT deployment through de-risking mechanisms**

Although returns to investment in technology in developing countries should be higher than in developed countries, country-specific risks—both actual and perceived—reduce expected returns across all types of LCT investment. High financing costs may render investment in LCT infeasible. Given the insufficient supply of long-term private capital to support decarbonization, public support is crucial. De-risking instruments, including loan guarantees, public equity co-investments, and political risk insurance, can help address the underlying causes of policy risk and accelerate private investment in LCT.

### **Introduce demand-pull policies to create a market for LCT**

Policies that support the demand for technologies—demand-pull policies—can be especially effective in encouraging the uptake of LCT. Direct subsidies and feed-in tariffs have proven effective in making renewable energies cost-competitive with fossil fuel technologies, though they often entail considerable costs. Public outreach campaigns designed to raise awareness of the costs and risks associated with climate change can foster positive social norms around consumption. Regulatory standards and labeling requirements can help overcome informational constraints. Governments can also increase LCT demand directly through their public procurement and investment policies, and they can provide financing to help firms and household transition to LCT. Partnerships between the government, public utilities, the private sector, and academic institutions can build the human capital necessary to support LCT deployment and supply LCT directly to low-income households as part of broader efforts to achieve energy-access and distributional-equity objectives.

Demand-pull policies tend to be most effective in large markets. Market size influences both the production and deployment of LCT, and countries with large consumer markets are well-positioned to leverage demand to advance their LCT goals. However, demand-pull policies can also be effective in smaller countries, especially if they pool their market size through policy harmonization and regional integration.

### **Focus on technology-push policies to drive innovation and support LCT production and exports**

Supply-side policies that encourage technology innovation—technology-push policies—are especially appropriate for countries seeking to spur LCT innovation, production, and exports. Determining which policies will work in which context, however, remains a key challenge for innovation policy in general and for LCT production and exports in particular. Developing countries seeking to innovate, produce, and export LCT require sophisticated national capabilities, long-term strategic planning, and an especially aggressive mix of demand-pull and technology-push policies. Countries that reach this stage are likely to experience accelerated productivity growth, as LCTs tend to be more complex than other technologies, with dense backward and forward linkages across multiple value chains. Consequently, the value of capturing part of a complex and growing sector may outweigh the risk-adjusted costs of investing in LCT. Within this

context, governments should adopt a policy approach designed to create—rather than pick—winners, which can reduce the risk of generating distortive rents. For example, governments can support intermediaries such as accelerators and technology centers that help firms and workers develop the capabilities to innovate, including the necessary managerial and absorptive capacity, rather than directly supporting specific firms.

Poorer countries tend to face more and deeper market failures involving technology, and they often have less domestic capacity to address those failures effectively. As these countries develop, policymakers should alter their LCT policies to reflect their expanding national capabilities, as well as other dynamic country- and technology-specific variables. However, the combination of technology-related market failures and limited national capabilities can leave low-income countries stuck in a “technology trap.”<sup>10</sup> Increasing external assistance for LCT transfer may be necessary to free low-income countries from the technology trap.

### **Use environmental provisions in multilateral trade and investment initiatives to accelerate LCT transfer**

Bilateral and regional trade agreements can enable trade liberalization and environmental protection to support and reinforce each other. The number of such agreements has soared over the past three decades, as has the number of environmental provisions they contain (Monteiro and Trachman, forthcoming). Committing to a clear path of sequenced reforms to support environmental objectives can boost economic and welfare gains and the inclusion of environmental provisions in trade agreements correlates with increased trade flows (Berger et al. 2020). Trade agreements have also helped to drive bilateral and multilateral cooperation on issues such as product standards and environmental subsidies.

Multilateral trade liberalization is vital to accelerate LCT transfer. In 2014, 46 members of the World Trade Organization (WTO) initiated negotiations for an Environmental Goods Agreement (EGA) designed to remove barriers to trade in goods with positive environmental or climate change impacts. However, these negotiations stalled in 2016. Completing the EGA could accelerate LCT transfer worldwide. Although reaching consensus on a list of environmental goods is likely to be a challenge, unilateral tariff reductions offer an immediate incentive to increase trade in LCT-intensive goods and services. Econometric analysis suggests that low-income countries would experience the greatest increase in LCT imports and the largest welfare gains from the elimination of tariffs on LCT (de Melo and Solleder 2018)—including expanded access to clean, lower-cost energy—which would disproportionately benefit low-income households (Mahlstein and McDaniel 2017).

International investment agreements could accelerate LCT transfer to developing countries by reducing FDI restrictions and stimulating both foreign and domestic investment. International investment agreements should, however, include a degree of flexibility to accommodate the “increased ambition” mandated by the Paris Agreement.<sup>11</sup> For example, they should allow for the periodic tightening of mitigation and adaptation policies in the Nationally Determined Contributions (NDCs), and they should include correction mechanisms that enable countries to adjust their policies in response to new information about

environmental risks. Finally, international investment agreements could encourage countries to provide greater policy certainty by clearly communicating their long-term climate objectives and transparently integrating them into their long-term macroeconomic and sectoral development strategies.

### **Adopt new IPR agreements for accelerating the transfer of LCT**

The international experience underscores the importance of IPR protections to promote the development of new technologies but the urgency for the rapid deployment of LCT to avert the catastrophic impact of climate change provides a compelling rationale for sharing the intellectual property that underpins LCT. Firms are interested in both profiting from the diffusion of their innovation and avoiding expropriation by imitating firms. To balance these interests, industries with historically high rates of patenting and records of operating in environments with complementary technologies—such as aircraft manufacturing, semiconductors, mobile telecommunications, and electricity metering—have managed to accelerate innovation and diffusion simultaneously by adopting technology-standards agreements and cooperative IPR arrangements, including cross-licensing (Iliev and Neuhoff 2009).

Patent pools, which are agreements between two or more patent owners to collectively manage IPRs, have the potential to accelerate LCT transfer, following the example of the biomedical and pharmaceutical industries. However, this approach would need to be incorporated into the international IPR architecture and linked to appropriate sources of financing. In the near term, a “club” of countries could take the lead by creating collaborative patent pools to facilitate the cost-efficient transfer of the most promising LCT (Maskus 2010).

### **Mobilize the UNFCCC to facilitate the transfer of LCT to the poorest countries**

International institutions and donor countries could play a much larger role in facilitating transfer of LCT to the poorest countries, including via the UNFCCC process. Increasing the amount of resources allocated to publicizing successful examples of technology transfer could provide critical knowledge for policymakers striving to promote LCT transfer and innovation. In addition, a much stronger commitment by upper-middle-income and high-income countries to explicitly include technology-transfer objectives in their NDCs would signal their commitment to facilitating the spread of LCT.

The UNFCCC has yet to formulate a comprehensive international framework to address the challenges of South-South LCT transfer. While this pattern of LCT transfer is likely to accelerate in the medium term even in the absence of a comprehensive international policy framework, a consistent focus on the unique dynamics of South–South LCT transfer within the existing framework could have a highly positive impact. The poorest countries have the most to gain from South–South LCT transfer, and the UNFCCC has a key role to play in overcoming their pervasive market failures and domestic financial and institutional capacity constraints. Low- and lower-middle-income countries should lobby the UNFCCC and the WTO to develop cooperative and differentiated IPR arrangements designed to



promote LCT transfer, following the example set by the health sector for HIV-AIDS medicines. Cooperative IPR arrangements such as cross-licensing, patent pooling, technology-standards agreements, and other forms of technology sharing could have the greatest positive impact in the poorest countries with the least access to finance.

Finally, resources from the Green Climate Fund could be used to meet the full cost of acquiring the IPRs to LCT, which should be provided to developing countries at no cost. This recommendation was initially put forward by the working group on the Durban Platform for Enhanced Action in 2015.<sup>12</sup> However, due to a lack of consensus among participant nations, the final version of the Paris Agreement did not include this provision. Instead, the agreement relies on technology networks and alliances to promote the diffusion and dissemination of green technologies. Given the critical importance of accelerating LCT transfer to developing countries, the Green Climate Fund could leverage its unique network, institutional capacities, and financial resources to acquire ownership and dissemination rights to patent-protected LCTs and make them available to the poorest countries. Technology donations, aided by voluntary patent-pool agreements, could minimize the cost of this approach.

## CONCLUSIONS

Achieving the Paris Agreement goals presents an immense challenge, reflecting both the global dependence on fossil fuels and the tremendous barriers to the deployment of LCT in developing countries. The five chapters of this report document the limited but encouraging progress achieved in LCT transfer, highlight key obstacles to LCT deployment and innovation, and present practical recommendations. The overarching conclusions of the analysis can be summarized as follows:

- National strategies for low-carbon development should be strategic, comprehensive, and bold. Key elements of a successful national strategy would include: (i) phasing out subsidies for fossil fuels and implementing an economy-wide price on carbon; (ii) building the technological capabilities necessary to adopt, imitate, and ultimately create LCT; (iii) strengthening regulatory frameworks to boost investor confidence in the political commitment to low-carbon growth; (iv) adopting demand-pull policies such as feed-in tariffs, fiscal incentives, public outreach campaigns, and policies to strengthen LCT-intensive public procurement, investment, and financing; and (v) implementing technology-push measures to support LCT innovation, production, and exports, particularly in countries with adequate capabilities.
- The international climate architecture should be strengthened to favor the least-developed countries. Effectively strengthening the climate architecture would require: (i) balancing appropriate IPR protections with the necessity to facilitate cost-efficient LCT transfer; (ii) supporting the creation of patent pools, as well as other cooperative IPR agreements; and (iii) advocating for the introduction of environmental provisions into multilateral trade and investment initiatives designed to accelerate LCT transfer.



## NOTES

1. “Global warming” refers to the long-term warming of the planet. “Climate change” includes global warming and broader related changes such as sea-level rise, glacial decline, ice melt, and shifts in agricultural conditions.
2. LCTs include renewable wind energy (offshore and onshore), solar energy (on- and off-grid solar photovoltaic and solar thermal), energy-efficiency technologies used in buildings, industrial processes, vehicles, heating and cooling, lighting, and appliances. This report deals exclusively with LCTs related to climate-change mitigation. The Intergovernmental Panel of Climate Change defines low-carbon development as “policies and strategies that mitigate GHGs while achieving, at the same time, social and economic development goals” (Metz et al. 2000).
3. In this report, “North” refers broadly to high-income countries as defined by the World Bank, while “South” refers to all other countries.
4. The report (refer to chapter 5) uses a multivariate regression analysis (controlling for country and year fixed effects) for identifying the factors that are critical for moving LCT trade up the technology staircase.
5. UNCTAD (2010) defines “low-carbon foreign investment” as the transfer of technologies, practices, or products by multinational firms to host countries—through equity and nonequity forms of participation—such that the firms’ operations, products, and services generate significantly lower GHG emissions than would prevail in the industry under business-as-usual circumstances.
6. The report uses FDI data on investments in renewable energy recorded in the *Financial Times’ fDi Markets* database, one of the few databases to specifically classify investments in the renewable energy sector.
7. Patent counts are a common metric for innovation, and technology transfer can be measured by counting the number of patents an inventor from one country files in a different country. This report uses patent counts and patent-transfer data from the PATSTAT database maintained by the European Patent Office (EPO) to analyze LCT innovation and transfer.

# 1 A Framework for Low-Carbon Technology Transfer

## INTRODUCTION

Accelerating the development and transfer of low-carbon technologies (LCTs) has been at the core of international climate change negotiations since the 1992 United Nations Framework Convention on Climate Change (UNFCCC). This chapter provides a conceptual framework for understanding the development and diffusion of LCTs, with a focus on the growing importance of technology transfer in the South.<sup>1</sup> The chapter starts by putting the dynamic process of technological change in historical perspective, highlighting how the diffusion of technologies has occurred over many centuries and is now entering a new critical phase of low-carbon transformation. After placing the challenge of low-carbon technological innovation and diffusion in the context of energy transitions, the chapter discusses the distinctive features of LCTs, relative to their carbon-intensive alternatives. Next, it describes the legal basis of LCT under the UNFCCC, and it reviews key findings from the academic literature on the avenues and determinants of LCT transfer and on sources of finance. Finally, the last section provides suggestions on how policy makers can help accelerate the next critical phase of LCT innovation, transfer, and development.

## TECHNOLOGICAL INNOVATION AND DIFFUSION IN HISTORICAL CONTEXT

From our earliest ancestors over 3 million years ago to the ongoing journey of *Homo sapiens* that began more than 200,000 years ago, each successive epoch was sustained by core technologies that formed the basis of human and economic development (Basalla 1988). From the early Stone Age to our modern Silicon Age, individual technologies have developed historically through three broad, interactive stages: *invention*, *innovation*, and *diffusion* (Schumpeter [1934] 2017, 1939). Certain technologies were concocted to meet human needs, whereas others emerged from sheer novelty and gave rise to new uses and desires. Resembling biological processes such as

horizontal gene transfer, technological change has always been a cumulative, evolutionary process involving selection, swapping, recombination, and incremental variation (Arthur 2009). Each segment in the chain of technological development—from invention to pilot demonstrations, diffusion, replication, and further improvement—follows a nonlinear, recursive process, whereby each part of the chain interacts endogenously with the other parts (Grubb 2014; Usher [1929] 1954).

Many modern-day technological innovations were made possible by basic technical advances that originated decades or centuries earlier and in many corners of the world, highlighting the collaborative basis of technological change. To take just one example, the remarkable ubiquity of cell phones today would have been impossible without James Clark Maxwell's original discovery of the phenomenon of electromagnetic radiation, through his theory unifying electricity, magnetism, and light in the 1860s. Subsequently, Heinrich Hertz was the first to actualize Maxwell's theoretical discovery by generating, sending, and receiving electromagnetic waves in the late 1880s. That work led to the first radio broadcasts by Oliver J. Lodge and Alexander S. Popov in 1894 and 1895, the first transatlantic transmission of radio signals by Guglielmo Marconi in 1901, the first radio broadcast of music by Reginald A. Fessenden in 1906, and the first vacuum tubes around the same time. The following decades spawned the invention of transistors, integrated circuits, and microprocessors (Smil 2017a, 2017b). Indeed, a decades-long, collaborative chain of cumulative innovation connects the intervening years between Maxwell's discovery and the modern-day microprocessors in products produced by companies such as Apple, Nokia, and Samsung.

The diffusion of technologies has occurred gradually over many centuries, well before the term “technology transfer” entered the parlance of international institutions after the Second World War. Nearly all of our knowledge of the nature of technological change during the preindustrial era is anecdotal, based on archeological evidence and historical interpretation. From the first known use of stone tools approximately 3.3 million years ago by our hominin ancestors in Kenya, to the first known metallurgical advances in copper and iron smelting about 7,000 years ago, our knowledge of early mechanisms of technological dissemination is inherently limited, speculative, and subject to data limitations (Harmand et al. 2015; Schmidt and Avery 1978; Van Noten and Raymaekers 1988).

The Industrial Revolution, which began in Britain in the mid-18th century, marked a profound structural break. The scale of its transformations and the exponential rate of its technological improvements are rivaled perhaps only by the Neolithic Revolution during the Holocene 12,000 years ago, when humankind first developed organized agriculture. The modern industrial era transferred most of the toil and travails of human labor to machines, ushering in multiple, interconnected innovations—such as steam engines and turbines, internal combustion engines, metallurgical advances, Portland cement manufacture, deep oil well drilling, gas turbines, electricity-generating plants, air conditioning, plastics and polymerization, and ammonia synthesis—that spread internationally by railway and steamship (Mumford [1934] 2010; Rosenberg 1982).

Technological differences across countries and firms are some of the key drivers of divergences in total factor productivity, per capita income, and long-run economic growth (Romer 1990; Schumpeter [1934] 2017, 1939; Solow 1956).

During the 19th century, technology transfer from Great Britain and other originating countries became a crucial driver of economic development in continental Europe and the United States (Jeremy 1981; Landes 1969; Rosenberg 1963, 1982). Over the past two centuries, cross-national differences in the adoption rate of new technologies may have accounted for as much as 75 percent of the divergence in per capita incomes between developed and developing economies (Comin and Mestieri 2018). To this day, the ability of developing countries to acquire, configure, and further improve core technologies, and to foster related technical skills and learning among their workforces, remains a key determinant of highly uneven levels of economic development (Bell and Pavitt 1997; De Long and Summers 1991).

Despite the ample developmental gains that accrue from strategic investment in innovation capacities (firm and productivity growth, economic diversification, and so on), many developing countries continue to chronically underinvest in core technologies, research and development (R&D), equipment, skills training, and intellectual property (IP) acquisition (Cirera and Maloney 2017). In some cases, that underinvestment is attributable to weak legal protections of IP, which limit the ability of firms to appropriate the returns from innovation. In other cases, underinvestment may be attributable to organized resistance to technological change, macrofiscal imbalances, risk-averse investors, or short-termism (Mokyr 1994, 2000; Parente and Prescott 1994). Greater investment in strategic public and private R&D, human capital, and complementary infrastructure will be central to moving beyond mere adoption of technologies and acquiring capabilities for further endogenous innovation. Economic history suggests that the process of rising up the technological ladder is often multidecadal and nonlinear, involving collaboration between the executive, the legislature, civil service, universities, and firms to develop regulatory frameworks and long-term industrial strategies capable of activating national innovation systems. Such industrial strategizing was, in different ways, at the heart of the early histories of industrialization in Germany, the United Kingdom, and the United States, and more recently with the “East Asian Miracle” in China, the Republic of Korea, and Japan.

Technology-driven industrialization has transformed the world’s wealth—coinciding with a doubling of average and maximum life expectancy globally since the mid-19th century—but at the cost of accelerating climate change and ecological devastation (Oeppen and Vaupel 2002; Riley 2005). As gross world product per capita has increased by an average of 2–3 percent annually since the mid-19th century, so too have global greenhouse gas emissions (Boden, Marland, and Andres 2017; Inklaar et al. 2018; Le Quéré et al. 2018). Left unabated, the sheer scale of global cumulative greenhouse gas emissions will drive accelerating warming that threatens “health, livelihoods, food security, water supply, human security, and economic growth,” with the mounting risk that coastal cities could, this century, be inundated by rising sea levels triggered by melting Greenland and Antarctic ice sheets (IPCC 2018). Beyond climate change, human economic activities including intensive agriculture, excessive nitrogen fertilizer use, destruction of tropical forests for food and livestock production, and overfishing are profoundly “reshaping life on Earth,” with 1 million species at the brink of extinction (Tollefson 2019).

Meanwhile, per capita energy consumption still varies by more than two orders of magnitude cross-nationally. Low-income countries do not benefit equally from global fossil fuel use, but they are most exposed to the harms of



accelerating climate change, which has already increased cross-national inequalities in gross domestic product per capita by about 25 percent compared to a world without global warming (Diffenbaugh and Burke 2019). Despite contributing the least to global cumulative emissions historically, the least developed countries are also the most vulnerable to the extreme weather events, food insecurity, displacement, economic and infrastructure damage, and habitat loss that unmitigated climate change will exacerbate.

## **THE DIFFUSION OF LCT AS PART OF A LONG HISTORY OF ENERGY TRANSITIONS**

Energy transitions at the global scale have throughout history been prolonged, with individual technologies typically requiring a minimum of 50–70 years to move from invention to large-scale adoption and diffusion (Grubler and Wilson 2014; Smil 2010). For certain energy technologies, the innovation stage alone has often extended over a century and the diffusion stage has typically lasted more than 50 years (Fouquet 2010). The definition of “transition” depends critically on one’s choice of measure and definition of a threshold, and no single measure adequately captures all the multidimensional processes. Using a typical point of comparison—the point at which the technology’s share of total global energy supply crosses the 25 percent threshold—several examples suffice to illustrate the protracted nature of global diffusion. Coal surpassed the 25 percent mark in 1871, more than 500 years after the first commercial coal mines were developed in England. Crude oil surpassed the same mark in 1953, about nine decades after Edwin Drake drilled the first commercial well in Titusville, Pennsylvania, in 1859. Hydroelectricity, natural gas, nuclear power, and other sources such as wind turbines and solar panels have yet to surpass the 25 percent threshold (Sovacool 2016). It is possible, however, that the current transition to a decarbonized global energy system will deliver a far more diversified set of primary energy sources and technologies than has existed in the past, implying that the 25 percent threshold may be less appropriate this century. The most critical factor may instead be the scale and speed at which fossil fuels and related carbon-intensive technologies are phased out rather than the predominance of individual technologies that are to replace them.

In contrast to the gradual pace of historical energy transitions at the global scale, numerous examples of energy transitions have occurred much faster—in under several decades. It is possible for well-designed policies and investments to greatly accelerate deployment of new technologies. Such examples include, among others, the rapid adoption of nuclear power in France and the spread of combined heat and power plants in Denmark from the late 1970s to early 1980s, which were state-led initiatives motivated largely by the oil price shocks and the burgeoning international environmental movement. Other examples include the adoption of air conditioning units in the United States from the late 1940s to 1970—driven simultaneously by urban sprawl, growth in the construction of new homes, marketing of and growing demand for cooling appliances, and innovations in air circulation and heat pumps—and the use of improved cookstoves in China during the 1980s and 1990s, driven

by an intensive national program that prioritized indigenous innovation and deployment across hundreds of rural provinces, reduced energy use per capita in rural areas by more than 5 percent annually, and affected half a billion people (Sovacool 2016).

Two historical examples of nonlinear, cross-national technological development—wind turbines and steel manufacture—help to put low-carbon technological “leapfrogging” in historical perspective. The origins of the modern wind turbine harken back to the first recorded use of the horizontal windmill for irrigating gardens in what are now Afghanistan and the Islamic Republic of Iran (circa 800 CE), although related concepts can be traced further back to Heron of Alexandria (circa 62 CE) and waterwheels used during the prior millennium (Lewis 1993). The windmill concept eventually spread to Europe circa 1100, likely through traders in the Byzantine Empire, whereupon technical efficiency improvements led to vertical windmills and tower mills (Hills 1994; Lewis 1993; Sørensen 1995). Nearly a millennium later, public policies pioneered in Denmark, Germany, and the U.S. state of California, followed by mass production and economies of scale in China, have propelled further wind turbine design improvements and market expansion. In the past two decades alone, cumulative installed wind energy capacity has seen a 25-fold global increase and wind energy patents a 60-fold increase (IRENA 2018). The mean levelized cost of (unsubsidized) wind energy has declined 69 percent to US\$42 per megawatt-hour over the past decade, with cost considerations driving wind energy penetration in markets as diverse as Brazil; Taiwan, China; Mexico; South Africa; the United Kingdom; and the U.S. state of Texas (Lazard 2018). The next phase of wind energy development will depend critically on further innovation: improving wind capacity factors, reducing the costs of high-capacity storage solutions, and deploying high-voltage, direct-current transmission lines across long distances (Davis et al. 2018; Huenteler et al. 2018).

The preindustrial origins of iron and steel production provide another instructive example of technology transfer. Iron smelting emerged as far back as the third millennium BCE in Southwest Asia, with the practice appearing to have diffused to Southeast Asia and China, Africa, and eventually Europe (Schmidt and Avery 1978; Van Noten and Raymaekers 1988). From this remote past, modern steelmaking eventually emerged during the Industrial Revolution thanks to several pioneering developments: the replacement of charcoal with coke as fuel in blast furnaces in the 18th century, the invention of the hot blast in Scotland in 1828, Bessemer’s steel converter in England in 1856, the Siemens-Martin open-hearth process and electric arc furnaces developed in Germany and France in the late 19th century, and the basic oxygen furnace and continuous casting in the mid-20th century (Hyde 1977; Smil 2016). Today, iron and steel production directly account for approximately 5 percent of global carbon dioxide (CO<sub>2</sub>) emissions and 33 percent of industrial emissions, with most production dominated by China, India, and Japan.

About 75 percent of the world’s crude steel is produced using coal, iron ore, coke, and limestone to fuel relatively inefficient and CO<sub>2</sub>-intensive basic oxygen furnaces. Meanwhile, global steel demand is projected to grow by more than 3 percent per year over the next decade. The next phase of low-carbon steel production will require major innovation and technology transfer, via either hydrogen-based iron smelting in electric arc furnaces or possibly carbon capture

and storage technologies. In the absence of those technologies, reducing the sector's emissions will require substituting steel with a new generation of low-carbon materials (Arens et al. 2017; Hanley, Deane, and Gallachóir 2018; Karakaya, Nuur, and Assbring 2018).

Technological diffusion is itself a major driver of further innovation, improved performance, and reduced costs. Many technologies have improved largely in accordance with Wright's law (often described as a "learning curve" or "experience curve"), which postulates that unit costs decline as cumulative output increases (Wright 1936). The negative relationship between cumulative production and unit costs is "one of the best-documented empirical regularities in economics" (Thompson 2012). It is most commonly explained by the idea that technology performance improves as firms learn through accumulated experience, or "learning by doing" (Arrow 1962). The unit costs of solar photovoltaic (PV), for example, have dropped by an average of 10 percent annually since 1990 (Farmer et al. 2019). The remarkable rates of cost reduction were initiated largely by "demand-pull" policies particularly in Germany, Spain, and Japan. These policies incentivized mass production and scale economies most prominently in China, which in turn led to further module efficiency improvements (Kavlak, McNerney, and Trancik 2018).

The costs of individual technologies have, however, improved at vastly different rates. Variation in improvement rates is attributable not only to the volume of cumulative output but also to policy constraints (for example, the failure to price negative pollution externalities) and features intrinsic to particular technologies (Ferioli, Schoots, and van der Zwaan 2009). In contrast to the dramatic cost reductions in solar PV, the real costs of coal, oil, and gas have not come down much over more than a century; and the costs of nuclear power have increased since the 1970s and 1980s, partly because of safety and waste disposal concerns (Farmer and Lafond 2016). Meanwhile, costs for batteries and wind turbines have each improved at an average annual rate of 3.0 percent (Benson and Magee 2014).

Optimal investment in LCT can be understood as a function of the technology's initial conditions (cost competitiveness and accumulated experience), learning rates and uncertainty about future cost, risk aversion, the discount rate, and the level of demand (Way et al. 2019). A potential trade-off exists as well: although diversification of investment can reduce the risks associated with uncertainty about future cost trajectories, specialization can drive increasing returns that drive down unit costs. Strategic investments in quickly improving LCTs are more likely to be amplified by positive feedback (for example, social learning, network, and bandwagon effects), turning investment in further technological capacity into a self-reinforcing phenomenon (Arthur 1989).

Like the Earth's climate system, our sociopolitical, economic, and technological systems have critical thresholds, or "tipping points," beyond which rapid, nonlinear, and large-scale change is possible with strategically targeted interventions (Farmer et al. 2019). Such positive tipping points can be generated not only by investing in the fastest-improving LCTs but also by adopting a sufficiently high and rising economy-wide carbon price, investing in the decarbonization of buildings and transport infrastructure, phasing out carbon-intensive products or production processes that have viable low-carbon substitutes, and, more generally, adopting legally binding and ambitious national legislation to reduce emissions across sectors and change expectations about the future direction of the economy.

## **DISTINCTIVE FEATURES OF LCTs, RELATIVE TO CARBON-INTENSIVE TECHNOLOGIES**

The sheer complexity of technological innovation and diffusion suggests the need for a simplifying framework. If the international transfer of LCTs is to be greatly accelerated within the next several decades, conceptual heuristics may help guide policy makers and governments, entrepreneurs and firms, and investors and financial institutions.

The theoretical literature on technological innovation and transfer is voluminous and has greatly expanded in recent decades. A recent survey identified 96 distinct theories of technological transitions, spanning 22 academic disciplines (Sovacool and Hess 2017). Some theoretical frameworks focus on very specific aspects of technological change (such as sociocultural responses to new technologies). Other frameworks aim to provide a critical, ethics-driven perspective (such as incorporating ideas of distributive justice and normative philosophy). Others, more applicable to the concerns of this report, aim to provide a holistic perspective spanning each stage of technological change—from innovation to diffusion. Much in this literature is applicable to frameworks for understanding LCT transfer, but it is not the purpose of this chapter to extensively review the full range of relevant studies.

Among theories that aim to describe the stages of technological change and to prescribe policies that may accelerate that process, there are two broad schools of thought: the literature on the “economics of innovation” and the more interdisciplinary literature on “innovation systems” (Grubb, McDowall, and Drummond 2017). The former approach is the orthodox perspective in neoclassical economics, and it tends to emphasize the roles of R&D, carbon pricing, market competition, patents, and licenses in promoting LCT transfer (Jaffe and Stavins 1995). From this perspective, the role of the state is primarily to correct market failures and negative externalities. The latter approach, focusing on innovation systems, draws upon further insights from both behavioral sciences and evolutionary economics, and it emphasizes the role of directed regulatory policies and policy sequencing at each stage of the development of a technology. From this perspective, the role of the state is to actively shape the rules of markets and encourage endogenous technological change, to define “mission-oriented” policy rather than merely to respond to market failures (Geels 2002; Grubb, McDowall, and Drummond 2017; Mazzucato 2015, 2016; Metcalfe 1995).

The value and importance of both approaches can be appreciated by first considering the distinctive features of LCTs, particularly from the perspective of governments and firms in developing countries. Table 1.1 describes the main features of LCTs: complexity of production inputs, multiplicity and heterogeneity, high up-front costs, relatively low levels of private R&D investment, competition with incumbent technologies and firms, dependence on basic infrastructure to grow at scale, dependence on natural capital, access to multilateral climate finance, incentives for sharing of IP, and dependence on both market and non-market policy support. Each of these LCT features has important implications for South–South and South–North technology transfer.

Countries with low absorptive capacity will not be able to access LCTs because many (but not all) of these technologies have higher-than-average complexity. For a given LCT, countries or firms will be more likely to develop and leverage a comparative advantage if they already possess the technical

knowledge and experience in producing and using closely related technologies requiring similar capabilities (Mealy and Teytelboym 2018). Government and firms may be best advised, therefore, to initially invest in the capabilities that are needed to access “core” technologies. Acquisition of (and specialization in) advanced green technologies on the periphery of the core product space is more likely to occur later in a country’s evolutionary process of technological development.

The multiplicity and heterogeneity of LCTs entail that firms and governments in developing economies require a strategic, long-term vision for

low-carbon investment and development. LCTs are highly heterogeneous and, like the impacts of climate change, span multiple sectors (energy, industry, transport, buildings, and land use) and may be related to mitigation, adaptation, or environmental monitoring. Moreover, LCTs also have highly heterogeneous costs, rates of improvement, and value added to economic development. Depending on how broadly one defines the range of relevant LCTs, their number may range from about 50 to several hundred (see chapter 2). The primary reason for the considerable range is that a single “green” product can in many cases be used for both environmental and nonenvironmental purposes. For example, manometers—devices that measure pressure levels—can be used to track the efficiency of power plants, but they can also be used to measure blood pressure or in carbon-intensive construction applications. Other technologies, such as photosensitive semiconductor devices like solar PV cells and light-emitting diodes (LEDs), are more straightforwardly low-carbon because they unambiguously are used to reduce energy and carbon intensity. The multiplicity of potential end uses for many green technologies is relevant not only for making progress in eliminating tariffs on low-carbon products but also for understanding the dynamics of innovation and technology transfer.

A critical insight that has emerged from technology-driven assessments and related financing is the importance of scalability, which should inform decisions about which technology investments to prioritize. The multiplicity and diversity of LCT needs present exceptional challenges in relation to the acquisition of finance. Banks and impact investors seek high-impact, scalable projects most likely to produce large returns (whether economic, environmental, or both). The inherently fragmented and compartmentalized nature of many disparate LCTs across sectors, however, often yields limited returns to scale if cross-sectoral complementarities are not simultaneously harnessed. Investments in concentrated solar thermal energy, for example, require complementary investment in grid infrastructure and connections, transmission, and storage to reach full scale. It appears that, for this reason, the accelerated transfer of LCTs may require a more holistic approach, involving coordinated, strategic investments across complementary sectors in each country.

Many technologies that reduce energy intensity or carbon intensity are capital-intensive and long-lived—including, among others, solar PV or concentrated solar power, wind turbines, fuel cells, heat pumps, electric rail, and efficient electricity transmission. Thus, they face political uncertainty regarding future carbon pricing and fossil fuel subsidies. Generally speaking, LCTs require longer investment horizons, less discounting of future benefits, and a more holistic cost-benefit approach accounting for future energy savings, health-related benefits, increased resilience, and avoided ecological damages. These requirements, however, may be less relevant for certain other technologies with significant cost savings—such as when a municipality invests in LEDs rather than incandescent bulbs for streetlights.

Technology costs do change, and at different rates. With the deployment of currently known technologies across multiple sectors, it is technically feasible to achieve net-zero emissions in all essential energy system processes and services (Davis et al. 2018). Significant cost barriers remain, however, and the extraordinary decline of costs in some LCTs has not been associated with comparable cost reductions in others. For example, average costs of solar PV modules worldwide have declined by more than two orders of magnitude since the 1970s—driven by government policy, increased module efficiency, and



scale economies (Kavlak, McNerney, and Trancik 2018). In contrast, cost estimates for electrolysis, a promising technology that could store large amounts of surplus intermittent solar energy, have not reached levels compatible with mass deployment (Saba et al. 2018).

Competition with incumbent, high-carbon technologies and firms poses an obstacle to LCT innovation and diffusion cross-nationally, particularly in developing countries. For countries without a domestic fossil fuel industry and heavily reliant on coal, oil, or gas imports, the environmental and fiscal rationales for developing LCT capacities are especially compelling; and governments may face less political inertia during efforts to accelerate the low-carbon transition. In other countries with incumbent fossil fuel firms and an established high-carbon industry, political inertia delaying decarbonization will be greater; governments may pursue “supply-push” policies supporting the development of LCTs as well as “demand-pull” policies supporting the creation of markets with high demand for those technologies. Given the problems of inertia and high-carbon “lock-in” (Seto et al. 2016), it will also be essential in these countries to use carbon pricing, remove fossil fuel subsidies, and establish clear and credible signals that the market for high-carbon energy will diminish over time.

## **THE LEGAL BASIS FOR LCT TRANSFER UNDER THE UNFCCC**

The widespread recognition that unprecedented levels of international technology diffusion—this time of environmentally friendly technologies—must drive the next stage of human and economic development dates to the early 1970s, when concerns about persistent underdevelopment and environmental deterioration hit an inflection point. Around the same time that Leontief (1970) was pioneering the incorporation of environmental pollution externalities within input-output models of the world economy, the United Nations Conference on the Human Environment in 1972 adopted the (legally nonbinding) Stockholm Declaration, urging developed countries to commit far greater finance and resources to tackling chronic socioeconomic and technological underdevelopment internationally (United Nations General Assembly 1972, Principle 12 and Principle 20).

Twenty years after the Stockholm Declaration, the objective of transferring “environmentally sound technologies” to developing countries was formally established in 1992 with the adoption of the UNFCCC and Agenda 21 in Rio de Janeiro. In Agenda 21 (the nonbinding action plan for sustainable development adopted at the Rio Earth Summit), Chapter 34 defines environmentally sound technologies as those that “are less polluting, use all resources in a more sustainable manner, recycle more of their wastes and products, and handle residual wastes in a more acceptable manner than the technologies for which they were substitutes” (United Nations Department of Public Information 1993). The Agenda 21 definition is broad, spanning the gamut of “know-how, procedures, goods and services, and equipment as well as organizational and managerial procedures.”

The adoption of the UNFCCC went further, in Article 4.1(c), to establish an explicit obligation for parties to the Convention to “promote and cooperate in the development, application and diffusion, including transfer, of technologies” (United Nations General Assembly 1992). The relevant technologies are defined

as the “practices and processes that control, reduce or prevent anthropogenic emissions of greenhouse gases not controlled by the Montreal Protocol in all relevant sectors, including the energy, transport, industry, agriculture, forestry and waste management sectors.” Article 4.1(c) places primary emphasis on mitigation technologies, but in recent years the scope of technology transfer discussions in the UNFCCC has expanded to encompass both mitigation and adaptation (Yamin and Depledge 2004). Article 4.5 emphasizes that the goal is not merely to deploy existing technologies from rich countries but also to “support the development and enhancement of endogenous capacities and technologies” of developing countries. The legal-financial basis for carrying out these objectives is described in Article 11, which establishes “a mechanism for the provision of financial resources on a grant or concessional basis, including for the transfer of technology.”

The UNFCCC’s legal provisions relating to technology transfer institutionalized the paradigm that developed countries would be the primary originators of climate technologies and developing countries the primary recipients (the North–South paradigm). The adoption of the Kyoto Protocol in 1997—including its establishment of the Clean Development Mechanism (CDM)—reinforced the North–South paradigm. Article 10(c) of the Kyoto Protocol recalls the necessity to “take all practicable steps to promote, facilitate and finance” the transfer of technology, particularly to developing countries. Recognizing developing countries’ concerns about IP constraints, Article 10(c) notes that not all climate-related technologies are patent-protected and refers specifically to “environmentally sound technologies that are publicly owned or in the public domain.” Recognizing the issues of public budgetary constraints and unfavorable regulatory environments in developing countries, Article 10(c) highlights the integral role that private sector investment must play in the international diffusion of technology, asking contracting parties to facilitate “the creation of an enabling environment for the private sector.” Furthermore, Article 12 of the Kyoto Protocol established the CDM, under which developed, Annex I countries may accrue “certified emission reduction” credits by financing certified climate change mitigation projects in developing countries, enabling industrialized countries to meet part of their emission abatement targets under the Protocol. International technology transfer was seen as an ancillary benefit of CDM projects, although it was never an explicitly mandated outcome.

The Intergovernmental Panel on Climate Change (IPCC) published its Special Report, *Methodological and Technological Issues in Technology Transfer*, in 2000 (Metz et al. 2000). In the report, the IPCC provided a broad and inclusive definition of technology transfer that has been widely adopted, explicitly or implicitly, by relevant bodies of the UNFCCC: technology transfer is “a broad set of processes covering the flows of know-how, experience and equipment for mitigating and adapting to climate change amongst different stakeholders such as governments, private sector entities, financial institutions, non-governmental organizations (NGOs) and research/education institutions.” To maintain consistency with active UNFCCC initiatives, this report also adopts the IPCC’s definition but discusses only technologies for mitigating climate change and defines them as “low-carbon technology.” Importantly, this definition encompasses not only the physical components or “hardware” of technology—solar panels, wind turbines, lighting units, insulation materials, and so on—but also the “software” (technical know-how and capabilities) and “orgware” (institutional and policy frameworks). The practical implication is



that technology transfer requires *system-wide, process-driven* thinking that takes into account the ability of technology providers and third-party organizations to identify impactful projects and suitable partners in host countries; the ability of host governments to create policy, regulatory, and legal frameworks that reduce risks and attract private and public investors; and the ability of host firms to understand, select, adapt, and replicate viable technologies that are suited to domestic circumstances and needs.

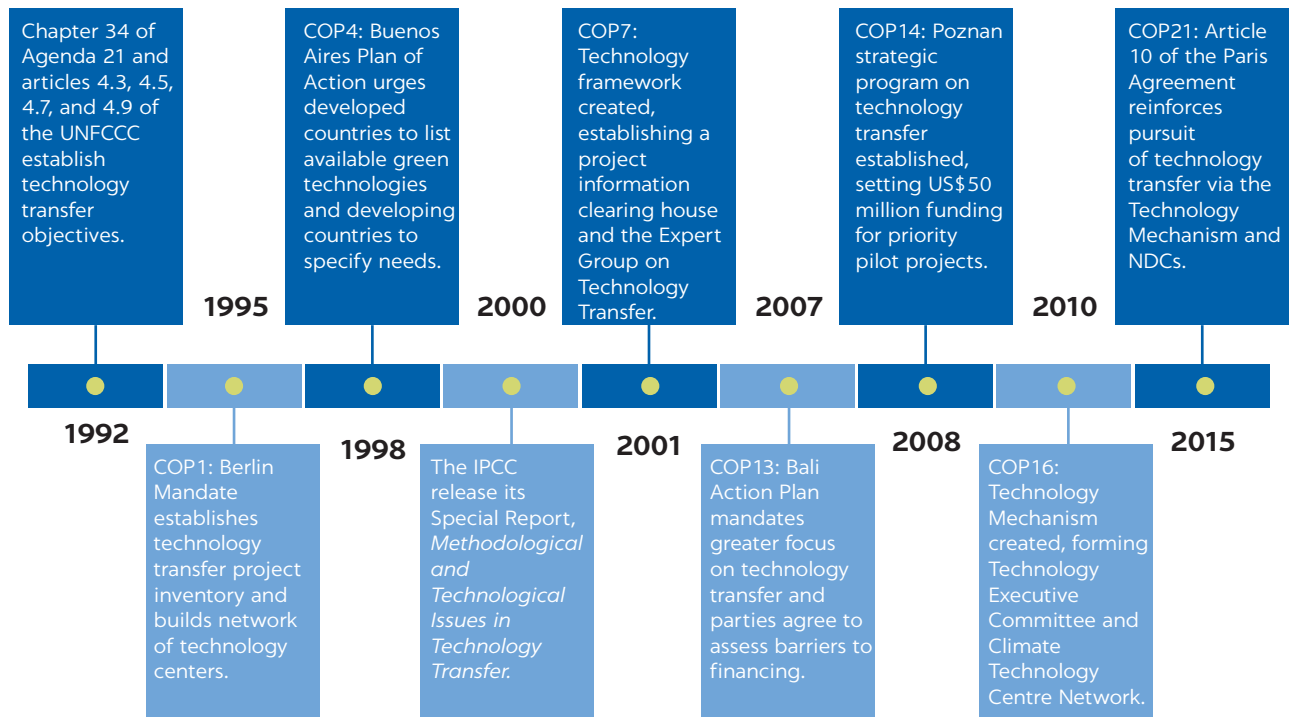
After the establishment of a legal and technical architecture for technology transfer under the UNFCCC, a succession of milestones has shaped subsequent efforts in the international arena: the adoption of a technology framework at the seventh session of the Conference of the Parties (COP7) in 2001, which established a project information clearinghouse as well as the Expert Group on Technology Transfer; the Poznan strategic program on technology transfer at COP14 in 2008; the creation of the Technology Mechanism at COP16 in 2010; and the continued recognition of technology transfer objectives in Article 10 of the Paris Agreement. Appendix A lists the various international legal provisions related to technology transfer, which establish the longstanding commitments of parties to the UNFCCC to facilitate and finance mitigation and adaptation-related technology diffusion in developing countries.

For nearly a decade, the UNFCCC has actively sought to synergize the independent activities of the Technology Mechanism and the Financial Mechanism, which together drive technology transfer efforts in the international arena. The Technology Mechanism consists of two branches: The Climate Technology Centre and Network (CTCN, the operational arm), and the Technology Executive Committee (TEC, the policy arm). The Financial Mechanism includes the Green Climate Fund (GCF), Global Environment Facility (GEF),<sup>2</sup> Special Climate Change Fund (SCCF), Least Developed Countries Fund (LDCF), and Adaptation Fund. In practice, integrating these arms and funds has involved translating developing countries' technology requirements into practical and bankable projects and linking the independent technical and financial mechanisms in operational and decision-making processes.

The expansive focus on the hardware, software, and orgware of technology transfer is enshrined in the mandates and activities of these key UN-level initiatives, described in figure 1.1. The two arms of the UNFCCC's Technology Mechanism are among the most important initiatives putting these concepts into practice. The CTCN, for example, has provided (or is currently developing) country-tailored practical solutions and financing for over 137 technology projects in response to individual country requests. CTCN's projects represent the formal execution of the UNFCCC's Technology Mechanism, whereas the TEC's policy-focused research, workshops, and knowledge dissemination represent its epistemic core.

The other two technology-related initiatives listed in figure 1.1—the GEF and the GCF—form part of the Financial Mechanism and belong to a broader set of multilateral climate funds including, among others, the Adaptation Fund, Clean Technology Fund, Forest Investment Program, Global Climate Change Alliance, LDCF, Partnership for Market Readiness, and SCCF. In aggregate, multilateral climate funds provided financing of US\$1.9 billion from 2015 to 2016, or just over 3 percent of total public flows of climate finance worldwide

(UNFCCC 2018). The remaining US\$56 billion in public climate-related finance came from bilateral government investment and multilateral development banks.

The main achievements of these technology transfer initiatives (described in the third column in table 1.2) provide several key takeaways: (i) the GCF has thus far provided funding commitments and emission reductions on the largest scale; (ii) the CTCN has in a short time pursued the largest number of mitigation and adaptation projects in developing countries facing a diverse set of challenges; and (iii) thus far, however, third-party evaluations of the economic and ecological benefits of these various projects are scant, which leaves some degree of uncertainty about which kinds of technology transfer projects have had the most success (in terms of scale, expertise employed, and terms of technology sharing).

The UNFCCC's track record on technology transfer over the past quarter century has sparked much debate. Early developments under the CDM, for example, were hampered by several issues, such as the additionality of CDM projects; the imbalanced concentration of most technology transfer projects in China and India (such as those under the CDM); the preference for CDM projects in China, involving higher profits from certified emission reductions (CER) for private actors, with far fewer projects transferring renewable energy technologies, delivering substantial CO<sub>2</sub> abatement, and leveraging longer-term benefits from R&D and innovation; a focus on transferring technology

“hardware” and relative neglect of “software” and “orgware”; the undifferentiated treatment of highly heterogeneous circumstances and technology needs in developing countries; and unresolved methodological issues in measuring the volume and effectiveness of technology transfer outcomes (Lema and Lema 2013; Phillips, Das, and Newell 2013; Watson et al. 2015; Zhang, Sun, and Huang 2018; Zhang and Yan 2015). Nevertheless, one encouraging result from CDM projects is that most renewable energy diffusion has occurred in countries with the least developed domestic financial markets, enabling deployment in places that otherwise have the most restricted access to financing (Kim and Park 2018).

These concerns have been largely soothed in recent years with the streamlining of technology needs assessments, the mobilization of greater volumes of multilateral climate finance, and country-tailored initiatives under the Technology Mechanism. The ultimate verdict, however, remains to be determined. “While the issue of technology transfer has continued to receive much attention in the international climate policy domain,” De Coninck and Sagar (2015) observe, “progress in enhancing our understanding of the various dimensions of technology transfer has been relatively limited.” Noting the slow progress made since 1992, some observers have questioned whether the UNFCCC can ultimately deliver on its technology transfer commitments (Glachant and Dechezleprêtre 2016).

## AVENUES AND DETERMINANTS OF LCT TRANSFER

LCTs may be transferred between countries and firms through several channels. Those channels include, among others, international trade, foreign direct investment (FDI), patents and licensing, the movement of people across countries, joint international research programs, cooperative agreements, and trade shows. Given the diversity of these channels and given that none of them alone provides unequivocal evidence of the full extent of technology transfer per se, measuring the quantity and quality of technology transfers necessarily involves multiple metrics. Each metric should be prioritized to varying degrees depending on the question, data availability, and data quality. Chapters 2 and 3 in this report undertake a deep analysis of the most important channels for transferring technology—international trade, FDI, and patents.

Previous scholars on technology transfer posit several key drivers of diffusion within countries and leapfrogging across countries: domestic absorptive capacity and technological capabilities (Cirera and Maloney 2017); human capital, skills, and relevant technical know-how (Nelson and Phelps 1966); the size of the market (Keller 2004); greater openness to trade (Keller 2004; Sachs and Warner 1995); geographical proximity to investors and financing (Comin, Dmitriev, and Rossi-Hansberg 2012); and stronger protection of intellectual property rights (IPR) (Dechezleprêtre, Glachant, and Ménière 2013; Dussaux, Dechezleprêtre, and Glachant 2018). Beyond the inverse of these factors, impediments to LCT transfer both within and across countries may include low levels of national income and a larger stock of existing high-carbon capital (refer to chapter 5).

Recognizing the trade-restrictive potential of certain investment measures and local requirements that discriminate against importers, the World Trade Organization (WTO) Agreement on Trade-Related Investment Measures (TRIMs Agreement) regulates trade in goods (but not services) and prohibits any measure inconsistent with the principle of national treatment (Article III of the General Agreement on Tariffs and Trade) and with the prohibition of quantitative import and export restrictions (Article XI). The TRIMs Agreement does not, however, formally cover the issue of international technology transfer via FDI and local content requirements, even though the latter are used frequently. Local content requirements necessarily imply discrimination between imported and domestic goods, and for this reason are inconsistent with the principle of national treatment enshrined in the TRIMs Agreement.

Various WTO agreements provide a legal foundation for balancing the interest in protecting IPR with the interest in enabling the uninhibited diffusion of technologies. IPR are protected and guaranteed under the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPs Agreement). Article 7 of the TRIPs Agreement requires that the international regime of IPR protection “should contribute to the promotion of technological innovation and to the transfer and dissemination of technology, to the mutual advantage of producers and users of technological knowledge and in a manner conducive to social and economic welfare.” As a counterbalance to Article 7, Article 8 has the purpose of safeguarding the international diffusion of technologies from the abuse of IPR protection in the formulation of national legislation; it safeguards the unimpeded diffusion of technologies against barriers arising from national policies that regulate different aspects of technology transactions, such as restrictive

business practices in licensing agreements (Correa 2007). Moreover, Article 66.2 establishes the specific obligation for developed countries to encourage the transfer of technology to least developed countries that are WTO members. To guarantee the regular monitoring of and constant adherence to this provision, the Decision on Implementation of Article 66.2 was adopted by the TRIPs Council in February 2003, resulting in the creation of the WTO Working Group on Trade and Transfer of Technology, to which developed countries must submit detailed annual reports.

### **Do IPR protection and trade openness support technology transfer?**

The question of whether strong IPR regimes and trade openness promote LCT diffusion (particularly in developing countries) remains a matter of contentious dispute. It is an essential area ripe for policy innovation and experimentation, with particularly promising ideas around patent pools and auctioning. Mansfield (1994) provides evidence that strict IPR regimes will have varying effects depending on the nature of the particular technology and industry, because technologies in some industries (such as metals and transportation) often require costly and complex complementary inputs and infrastructure that make it difficult for firms in less developed economies to exploit them. In contrast, other industries (such as chemicals and pharmaceuticals) tend to have products and supply chains that are more easily implementable, with companies more concerned about establishing strict IPR protection. To facilitate technology transfer and investment, firms in developing countries may have a vested interest in securing stronger IPR regimes as the domestic economy diversifies and climbs the technology ladder (Intarakumnerd and Charoenporn 2015).

Regarding the specific effect of IPR on LCT diffusion, the econometric literature finds some evidence of positive impacts. Using green patent data across 96 countries from 1995 to 2006, Dechezleprêtre, Glachant, and Ménière (2013) find that weaker IPR protection and lower openness to trade and FDI are associated with lower rates of LCT diffusion. Using data on trade and FDI between 140 countries from 2006 to 2015, Dussaux, Dechezleprêtre, and Glachant (2018) find that stricter IPR protections in countries outside the Organisation for Economic Co-operation and Development are associated with larger inward FDI by firms producing LCTs but have no significant effect on the imports of low-carbon capital goods. In chapter 3, this report returns to this question and contributes further evidence with a longer time frame and larger set of countries. The chapter concludes that IPR protection has no significant effect on LCT transfer from either high-income or developing countries.

### **Climate finance for LCT**

Climate finance continues to be one of the key issues on how the global community proposes to follow through with the implementation of the Paris Agreement, which aims at mobilizing US\$100 billion a year by 2020 from developed countries to developing countries. But what matters is not just the quantity of finance but also the composition and mix of investor types and financing mechanisms because they all influence the direction of LCT innovation and transfer

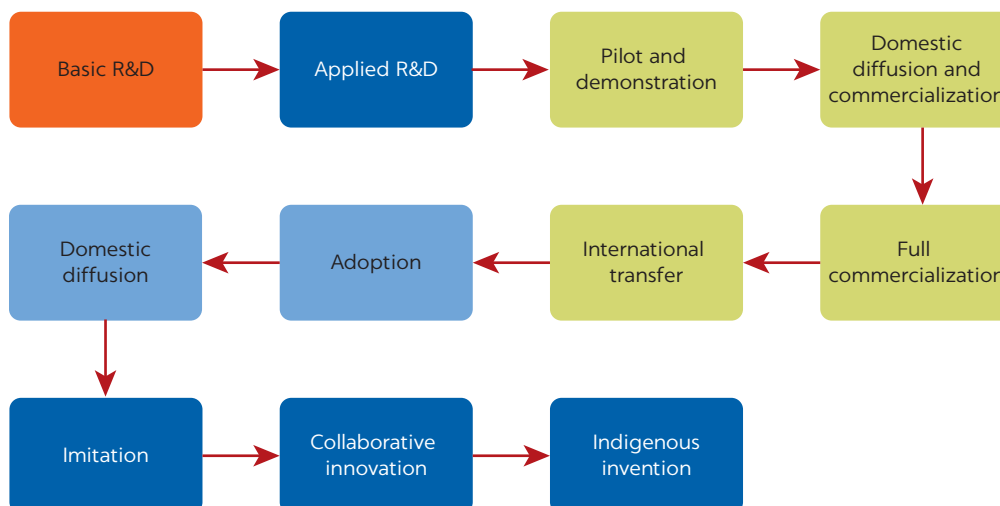
(Mazzucato and Semieniuk 2018). Lack of knowledge about the risk–return profile of investment in low-emissions technologies remains a key barrier along the entire technology chain, from innovation to diffusion, commercialization, international transfer, and further innovation. This lack of knowledge could lead to a skewed distribution of investment, with some areas overfinanced and others underfinanced.

This chapter does not address the issue of climate finance for LCT in a comprehensive way: this issue is complex and would deserve an entire new study. The chapter does present some insights into the landscape of LCT financing, the sources of finance, and the financing actors that are most likely to fund the different stages of the LCT transfer and innovation cycle. Chapter 5 will provide some answers to the question of how to mobilize larger amounts of finance for LCT transfer and innovation.

Figure 1.2 shows the stages of a typical LCT cycle. The cycle starts in developed countries with innovation—funded by R&D—which is followed by pilots and demonstrations, domestic diffusion, and commercialization. The technology may then be transferred to developing countries; through adoption, diffusion, imitation, and collaborative innovation, these countries may reach the final stage of indigenous innovation. These different stages are associated with financing from different sources and financial actors.

*Basic R&D* typically requires public financing because of its characteristics of public good. Private markets tend to undersupply R&D because knowledge spillovers prevent firms from fully appropriating the returns to their investments. Moreover, innovation requires long lead times and is highly uncertain. Private investors tend to favor low-risk R&D investments, and private investment in individual high-risk technologies is often driven by just two or three financial actors. Consequently, governments are more likely to provide the capital-intensive, high-risk financing needed to achieve innovations in LCT. Integrating environmental policy targets in technology policy

and research programs would help increase technological diversity and redirect funds into LCT research. Furthermore, public–private R&D partnerships could overcome competence lock-ins in fossil fuel–based technologies.

*Applied R&D:* Development and state banks, state corporations, and even institutional investors typically cover this stage, especially in cases involving large, expensive infrastructure projects. Governments and universities often provide proof-of-concept funds and demonstration support for small firms and start-ups, as do public and private incubators and accelerators.

*Pilot and demonstration:* Technologies at the pilot and demonstration stage face particular financing challenges that may lead to underinvestment and ultimately to the death of what could have been a promising innovation. Private financiers often refrain from financing these pilots unless public actors mitigate some of the risks. Testing and demonstration may necessitate some form of public support until these technologies can compete with more mature technologies. Missing physical infrastructure (such as power and transport) and scientific infrastructure (such as high-quality universities, research laboratories, and technical institutions dedicated to LCT) also represent significant barriers. Recently, energy crowdfunding platforms are being developed to address the financing gap for the LCT pilot demonstration phase. Policy makers can use fiscal incentives to support LCT in the adoption and diffusion stages, but the short-term nature of these incentives may discourage private investment (Polzin et al. 2015).

*Domestic diffusion and commercialization:* In this stage, private sector actors take the lead to foster diffusion of the technology, with banks, private equity investors, and internal funds providing financing. Business angels and venture capitalists often invest in start-ups and small innovative firms, whereas large or mature firms deploy internal funds for ongoing commercialization activities. Venture capital has played an important role in the uptake of LCT, especially the boom in solar power production in the late 2000s and 2010s; however, venture capital is often ill-suited to investments in clean energy projects or other forms of LCT deployment that involve long lead times, large sunk costs, or limited commercialization potential. Recently, crowdfunding has emerged as an alternative way to raise seed finance. Commercial banks and project financiers are important when technologies are fully commercialized.

From *international transfer* to *indigenous innovation*: Trade and direct investment have been the major conduits for global technology transfer for centuries. Obtaining financing for deployment of technology and for innovation is difficult in developing countries because of uncertainty and risks that are difficult to mitigate, lack of guarantees, poor creditworthiness, and low availability of public capital. Besides domestic financing—from government and public banks—the most significant public funding sources are development financial institutions (national, multilateral, and bilateral development banks) and international climate funds and aid agencies (often providing limited financing with a concessional or grant component). The CDM of the Kyoto treaty and climate funds under the Financial Mechanism of the UNFCCC have been important funding sources of climate change mitigation technologies. Blended climate finance has been successful in catalyzing private investment by providing funding at concessional terms that compensate for the higher cost of riskier technologies.



## CONCLUSIONS

This chapter has presented several findings to guide the next phase of LCT transfer and innovation internationally. First, historical energy transitions at the global scale have often been gradual, protracted processes lasting a minimum of fifty years, but numerous examples of expeditious transitions at the national level provide valuable lessons. Second, the mounting threat of global climate change—as well as the diverse array of economic, social, and ecological benefits of moving toward net-zero emissions—highlight the urgency of accelerating LCT innovation and diffusion both within and across countries. Third, because the cost and performance of many LCTs are rapidly improving, countries that make strategic steps to enhance their absorptive capacity, technological capabilities, and regulatory and legal frameworks could generate positive “tipping points,” turning technology-driven development into a self-reinforcing phenomenon (Arthur 1989). Finally, to realize these objectives, it is essential to fundamentally redirect substantial sums of domestic and international finance toward accelerated LCT and to greatly accelerate financing and technical assistance in the developing world.

The chapter has also discussed the international architecture for LCT transfer and innovation. Focused primarily on the North–South diffusion of technologies, the UNFCCC has not yet formulated any comprehensive international regulatory framework governing LCT transfer that addresses the particular challenges and opportunities of emerging South–South transfers. These transfers are likely to accelerate significantly even without a comprehensive international regulatory framework. It is with respect to the poor, least developed countries, however, that the UNFCCC has the greatest role to play in delivering results where markets alone have fallen short. For example, the Green Climate Fund could endeavor to leverage its unique network, institutional capacities, and financial wherewithal to acquire ownership and dissemination rights in patent-protected LCTs for expediting the technology transfer to poor countries through technology donations, aided by voluntary patent pool agreements. In practical terms, poor, least developed countries could lobby for cooperative and differentiated IPR arrangements within the UNFCCC and WTO by following the successful precedent set by the global health sector (see box 1.1).

Analogous international mechanisms could be based on the principle that the large-scale deployment of green technologies is a vital matter of economic security and planetary health. Differentiated legal treatment of patented technologies to promote the accelerated dissemination across poor, least developed countries would arguably have a strong legal basis within the WTO’s current legal structures and, moreover, could revamp stalled negotiations around the WTO’s Environmental Goods Agreement (refer to chapter 2). Moreover, it was, after all, the poorest countries with the least access to financial markets that attracted a disproportionate share of investment in renewable energy projects under the CDM, highlighting the potential for leveraging UNFCCC initiatives in poor countries (Kim and Park 2018). It was also the least developed, small island nations that lobbied successfully for the inclusion of commitments to pursue efforts to limit global warming to below 1.5°C under the Paris Agreement—a goal that was widely considered unattainable in prior years. Cooperative IPR arrangements such as cross-licensing, patent pooling, technology standards agreements, and other forms of technology sharing could have the greatest, outsized positive impact in the poorest countries with least access to finance.



## BOX 1.1

**Patents and medicines for all**

In response to rising drug prices and patent-related international trade rules that had severely restricted access to life-saving drugs (for example, patented HIV/AIDS medications) in the 1990s, a global political mobilization successfully pressured the international community to deliver the World Trade Organization's Doha Declaration on the Agreement on Trade-Related Aspects of Intellectual Property Rights and Public Health in 2001. The Declaration affirmed that patent rules should be interpreted and implemented to protect public health and to promote access to medicines for all. This resulted in large-scale

access to generic versions of patented medications by over 60 low-income and middle-income countries and a dramatic decline in prices (Hoen et al. 2011). Further progress has been made since 2010, when Unitaid established the Medicine Patent Pool (MPP), a mechanism for negotiating voluntary licenses that enable the transfer of high-quality, low-cost HIV, hepatitis C, and tuberculosis medicines in low-income countries. The MPP is expected to generate direct savings of about US\$2.3 billion (in net present value) by 2028, with every dollar spent on the MPP generating US\$43 in savings in the provision of global public health.

Finally, the critical task before policy makers and firms in the South is to attain a solid conceptual grounding that can guide cross-sectoral efforts in implementing a low-carbon development strategy. As will be discussed in chapter 5, a critical first step is to formulate and implement systemic policies such as carbon pricing and the removal of direct or indirect subsidies for polluting activities complemented by demand-pull and technology-push measures as well as adequate funding. In each sector or technological area, governments that successfully align policies covering each of these domains are far more likely to create productive synergies that deliver outsized impact (Grubb 2014). Policy makers and firms can endeavor to use the best available knowledge about the drivers of (and impediments to) LCT diffusion and pursue policy packages that increase the likelihood of garnering productivity spillovers and accelerating low-carbon growth.

**NOTES**

1. In this report “the global South” (or “the South”) is broadly defined as all the countries not included in the World Bank definition of high-income countries.
2. Since its formation in 1992, the Global Environment Facility (GEF) has long-running operational experience with financing and facilitating pilot technology transfer projects through four regional initiatives: the Finance and Technology Transfer Centre for Climate Change (FINTECC), Special Climate Change Fund Program for Technology Transfer (SCCF-B), the African Climate Technology Centre (ACTC), the Climate Technology Transfer Mechanisms and Networks in Latin America and the Caribbean (IDB), and the Asia-Pacific Climate Technology Network and Finance Center (CTNFC).

# 2 Trade and Foreign Direct Investment as Channels of Low-Carbon Technology Transfer

## INTRODUCTION

International trade and foreign direct investment (FDI) are two of the most important channels for the international diffusion and transfer of technology. Firms that engage in international trade tend to be larger, more productive, and more technologically advanced than firms operating solely in a domestic market (Claessens and Schmulker 2007; Helpman, Melitz, and Yeaple 2004; Keller and Yeaple 2009). Whereas trade offers the ability to quickly move technology embedded within physical products, FDI offers the potential to transfer physical products and the knowledge, skills, and processes to produce or operate them.

The extent to which trade and FDI do transfer technology and knowledge is difficult to disentangle. Commonly cited studies from the late 1990s and early 2000s find little evidence of significant knowledge and productivity spillovers from FDI and trade (Gorg and Greenaway 2004; Gorg and Strobl 2001; Meyer 2004). The explosive growth of global value chains (GVCs) from the late 1990s onward dramatically altered these dynamics, with the academic and economic literature later finding more consensus on the positive relationship and higher potential for welfare gains delivered through trade and FDI.

This chapter begins with an assessment of international trade and FDI as channels for increasing the transfer of low-carbon technologies (LCTs). Next, the chapter provides empirical evidence on the extent to which the traditional North–South technology transfer paradigm is still valid or is shifting to more complex modes (Chen 2018; Kirchgerr and Urban 2018; Urban 2018). Specific focus is given to the role of emerging economies—especially China, whose impact on these shifting patterns of LCT trade and FDI is unmatched. This analysis aims to provide further empirical support for evidence-based policies that can more effectively foster the transfer of LCTs.



## CHANNELS FOR TECHNOLOGY TRANSFER

Technology can be transferred through multiple transmission channels that can be categorized into seven types:

1. Importation of intermediate and capital goods through international trade
2. Movement of capital and knowledge through inward and outward FDI, including joint ventures
3. Movement of people through migration or through business, travel, and educational purposes
4. Licensing for the use of foreign technologies (for example, patents, copyrights)<sup>1</sup>
5. Collaboration on international research
6. Integration into GVCs, benefitting from knowledge and technology transfer between buyers and suppliers
7. Diffusion of codified and disembodied knowledge through the Internet and other media (Fu, Pietrobelli, and Soete 2011)

This chapter focuses on the first two such channels: LCT transfer through international trade and through FDI. Patents are discussed in depth in chapter 3. Additional channels for the transfer of LCT are recognized but not examined explicitly in this chapter.

International trade and FDI can introduce goods and services that are less polluting and more energy-efficient compared to those currently available on a domestic market, can foster spillovers of environmental good practice to domestic firms, and, in exceptional cases, can lead to technology leapfrogging (Gallagher and Zarsky 2007). But they can also bring heavily polluting “brown” technologies. Whether and how trade and investment create pollution havens by entering markets with lower environmental standards and resulting in increases in carbon dioxide (CO<sub>2</sub>) emissions remains an open debate.<sup>2</sup> Measuring the extent and the impact of brown technology transfers is a critical area for investigation but is beyond the scope of this chapter.

Unlike other forms of technology transfer, trade moves a physical product with embedded technology between locations relatively quickly. Even the world’s largest cargo can be transported around the globe in just a matter of weeks. By leveraging global markets to tap into the larger stock of knowledge from cumulative research and development (R&D) activities in the North, countries in the South can import a variety of intermediate products and capital equipment they could otherwise not afford or produce domestically (Coe, Helpman and Hoffmaister 1997; Grossman and Helpman 1991; van Pottelsberghe de la Potterie and Lichtenburg 2001).

Importing low-carbon capital goods (machinery) has traditionally been considered the most robust channel of technology transfer via trade because it increases productivity and the likelihood of generating positive environmental and innovative externalities (Navaretti and Tarr 2000). Further analyses suggest that importing intermediate goods can be equally impactful (Taglioni and Winkler 2016). In light of the urgent need to scale up deployment of LCTs across all countries, including those with limited technological capacity, trade offers the quickest mechanism for delivering and deploying LCTs.

Technology transfers through FDI are often considered more knowledge-intensive than those through trade because of the longer-term and deeper engagement in the receiving country (Dechezleprêtre, Glachant, and Ménière 2013). Assessments on which types of firms benefit from FDI spillovers tend to find that small firms with low productivity can often benefit the most (Keller and Yeaple 2009).

Increasingly, research finds that FDI-receiving countries benefit strongly from direct and indirect knowledge spillovers between foreign and domestic firms (Bitzer and Kerekes 2008; Dechezleprêtre, Glachant, and Ménière 2013; Newman et al. 2015). Multinational firms that invest around the world tend to share certain characteristics: they are technologically advanced and operate at higher international standards, including using management systems that monitor and actively seek to reduce environmental impacts. In the case of high-tech sectors—where many LCTs would be considered—FDI spillovers are found to have even more impact (Keller and Yeaple 2009).

Furthermore, FDI is a crucial source of financing for the deployment of LCTs (Buchner, Brown, and Corfee-Morlot 2011; Golub, Kaufmann, and Yeres 2011). FDI into renewable energy (RE) is most often invested to develop downstream power production facilities and other infrastructure assets, rather than into the manufacturing processes that could lead to more knowledge and skills spillovers in the domestic economy. In addition, FDI can crowd out domestic companies, push lower-productivity firms into bankruptcy, and lead to the capture by foreign firms of monopoly rents in underdeveloped sectors.

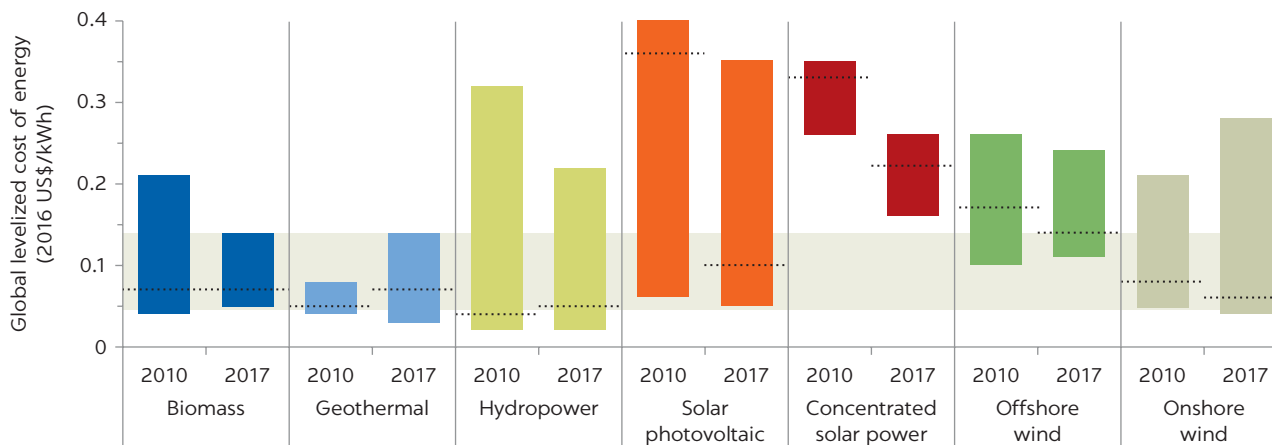
## MEASURING TRADE AND FDI

The trade analysis in this chapter is based on trade data obtained from the United Nations International Trade Statistics Database (UN COMTRADE), using the Harmonized Commodity Description and Coding System (HS).<sup>3</sup> At the most granular six-digit level recognized by the World Trade Organization (WTO), very few subheadings contain products that are exclusively low-carbon or are used only in the production of environmentally friendly LCT. Most products are lumped together with similar products that can be considered “dual use”—meaning they may or may not be climate-friendly. This chapter relies also on trade values because the units and prices reported to UN COMTRADE vary by country and by product, complicating direct comparisons through available data.

The falling cost of production of many LCT products means that nominal and real value of trade flows may differ substantially. Manufacturing prices of many LCTs in the early 1990s were vastly higher than they are today. Increasing economies of scale through deployment and accelerated technological progress have helped to create a virtuous circle of falling costs. According to the International Renewable Energy Agency (IRENA), solar photovoltaic (PV) module prices have fallen 80 percent over the past decade, and wind turbine prices have been reduced between 30 and 40 percent.<sup>4</sup> Therefore, it is likely that trade figures overestimate the flow of technology in the 1990s and early 2000s and underestimate the amount of technology transfer happening today.

The dashed lines in figure 2.1 show the global weighted average of the levelized cost of energy (LCOE)<sup>5</sup> for plants commissioned in 2010 and 2017. This average has fallen dramatically for solar PV and concentrated solar power (CSP) and to a lesser extent for on- and offshore wind, according to IRENA.

FDI—to the extent that the data are available and reliable—is at best a proxy for technology transfer. FDI data are notoriously unreliable because many announced investments take years to come fully online—if they do at all. This makes accurately tracking the transfer of funds and technologies complicated.<sup>6</sup> Occasionally, the motivation of a firm is quite clear when the investment is a one-off, asset-seeking acquisition—such as the very well-noted acquisition of German wind engineering firm Vensys by China’s Goldwind in 2008—but this clarity is quite rare.

This chapter uses the most accurate available FDI data by focusing on investment in RE. Other low-carbon FDI—in agriculture, mining, forestry, and construction—are not assessed. Calculating investment in these other sectors would require a case-by-case assessment and access to firm’s private data (Golub, Kaufmann and Yeres 2011).

### Identifying traded LCT

Determining which products to include in an analysis of LCT is a challenge. This difficulty is perhaps best evidenced by the collapse of the WTO Environmental Goods Agreement (EGA) negotiations in late 2016 when negotiators could not agree on competing lists (de Melo and Solleder 2019; ICTSD 2016). Although consensus has not been reached on a list of environmentally friendly goods, this chapter draws on three well-established and well-recognized lists, each produced by a different type of stakeholder: an international organization (the World Bank), the multilateral Asia-Pacific Economic Cooperation (APEC) forum, and academia.<sup>7</sup> Each list varies in scope but provides a representative and manageable sample of traded climate change mitigation technology products—backed by a degree of consensus on their

environmental friendliness—for deeper analysis.<sup>8</sup> Box 2.1 gives a brief overview of the lists adopted for this report. After eliminating duplications, the combination of all the products in those three lists results in a new list comprising 107 traded LCTs.<sup>9</sup> That list is provided in appendix B.

Each list described in box 2.1 contains a different mix of capital, intermediate, and consumption goods, as defined by Broad Economic Categories<sup>10</sup> (table 2.1). The mix of technological sophistication of the goods on each list also differs, pointing to the fact that technology transfer is not exclusively high-tech (table 2.2). The World Bank Group list actually includes eight low-technology products, and the Glachant, Dussaux, and Dechezleprêtre list includes five natural resource-based products used as inputs to more sophisticated LCTs. Notably, all three lists exclude lithium (HS 282520) and lithium batteries (HS 850650), which have become commonly used in the manufacturing of electric vehicles and many other energy storage systems. Lithium’s absence highlights another challenge of codifying LCT lists—technological change.

The following section uses gross trade data from the UN COMTRADE database to quantify LCT trade between countries and to explore the importing and exporting patterns of emerging economies to determine the direction of North and South trade flows. We recall that, for the purposes of this report, the World Bank’s income group classifications are used to define the “North” as high-income countries and the “South” as all economies not classified as high income. Special attention is paid to emerging economies—including Brazil, China, India, Mexico, the Republic of Korea, and South Africa—and their relative success or lack thereof in absorbing LCT and developing their own LCT sectors.

## BOX 2.1

### Lists of climate change-related technologies

**Asia-Pacific Economic Cooperation List of Environmental Goods (APEC54):** Asia-Pacific Economic Cooperation (APEC) members endorsed this list in 2012, pledging to reduce applied tariff rates on these products to 5 percent or less by the end of 2015. The agreement was intended to signal commitment to pursuing green growth objectives, addressing climate change, and securing sustainable economic development. The list contains many dual-use products, and member states were allowed to exercise “ex-outs” to avoid tariff reduction commitments on goods they deemed of national interest.

**World Bank Group Climate-Friendly and Clean-Energy Technologies List (WBG43):** The World Bank’s *International Trade and Climate Change: Economic, Legal, and Institutional Perspectives* (World Bank 2008) report identified 43 traded

“climate-friendly and clean-energy technologies.” The report discussed the need for liberalizing trade in clean energy technologies, while at the same time flagging the issue of carbon leakage in developing countries. At that time, the authors found that the complete zeroing of tariffs on these 43 goods would lead to a 7 percent increase in the volume of trade.

**Glachant, Dussaux, and Dechezleprêtre List of Climate Change-Related Technologies (GDD30):** Glachant, Dussaux, and Dechezleprêtre have authored many peer-reviewed publications on the international diffusion and transfer of low-carbon technologies. Their analysis is based upon a list of 30 low-carbon technologies, including various types of renewable energy technologies, energy storage, electric and hybrid vehicles, and other products related to energy efficiency in construction and heavy industries.

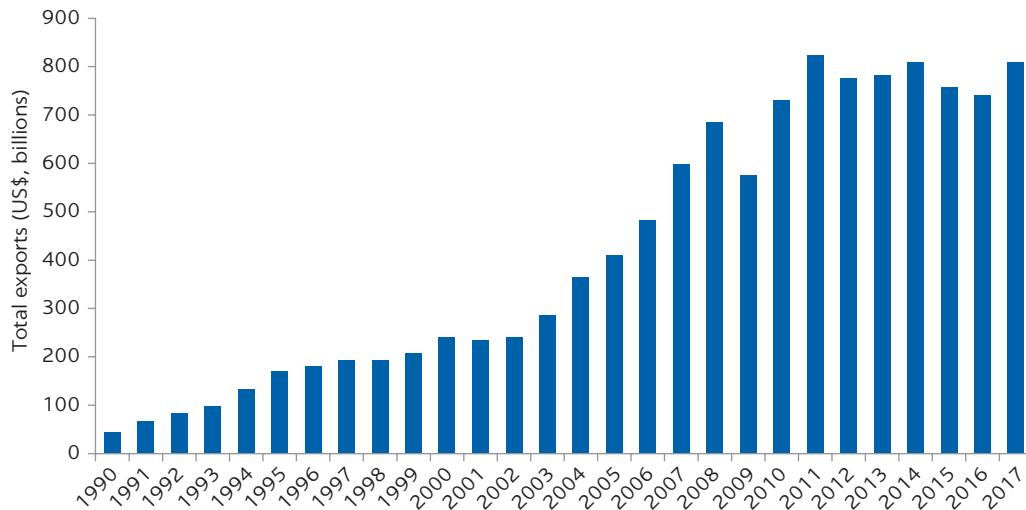

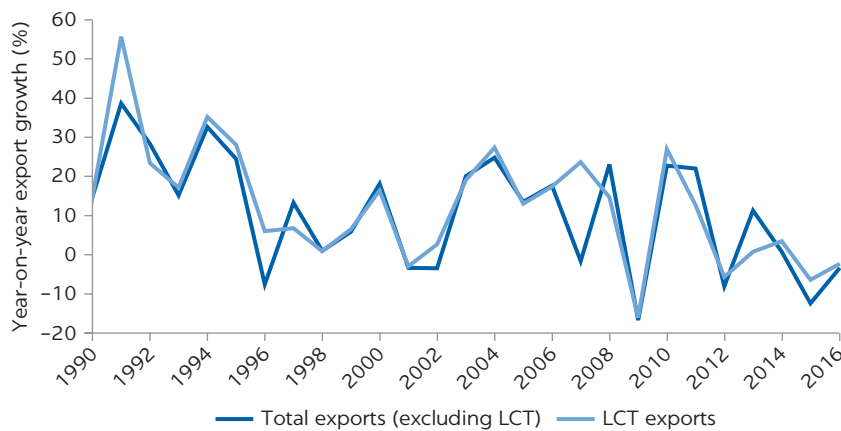
## TRADE AS A CHANNEL OF LCT TRANSFER

Global trade of these 107 LCTs has plateaued since 2011, a potentially worrying sign for climate change mitigation. Exports have risen nearly 20-fold—from US\$43.6 billion in 1990 to an estimated US\$809.9 billion in 2017 (figure 2.2). Despite strong year-on-year export growth in the early 1990s and 2000s, LCT trade has actually failed to grow in value terms in three of the past six years. Bilateral trade volumes have fluctuated by product and country pair, with no clear pattern of continued decline or growth. If one uses installed capacity of RE as an indicator of LCT trade volumes, the steady rise in installed capacity would suggest more production, and potentially trade, of these products albeit at lower prices. This increase, however, would include only a subset of the 107 LCT products.

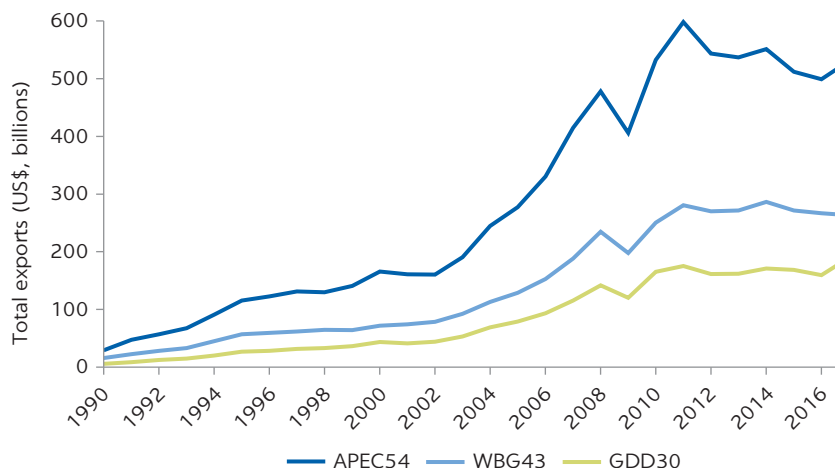
**FIGURE 2.3****LCT export growth versus growth of all exports, excluding LCT, 1990–2016**

The slowdown in year-on-year growth in trade values is slightly less worrying considering the general slowdown in global trade. Figure 2.3 illustrates how the year-on-year growth of LCT exports has tracked that of total exports relatively closely, indicating that LCT trade is not immune to macroeconomic conditions. On the positive side, however, LCT exports have been growing at a compound annual growth rate of 11.1 percent, outpacing that

of total exports (9.7 percent) and merchandise exports (6.0 percent) from 1990 to 2016, and faster (4.2 percent) than the broader universe of high-technology exports (3.4 percent) since tracking of these exports began in 2000. In addition, available 2017 trade data already show a year-on-year increase of 11.4 percent in total value of exports, even though not all countries have yet reported.

Each of the three LCT lists (APEC54, GDD30, and WBG43) has shown a similar trend of strong export growth before tapering off in 2011 (figure 2.4). Despite the differences in the number of products included in the lists, their varying composition along final use, and the diversity in technological sophistication, export flows for each list mirror each other quite closely. The 107 LCTs identified for this chapter accounted for a 4.3 percent share of global exports in 2016, up from 3.1 percent in 1990.<sup>11</sup>

### Trade of LCT by income group

This section decomposes total trade of LCT by income group, matching trade data to the income classifications each year or over a time period. Roughly one-third of countries are classified as high income in 2019 (see table B.3 in appendix B). The number of high-income countries has more than doubled since 1992, the year climate change was drawn into the public spotlight during the Rio Earth Summit. Since that time, the number of low-income and lower-middle-income countries has shrunk by over one-third. When interpreting trade flows by income group, it is important to recognize that the total number of countries in each group has shifted year on year, with the number of high-income and upper-middle-income countries growing and the number of low-income and lower-middle-income countries shrinking. Box 2.2 highlights the reclassification of important emerging economies featured in this analysis.

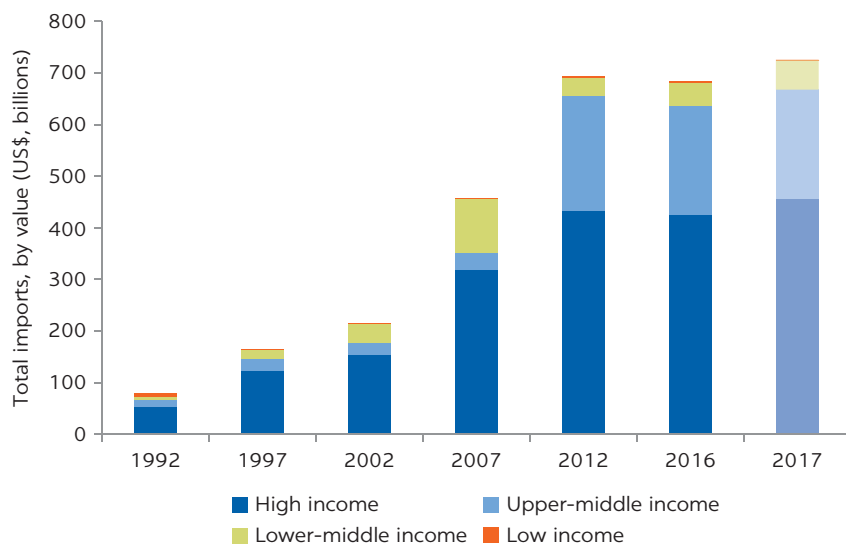
## BOX 2.2

## Income group classification changes, select countries

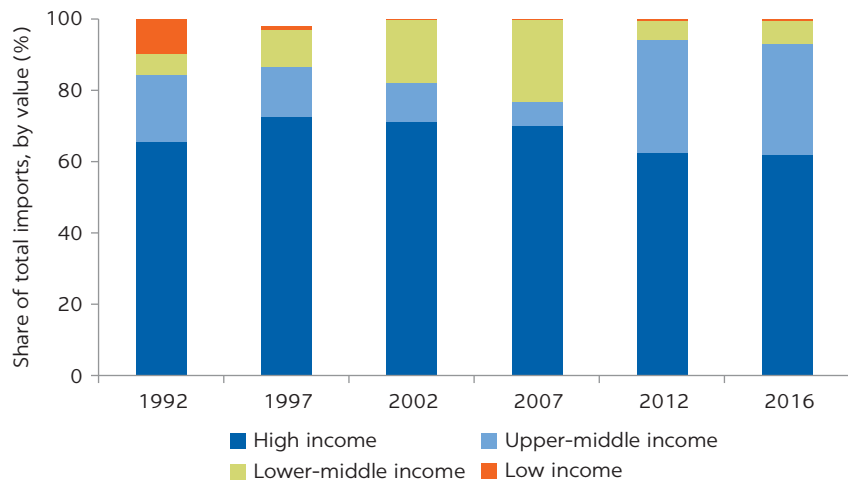

### Imports of LCT by income groups

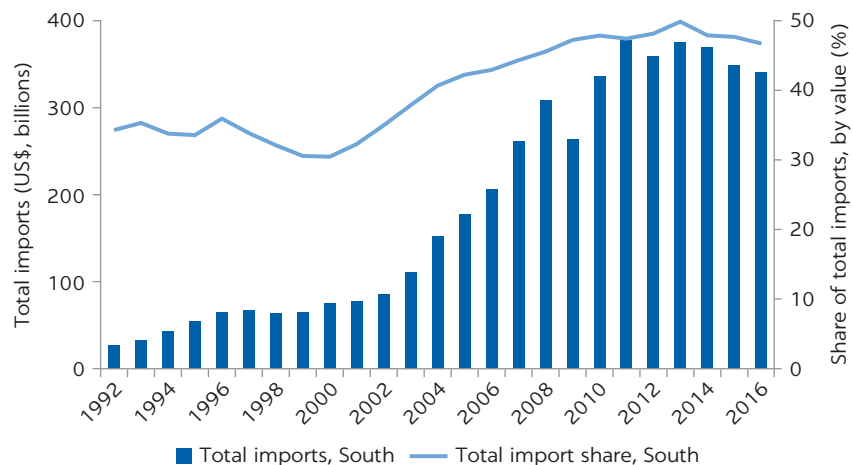
The ratio of imports by countries in the North and South has narrowed slightly since the early 1990s, taking into account the shifting composition of countries within each income group over time (figure 2.5). Higher income per capita is strongly correlated with higher imports of LCT, supporting Kuznets’s hypothesis of higher demand for environmental quality as income per capita increases (Pueyo and Linares 2012). Indeed, when one holds the 1992 income group classification constant (figure 2.6), LCT imports have risen sharply among lower-income countries, especially as those countries have graduated into higher-income classifications. In 1992, for instance, only 23 of 125 low-income and lower-middle-income countries were importing LCT products. By 2016, nearly two-thirds (53 of 84) of countries still classified as low income or lower-middle income were importing LCT (figure 2.7).

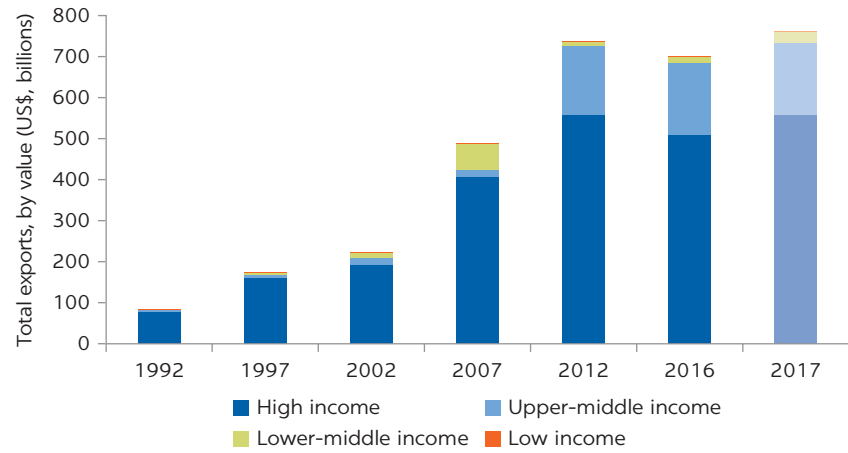

China is now the world's top importer of these 107 LCT products (15.9 percent), ranking ahead of the United States (13.2 percent) and Germany (6.9 percent) in 2016 (table 2.3). The share of imports among these top three markets has been fairly consistent over the past decade, with the United States slightly narrowing the margin with China since 2014. China accounts for more than 40 percent of all LCT products imported by developing countries. In 2017, China imported more than US\$1 billion of 23 separate goods, up from 19 in 2016. Mexico was the second-largest market for LCTs in 2016. No other developing countries rank in the global top 10. The third-largest importer among countries not classified as high income was the Russian Federation, which had previously been classified as high income from 2012 to 2014.<sup>12</sup> Turkey, Thailand, and Vietnam, which have enjoyed relatively strong economic growth over the past 20 years, have also emerged as growing markets for LCT (table 2.4 and table B.5 in appendix B).

### Exports by income groups

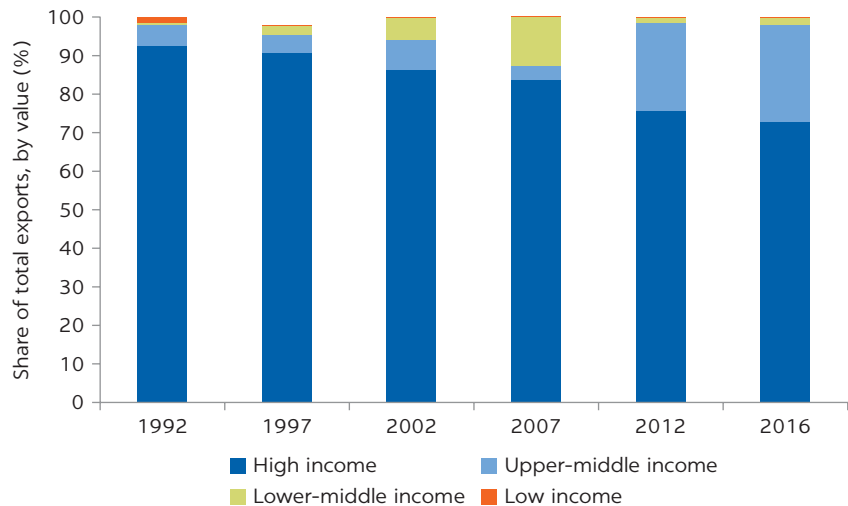
Developing countries’ share of global LCT exports by value has grown considerably since the early 2000s, primarily driven by China’s rapidly growing competitiveness in LCT-related export sectors (figure 2.8). With the exception of China, LCT technology and knowledge remains concentrated in developed economies—although this includes recently developed high-income economies such as the Republic of Korea and Taiwan, China.<sup>13</sup> Together, high-income economies accounted for 72.8 percent of total LCT exports by value in 2016, nearly triple the share of upper-middle-income economies (25.1 percent) (figure 2.9).

China was the world's top exporter of the 107 LCTs in 2016, accounting for 16.8 percent of total exports (table 2.5). In terms of exports to each income group, China is the top exporter of LCT to each of the income categories besides its own (table 2.6 and table 2.7). It ranks fourth in terms of total exports to upper-middle-income economies, in part because China itself is the largest importer of LCT in that group. Mexico was the second-largest exporter among developing economies, with 2.7 percent of global market share, followed by Malaysia, Thailand, India, and Vietnam. Notably, 8 of the 10 top developing economy importers of LCT are also among the top-10 exporters of LCT, suggesting that there is not only demand for low-carbon products but also the capabilities to produce LCT for other markets.

Low-income countries play very little role in LCT markets, either as buyers or sellers, and are less active in LCT trade than they are in trade of all

goods (table 2.8). In 2015–16, the distribution of LCT imports and exports by income group was not dramatically divergent from the distribution of trade of all goods among income groups (table 2.8). High-income countries are slightly larger exporters of LCT, and upper-middle-income countries are slightly larger importers of LCT.

Low-income countries and lower-middle-income countries together accounted for just 2 percent of exports of the 107 products in 2015–16, 1.9 percent and 0.01 percent, respectively. This finding should not be misconstrued as meaning that low-income countries are completely absent from low-carbon industries. Some of these countries play an important role in upstream segments of the supply chain. For example, the manufacture of a crystalline silicon solar PV module requires silica and silver as raw materials, the latter of which is produced primarily in Bolivia, Mexico, and Peru. These raw materials are then traded to be processed into polysilicon, silver paste, and glass and traded again before finally being assembled to create crystalline silicon PV wafers and cells (CEMAC 2017). These upstream activities are rarely included on lists of environmentally friendly production.

### South–South trade

Patterns of LCT trade need to be considered within the context of South–South trade to determine if they are shifting (table 2.9). Overall, global trade as a percentage of gross domestic product has yet to regain the momentum it had before the 2008–09 financial crisis, showing weaker than expected performance again in 2018.<sup>14</sup> In 2016, South–South trade accounted for 11.2 percent of total global trade. Growth has slowed in emerging markets and developing economies, although developing countries' trade with China has shown resilience (see UNCTAD 2018; World Bank 2019). Before 2016, South–South trade had been

rising steadily since the early 1990s, outpacing the growth rate of total world trade (measured in either imports or exports).

In 2016, South–South trade accounted for 9.0 percent of all LCT exports, but for 11.2 percent of total global exports. The share of North–South trade, the traditional direction of technology transfer from more to less advanced countries, is noticeably higher for LCT products than for total goods. China, the Republic of Korea, the United States, Japan, and Germany are the top-five exporters of LCT to the global South. China is the top destination market of each exporter, with the exception of the United States, which exports more LCTs to Mexico, with China as its second-largest LCT export destination.

The share of South–North and South–South trade has risen steadily since the early 1990s, which suggests growing capabilities in the South. Meanwhile, the share of North–North trade has fallen sharply since the early 2000s, likely because of increased domestic production and offset by imports from China and the global South. North–South trade has risen significantly and now represents about a quarter of all LCT trade.

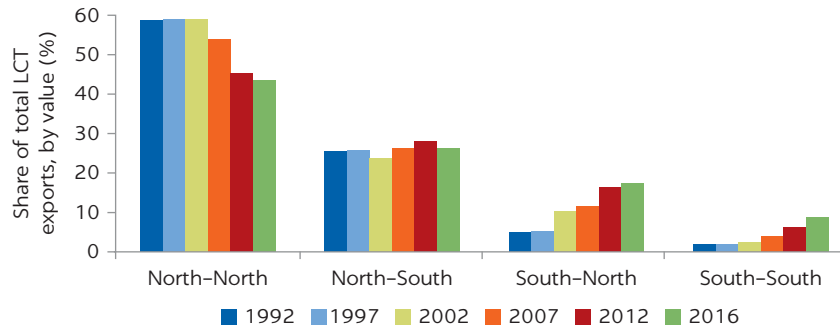
Although South–North LCT trade flows have grown, only a few countries are participating in this phenomenon to any significant degree. China accounted for 56.1 percent of the total value of LCT exports from South to North in 2016. Mexico had the second-largest share of South–North exports, accounting for 13.6 percent. Brazil, India, and South Africa account for much smaller shares of South–North exports, providing a combined 4.3 percent of exports to high-income countries.

Removing China as an importer and exporter from the dataset, we find that both South–North and South–South trade have still been increasing (figure 2.10). Since 2002, the share of exports from South to North has increased 40.2 percent, and the share of trade between developing countries has more than doubled (figure 2.11). These gains are relatively small in terms of total value, but they are encouraging.

### Trade of select developing countries

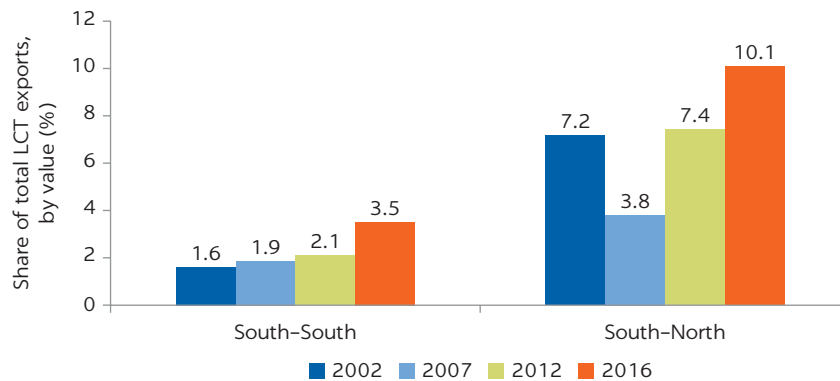
As evident through the trade analysis, emerging economies play an important role in the transfer of LCTs. This section focuses on six countries—Brazil, China, India, Korea, Mexico, and South Africa—selected on the basis of their current and future importance in the production, trade, and deployment of LCTs. As centers of production and critical hubs in regional and global value chains, these countries are positioned for continued economic growth. But growing

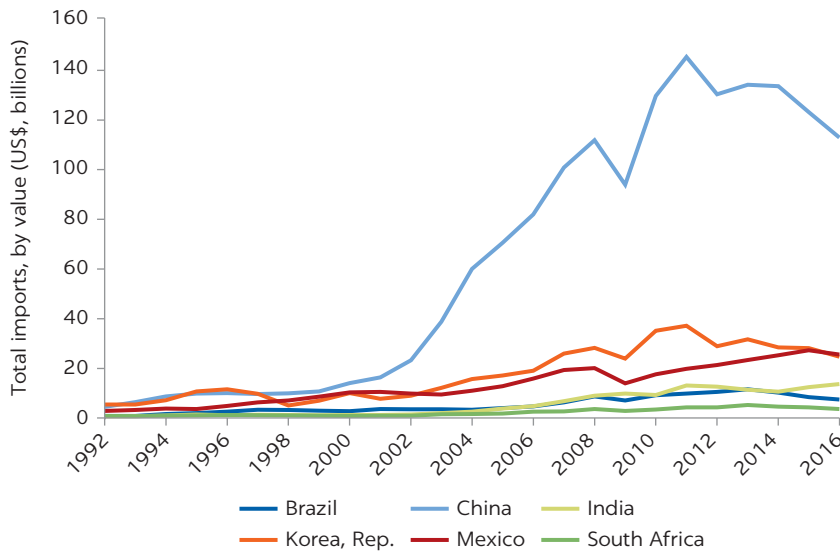
sustainably will increasingly hinge on producing more with less, reducing the carbon intensity of production, and mitigating environmental impacts.

These six countries, in particular, have an important role to play not only in absorbing the LCTs necessary to speed their own transitions to low-carbon economies but also in transferring these technologies to low-income and lower-middle-income neighbors. China and Korea have already become quite successful in attracting and absorbing new technologies, using this success as a lever to rapidly drive indigenous innovation. Others have had varying degrees of success, integrating into some GVCs (for example, Brazil, Mexico, and South Africa in the automotive GVC) but remaining outliers in many other LCT industries.

China first diverged from its peers in the early 2000s, beginning to increase its imports before also becoming, a few years later, a major exporter of LCT (figure 2.12 and figure 2.13). Each country began by importing more LCTs than it exported, suggesting these technologies were first introduced and absorbed before indigenous innovation processes set in. South Africa was the first of these

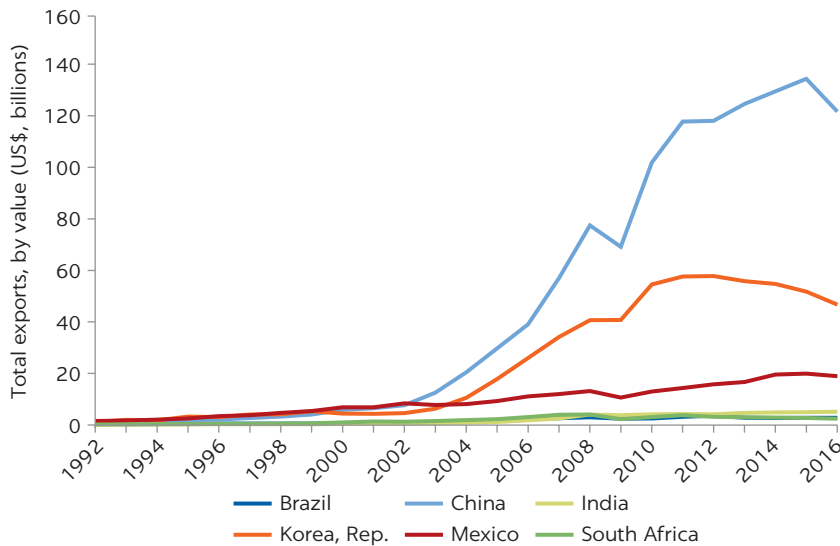
## Total LCT imports, select countries, 1992–2016

countries to become a net LCT exporter in 2000 but reverted to being a net importer in 2009. Korean LCT exports overtook imports in 2005.

Among its peers, China is the largest exporter of LCT (figure 2.13). Mexico's market share grew in the 1990s, but it shrank from the 2000s onward. Brazil, India, and South Africa have not been able to keep pace with their peers; however, India's exports have been growing since 2012, diverging from Brazil and South Africa, whose LCT export industries have stagnated.

Table 2.10 shows the top import origins and export destinations for Brazil, China, India, Korea, Mexico, and South Africa. Similar to the network structure of GVCs in other sectors, most LCT trade centers around the hubs of China, Germany, and the United States. The largest shares of imports tend to come from the geographically closest hub, with the exception of South Africa, which imports more from China despite its being at a further distance than Europe. A similar pattern is observed for top export destinations, along with the introduction of regional markets as important export destinations. These trade patterns suggest complex, interrelated trade relationships, where technology transfer is an inherent dimension of the business ecosystem.

Of the total US\$404.9 billion of LCT products exported by the selected countries to all partners in 2017, only 0.5 percent of the total was exported to low-income countries and about 30 percent to the North. China accounted for the largest value of LCT exports to low-income and lower-middle-income countries, followed by Korea and India. Interestingly, of the 34 destination countries for Indian LCT exports in 2017, 27 were in Sub-Saharan Africa. For South Africa, essentially all LCT exports to low-income countries in 2017 went to partners in Sub-Saharan Africa—led by Mozambique, the Democratic Republic of Congo, and Zimbabwe. These trends emphasize the role of global as well as regional value chains.

### Product-level analysis

Reflecting the bilateral trade relationships, the most commonly traded individual LCT products are also part of complex, interrelated trade networks. For both imports and exports of the 107 LCT products identified in this chapter, 4 of the top-5 traded products are the same. These 4 products accounted for over 30 percent in 2017. Perhaps unsurprisingly, the same 4 products were also in the top-5 imports and exports of the six countries selected for analysis.<sup>15</sup>

Untangling which countries import or export which LCT requires firm-level analysis methodologies. For instance, China's top import in 2017 (optical devices, appliances, and instruments) was also its top export. China's and Korea's top-five LCT exports accounted for over half of their LCT exports in 2017, whereas Mexico's top-five products accounted for just slightly less than half of its export basket. India is the only country to import more from developing countries—primarily China and other upper-middle-income countries—than it does from developed countries, which could signify that it is not importing the most advanced technology but rather more suitable or affordable technologies from its developing peers.

Clear dependencies are also evident in the trade data. By far India's top import in 2017 was solar PV/LEDs from China. Mexico specializes in exporting electric control panels, essentially all of which went to the United States. As evident in table 2.10, Mexico is primarily a supplier to the United States and is yet to advance into neighboring regional markets, with only 4.2 percent of its total LCT exports by value destined for developing countries in 2017.

## FDI AS A CHANNEL OF LCT TRANSFER

FDI into LCT is a critical channel for technology transfer to developing countries seeking to grow domestic industries, produce lower-carbon products, and put themselves on a path toward sustainable economic growth. UNCTAD (2010) defines “low-carbon foreign investment” as the transfer of technologies, practices, or products by multinational firms to host countries—through equity and nonequity forms of participation—such that the firm's operations, products, and services generate significantly lower greenhouse gas emissions than would otherwise prevail in the industry under business-as-usual circumstances. UNCTAD also considers the acquisition of LCTs, processes, and products as low-carbon foreign investment.

FDI data are not as systematically captured as trade data, and thus leave much to be desired in terms of coverage and accuracy. The simplest, most accurate way to measure FDI into LCT is to focus on RE investments. However, even within this more narrowly defined sector, data coverage is limited, especially for developing countries. Often, it is not national governments or even national state-owned utilities but rather cities, community energy projects, and large corporations that invest in RE (Motyka, Slaughter, and Amon 2018). Table 2.11 captures some of the general determinants of FDI as well as how climate change-specific factors may influence FDI into these sectors.

Comparing data on RE investment is complicated by the lack of available public information and differing measurement methodologies. One of the most reputable sources for information on investment is the *Renewables Global Status Report* (GSR), published since 2005. The 2018 edition reports on investment in RE through a wide set of financing vehicles (for example, asset finance, venture capital, and capital markets), in both domestic and foreign markets. The most recent GSR reported that domestic and foreign investment in “renewable power and fuels”<sup>16</sup> totaled US\$279.8 billion in 2017 (REN21 2018). BloombergNEF, found that global “clean energy”<sup>17</sup> investment—covering a broader number of industries and products—totaled US\$332.1 billion in 2018, the fifth year in a row in which investment exceeded US\$300 billion (BloombergNEF 2019). RE is now the third-largest sector in the world for

greenfield investment, although it still trails investment in the coal, oil, and gas sectors (Shehadi 2019).

Cementing its leadership in the green economy, China set a new record for its RE investment, providing 45 percent of total global investment in RE—counting its domestic expenditure and FDI—in 2017 (REN21 2018). India was credited for 4 percent and Brazil for 2 percent of global RE investment. Investment into developing countries accounted for a record 63 percent of global investment in RE in 2017 (US\$177 billion).

Asset-seeking investment is the most intuitive type of investment related to technology transfer, headlined by mergers and acquisitions. Rarely does a firm from a developing country acquire a business (and its technology) from a developed country. On average, more than 90 percent of mergers and acquisitions are executed by firms headquartered in the European Union and the United States. China, and to an even lesser extent Brazil and India, has occasionally sought to purchase technology outright through this type of asset-seeking investment, but this has been less frequent and on a much smaller scale.

Efficiency-seeking and market-seeking FDI can lead to technology transfer within domestic manufacturing sectors. In general, when a firm is considering investing in a developing country, its executives are most concerned with political stability and a business-friendly regulatory environment (Kusek and Silva 2018). Investment determinants, however, vary by sector, by motivation, and by firm size. In RE, for instance, an investor may seek a specific natural phenomenon, such as geothermal features or high solar irradiance.

The following section draws on RE FDI data from the *Financial Times' fDi Markets* database, one of the few databases to specifically classify investment into RE sector. This database tracks information<sup>18</sup> on capital investment and direct jobs created associated with global outward FDI, covering the years

2003 to 2018.<sup>19</sup> The *fDi Markets* database is one of the largest on FDI, although coverage of deals in developing countries is believed to be lacking in comparison to information on FDI from and between developed countries. In addition, *fDi Markets* does not differentiate between public, private, and semiprivate investors, meaning that its data also include investment from state-owned enterprises. One should also take into account that these investments may have a lag in delivery and development, and some deals may never come to fruition. The database defines the RE sector as encompassing all investment into the following subsectors: (i) biomass power, (ii) geothermal electric power, (iii) hydroelectric power, (iv) marine electric power, (v) other electric power generation (alternative/renewable energy), (vi) solar electric power, and (vii) wind electric power.

In 2018, foreign investors put US\$82.5 billion into RE sectors, according to *fDi Markets*, which brings total investment into RE to US\$795.2 billion through 3,790 investment deals from 2003 to 2018 (table 2.12). FDI grew quite steadily until the 2008–09 financial crisis but has been volatile since.

In 2018, one-third of investment into RE came from the South. This ratio has grown steadily, in large part because of China, which accounted for 29.1 percent of all outward FDI into RE in 2018. From 2003 to 2018, countries from the global South were responsible for 16.7 percent of outward FDI investment into RE by value, and 12.2 percent of the number of investments.<sup>20</sup>

Roughly half of all FDI into RE recorded by *fDi Markets* has been invested into the global South. Investment into the South dipped following the 2008–09 financial crisis, but it has since recovered and has remained fairly stable at just above 50 percent of all FDI recorded. Electricity production was the primary purpose for roughly 85 percent of total RE investment. About half of this

investment went into developing countries, emphasizing the significant role FDI plays as a source of financing for RE deployment in these countries.

FDI into RE manufacturing is much less common. Since 2003, it has accounted for just 10.7 percent of total recorded RE FDI flows. Roughly 85 percent of that total came from high-income countries, with two-thirds flowing into developing countries—suggesting efficiency-seeking motives. Almost all of that went into greenfield investment. Most projects went into countries that were lower-middle income or have since graduated to upper-middle income. The poorest countries have attracted almost no investment, especially from their fellow neighbors in the South.

China overtook Germany to become the top investor in RE in 2018. Sinohydro, a subsidiary of the wholly state-owned Power Construction Corporation of China (PowerChina), accounted for nearly three-quarters of the 2018 sum—with a single investment into hydroelectric power in Indonesia totaling US\$17.8 billion dollars.<sup>21</sup> This single investment was enough to vault PowerChina into the top-five investing firms since 2003.

The top sources of outward investment have been mostly advanced economies (table 2.13) and China. Among developing countries, the second-largest total sum of investment came from India, which ranked 17th, followed by Malaysia (18th) and Thailand (20th).

FDI from developing countries tends to reflect their comparative advantages in certain technologies. For example, China invests more than one-third of its total FDI in hydroelectric power and an almost equal amount into solar electric power. Also well-known for hydro, Brazil has put more than one-third of its outward FDI into hydroelectric power since 2003, followed by investment in biomass power generation. Almost half of reported outward FDI from India is going into wind power and only 24.6 into solar, despite the country's well-known expertise in solar systems.

### South–South investment flows

South–South investment flows totaled US\$99.9 billion between 2003 and 2018,<sup>22</sup> accounting for 14.1 percent of the total sum of investment. Most South–South

investments into RE have gone into large hydropower projects (table 2.14) because many developing countries—including most notably China—have expertise in these technologies.

China is the largest source country for FDI into RE in lower-middle-income countries and the second-largest source of FDI into RE in low-income countries, after the United States.

During 2003–18, Indonesia received more than one-fourth of all South–South FDI. Of that, three-fourths went into hydroelectric power—all of which came from China. The remainder consisted mostly of investment into biomass power and geothermal electric power.

According to *fDi Markets*, India received the largest amount of FDI (table 2.15). Brazil and Mexico were the second- and third-leading destinations. Only 13.2 percent of the total investment across these three countries went into manufacturing, most of it going into electricity production. These three countries are not strong exporters of LCT, suggesting that the investment they have received has not led to transformative technology transfer. Interestingly, China does not appear to have been an attractive market for FDI into RE sectors over this time period.

### Role of multinational firms in FDI

A single multinational firm can often have an outsized impact on investment trends, evidenced by the fact that the top-five investing firms account for 12.8 percent of total FDI (table 2.16). These firms also account for a large share

of total investment from their country. Iberdrola, the world's top investor in RE, accounts for 27.0 percent of all RE investment that has come out of Spain since 2003. Enel accounts for 59.5 percent of all outward RE FDI from Italy, and Energias de Portugal accounts for 78.3 percent of outward RE FDI from Portugal.

The degree to which these top firms invest in the global South varies, but investment into low-income countries is very low. After ChinaPower, Enel has invested the most money into the South, more than 50 percent of its total recorded FDI, whereas Électricité de France and Energias de Portugal have invested more heavily in the North. These firms' FDI into RE in low-income countries has been minimal. Électricité de France has invested US\$619 million into low-income countries to lead the group, followed by Energias de Portugal.

## MOVEMENT OF PEOPLE AS A CHANNEL OF LCT TRANSFER

Although this chapter has focused on trade and FDI, intranational and international movement of people is critical for knowledge and technology transfer. The former cannot happen without the latter—trade and investment are conducted by businesspeople moving around the world seeking opportunity. Noting that technology is best explained and demonstrated in person, Hovhannisyan and Keller (2015) show that a 10 percent increase in short-term, cross-border labor movement (that is, business travel) leads to a modest but significant 0.2 percent increase in patenting in the destination country.

Beyond business travel, movement of people can transfer knowledge and skills in multiple ways including, among others, nationals studying or working abroad and later applying new knowledge gained after returning to their home country, temporary relocation and even emigration of foreign professionals into a country, labor turnover of highly skilled workers from multinational firms to domestic firms (Golub, Kaufmann, and Yeres 2011; Hoekman, Maskus, and Saggi 2004). Assessing the literature on emigration, recent World Bank (2018) analysis finds that a large part of what makes high-skilled workers more productive is the work environment in the destination country: if they had not left their home countries, these workers may never have been so productive or developed higher skills.

Freedom to travel between countries is primarily determined by one's passport and the various visa processes and policies, including restrictions, of destination countries. The Henley Passport Index, based in part on International Air



Transport Association data, provides a rigorous measure of travel freedom spanning the past 14 years. When looking at the selected countries of focus in this chapter, China and Korea both show marked improvement in the ease of travel since 2006, whereas traveling as a national from India, Mexico, and South Africa has become more difficult (table 2.17). The more restricted it is for someone to travel, the higher the transaction costs for studying and working abroad, and the more difficult it is to enter a country, the less likely it is that a country will attract global talent.

### International education mobility

The number of individuals studying abroad continues to soar, having risen from 2.1 million students in 2001 to more than 5 million in 2018.<sup>23</sup> Students coming from East Asia and the Pacific region have been a major driving force, but the Institute for International Education, in partnership with the OECD and the United Nations Educational, Scientific, and Cultural Organization, has found outward mobility of students increasing across all regions (figure 2.14). Long the

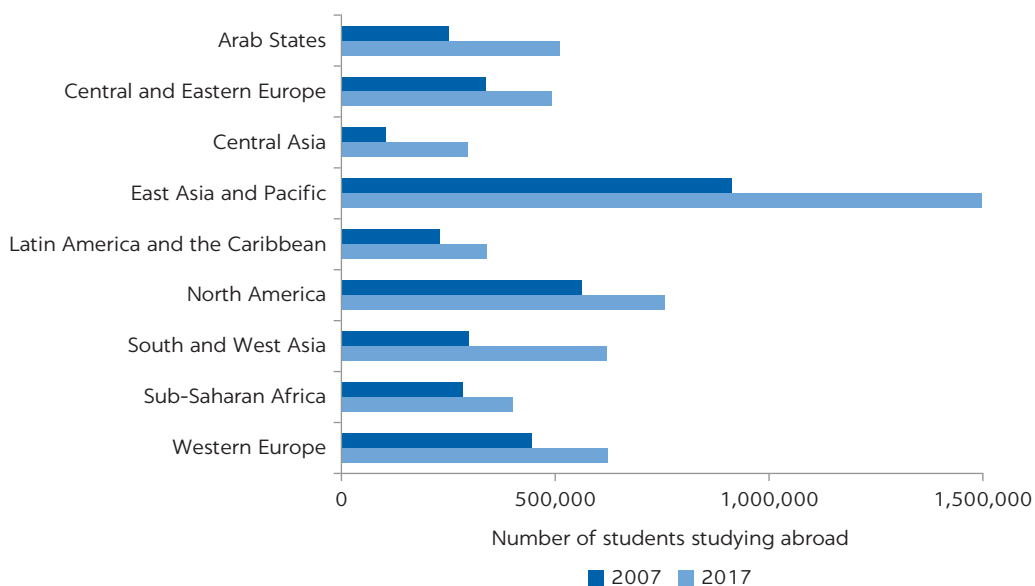

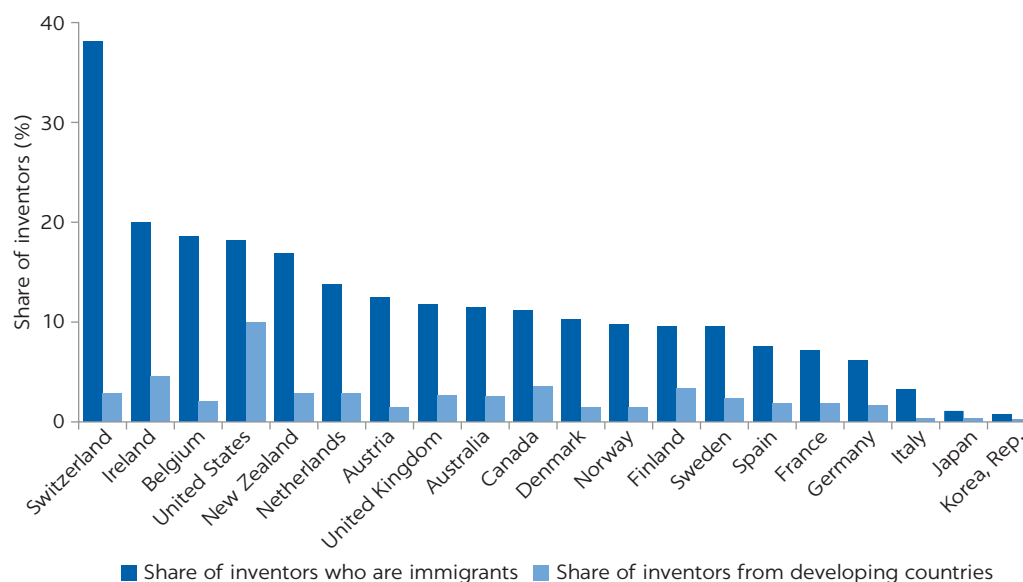


primary destination for international students, the United States now accounts for slightly less than a quarter of the world's international students. The U.S. share has been declining as other countries have instituted policies to attract foreign students and to retain them in their local labor force once they have completed their studies (Institute of International Education 2018). China, the most successful developing country to have instituted such policies, attracted 10 percent of all inbound international students in 2018, up from less than 2 percent in 2001, tying it with the United Kingdom as the second-most popular destination for international students. In an effort to retain some of these students, the Chinese government has put in place policies to ease the process of attaining residency after studying for foreigners choosing to work in strategic sectors, including engineering research centers, high-tech companies, and foreign-funded R&D centers (in June 2016).

Making it easier for students and professionals to visit and relocate to a country can provide a significant boost to knowledge, technology transfer, and innovation. Available evidence shows immigrants play an outsized role in inventing (figure 2.15) and are disproportionately employed in science, technology, engineering, and mathematics (STEM) fields, often as inventors and innovators (World Bank 2018).

The primary challenge for developing countries is to facilitate temporary movement abroad and to encourage those who leave to return and apply their knowledge in the local economy (Hoekman, Maskus, and Saggi 2004). Failing to attract nationals to return can result in brain drain. Emigration of high-skilled workers, in particular, can reduce income levels by 6 percent in origin countries with per capita income levels below US\$3,000 (World Bank 2018). Remittances sent back home help to defray the cost, but they do not fully compensate for the loss.

Developing country governments can help to foster knowledge and technology transfer by implementing policies and incentives that effectively facilitate the free movement of students and labor. Diaspora engagement programs, for example, can help to connect diaspora investors and entrepreneurs with investment opportunities in their home countries. Incentive policies to encourage the return of a country's high-skilled diaspora have demonstrated return on investment (World Bank 2018). The Malaysian Returning Expert Program, which provides tax breaks to successful emigrants who return to Malaysia, is a notable example. Return migration has increased, and the program has roughly paid for itself as the return migrants pay taxes—even at lower rates.

## **ABSORPTIVE CAPACITY AS A DETERMINANT OF LCT TRANSFER**

The degree to which workers, local firms, and domestic industries benefit from LCT knowledge spillovers and technology transfers through trade and FDI ultimately depends on the absorptive capacity of domestic actors. Absorptive capacity refers to the “ability to identify, assimilate, and exploit knowledge” (Cohen and Levinthal 1990). Developing absorptive capacity in LCT sectors is not unlike doing so in other high-technology sectors. Countries with established manufacturing industries in sectors such as aircraft, steel, and glass have been shown to have a competitive advantage in developing solar and wind manufacturing (Huberty and Zachmann 2011; Jha 2017). At the firm level, absorptive capacity is often associated with the number of workers with tertiary education, managerial skills and management systems, use of modern technologies, firm size, proximity to other firms in the same sector, and whether or not the firm exports—to name but a few factors. When a firm has absorptive capacity, it can then strengthen and develop technical capabilities, which, in turn, can support indigenous technology development and innovation.

Much of the recent literature on absorptive capacity has focused on spillovers from FDI and participation in GVCs. A large study of over 25,000 firms in 78 different low- to middle-income countries found that, for low-productivity firms, national policies to support education, trade openness, and openness in financial markets were significant mediating factors of FDI spillovers, with the importance of these conditions diminishing as firms became more productive (Farole and Winkler 2012).

FDI spillovers tend to depend on the degree of interaction between buyers and suppliers (for example, the share of outputs going to a single buyer) and the length of the trading relationship (Winkler 2013). A study on how China has built technological capabilities in LCT sectors finds that advances in capabilities were more often achieved via bottom-up market relationships between Chinese and foreign firms, facilitating knowledge flows and learning, rather than top-down efforts to foster indigenous R&D (Watson et al. 2015). Studies on market-seeking FDI—measured by the share of a foreign firm's output sold domestically—demonstrate that, when foreign firms source more intermediate inputs from local suppliers, especially from low- and medium-productivity firms, spillovers tend to be higher (Farole and Winkler 2012). Although interesting, these ex post assessments leave much to be desired in identifying policies and strategic pathways for developing absorptive capacities in specific infant industries, such as LCT.

Advances in data collection have allowed for deeper exploration of the determinants of absorptive capacity, capabilities, and their role in the economic geography of innovation—allowing for more predictive analysis. This emerging field assumes that innovation and diversification occur as part of a cumulative process of building capabilities and are therefore path dependent. It follows that innovation and diversification are more likely to occur in regions, and sectors within those regions, that demonstrate existing capabilities in related technologies (Boschma and Frenken 2011; Hidalgo et al. 2007). One recent study on “eco-technologies” in the European Union finds this hypothesis to hold, with regions with an existing knowledge base in related technologies being more likely to enter into and more likely to develop patents in LCT (van den Berge and Weterings 2018). The empirical findings of this branch of study are improving with better-quality data, offering important insights into the relatedness of products and the likelihood of developing industries in specific regions. These initial studies confirm that one-size-fits-all policies are unlikely to be effective in fostering the development of new green sectors. Chapter 5 further explores these issues.

## CONCLUSIONS

This chapter has described some of the shifts in the landscape of international LCT trade and investment, highlighting their importance as channels of LCT transfer and know-how. Given data limitations, the analysis of these flows suggests that the traditional North–South technology transfer paradigm is still predominant but that South–South and South–North technology transfers are becoming increasingly relevant within LCT sectors. This shift has been driven by China’s rapid development of capabilities in LCT sectors and a small cohort of emerging economies that have leveraged factor endowments, existing capabilities, and links to global trade hubs to carve out global market share and become attractive investment destinations.

In order to make more informed, evidence-based decisions, policy makers will need better and more data, and data analysis, to deepen their understanding of LCT products, value chains, and investment flows. Updated and improved multiregional input-output tables could help to deliver more accurate insight into the multiple components involved in LCT manufacturing. These tables could also help countries to find consensus on products that could be included in bilateral or multilateral preferential trade agreements. Policy makers also need to understand how much investment is being channeled to meet low-carbon commitments. Improved data collection and classification of investment into environmentally friendly activities and industries would be beneficial.

Many of the policies or reforms needed to promote LCT transfer through trade and investment are the same as those necessary for all products and sectors: stable macroeconomic conditions, access to finance, a good investment climate, preferential market access, connectivity, and so on. For a start, policy coherence—clear climate commitments and actions to demonstrate follow-through on those commitments—can signal to the private sector that the government is serious about low-carbon development and thus help to attract investment. Depending on a country’s fiscal and institutional capacity, such actions could include sector-specific support policies to boost productivity and competitiveness in green industries, and technical regulations on

products that can be imported and sold in the domestic market. The feasibility of implementing such policies and the likelihood of effectiveness will depend on the country context. A more complete discussion of policies can be found in chapter 5.

The following multilateral, bilateral, and regional initiatives and policies can provide further impetus for LCT trade and investment.

**Multilateral cooperation for trade liberalization.** Governments that support climate action need to push for progress at reducing tariff and nontariff barriers to trade in LCTs at the multilateral level. None of the WTO agreements requires signatories to take specific actions to prevent negative environmental externalities or requires them to put in place environmental protection measures. This must change. At the very least, the Environmental Goods Agreement (EGA) negotiations should be revived. Since July 2014, 46 WTO members have been negotiating the EGA as a means to remove barriers to trade in goods that have positive environmental or climate change impacts.<sup>24</sup> Because the EGA is a plurilateral trade agreement, all WTO members would enjoy most-favored-nation tariff rates for environmental goods once it is ratified. EGA negotiations were suspended in December 2016 when the parties failed to reach a consensus on outstanding issues after China submitted a new list of products at a late stage in the process (European Parliament 2019). The EGA faces a number of negotiation challenges. First, the current version of the EGA covers only tariffs for certain environmental goods, and nontariff barriers and trade in services are excluded. Second, the parties have not yet agreed upon a common list of the goods covered. Third, the parties have not agreed on the extent of the tariff reductions, and a few countries have raised concerns about the potential elimination of tariffs on certain sensitive goods. Extensive negotiations will be necessary to resolve these issues.

Meanwhile, unilateral tariff reductions could offer an immediate dollar-value incentive to increase trade. Econometric assessments suggest that, if tariffs on LCT were liberalized, the largest increases in imports of LCT would be for lower-income countries (de Melo and Solleder 2018). But governments from these countries have been reluctant to further liberalize, expressing concern over trade balances and the detrimental impact on domestic firms. Multiple studies have shown, however, that these countries would benefit from large increases in welfare gains—such as access to lower-cost, clean energy—which would also disproportionately benefit low-income households. Other sticking points also need to be addressed multilaterally, including how best to apply the WTO Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) in a way that removes impediments to technology transfer and actually encourages and incentivizes transfer of LCTs to developing countries. A balance will need to be struck on these issues, across parties, with mechanisms to address distributional impacts.

**Services market liberalization.** Much of this chapter focused on trade in goods, but many of these goods were destined for use in services sectors. More can be done at the multilateral level to clarify existing WTO commitments and bilateral level to develop new commitments and guidelines on energy markets and services. Many countries are just now putting in place legal frameworks for third-party access to energy facilities, permit and licensing policies for captive RE systems, competition safeguards, and regulatory transparency. Although many of these issues focus on the domestic market, recent trends toward privatization and energy market liberalization, in light of the need to rapidly transition

away from fossil fuels, have created new opportunities for fundamentally different approaches to energy systems and regulation.

**Regional integration and bilateral trade agreements with stronger environmental provisions.** Trade liberalization and environmental protection can be mutually supportive. As the number and regulatory coverage of preferential trade agreements has soared over the past three decades, so too has the number of environmental provisions contained in these agreements (Monteiro and Trachman, forthcoming). Agreements negotiated between developed countries, and between developed and developing countries, tend to include the highest number of such provisions. Committing to a clear path of sequenced reforms to support environmental objectives can boost economic and welfare gains. Analysis of the impact of environmental provisions has shown that their inclusion has been correlated with increased trade flows (Berger et al. 2020). Even in cases where developing countries sign agreements with more developed partners, the former's exporters have been shown to benefit from the inclusion of environmental provisions (Berger et al. 2018). These agreements have also helped to drive bilateral and multilateral cooperation on issues such as private product standards and environmental subsidies.

## NOTES

Licensing contracts vary according to the form and size of the payment for which the licensee is responsible (fixed fees versus royalties), the degree of exclusivity (single licensee versus patent pools), and the division of rents across the parties involved (Gallini and Wright 1990). In principle, evidence related to licensing and observational data on royalty fees would be the most robust metric indicating that technology transfer has occurred; however, product-specific data on licensing fees are very limited or not publicly available. Nevertheless, as Dussaux, Dechezleprêtre, and Glachant (2018) point out, the omission of licensing data from empirical analyses of technology transfer is not necessarily a major issue, because in recent years licensing fees represent a very small portion of global gross domestic product.

In many cases, technology transfer is difficult to quantify; it occurs less explicitly and more implicitly through indirect knowledge spillovers, such as those generated through reverse engineering or the circulation of skilled labor. All factors vary by industry.

The list of 54 environmental goods established by the Asia-Pacific Economic Cooperation (APEC) forum is arguably the most well-known, because it is the only list agreed and acted upon by governments around the world. The last list presented for negotiation of the WTO EGA comprised 411 products at the HS six-digit level (de Melo and Solleder 2018). These 411 products were drawn from nationally constructed lists and other previous iterations produced by the OECD, academia, and other organizations. The OECD defined

a list of 334 Environmentally Preferable Products (EPPs) in the context of the Doha Round of Negotiations, which was then reduced to an EPP-Core list of 107 products (Zugravu-Soilita 2016). The OECD later compiled a new Combined List of Environmental Goods (CLEG), totaling 248 products (Garsous 2019). # 3 Using Patents to Measure the International Transfer of Low-Carbon Technologies and Its Determinants

## INTRODUCTION

As discussed in chapter 1, accelerating the transfer of low-carbon technologies (LCTs) is crucial to limit global warming to 1.5°C above preindustrial levels. This chapter uses data on cross-border patent transfers to examine current trends in the dissemination of LCTs and explores options for accelerating the uptake of these technologies, especially in developing countries.

A patent gives an exclusive right to an inventor to use and sell the invention for a certain number of years. By limiting competition and creating a temporary monopoly rent, patents not only help innovators reap rewards but also provide incentives for others to invest in new innovations. Patents are a common measure of innovation: applying for a patent is a costly process, and inventors do it only for innovations they expect to exploit and benefit from. Not all patents have the same quality, however, which makes cross-country comparisons informative but challenging. Firms that export capital goods and invest in foreign countries use patents to protect their intellectual property (see Dechezleprêtre et al. 2011; Dechezleprêtre, Glachant, and Ménière 2013; de la Tour, Glachant, and Ménière 2011; Eaton and Kortum 1999; Glachant et al. 2013; Maskus 2004). Thus, patents are also a measure of technology transfer because they give the right to commercially exploit the invention in the country where the patent is filed and because patentable technologies must be both novel to the local context and susceptible to industrial application.<sup>1</sup>

Using patent-transfer data from the PATSTAT database maintained by the European Patent Office (EPO),<sup>2</sup> the first part of the chapter describes current trends in LCT innovation and transfer, and discusses the factors that encourage or impede the diffusion of LCTs in developing countries. Unlike the datasets used in previous studies, which focused on renewable energy, low-carbon buildings, and cleaner vehicle technologies, the PATSTAT data cover all types of LCT, including energy-efficient manufacturing technologies, which cannot be measured using current trade data or foreign direct investment (FDI) data.

The second part of the chapter constructs an econometric model using a dataset of 75 countries observed from 2006 to 2015 to measure the impact of

different factors on patent transfers. These factors include local capacity for technological absorption, environmental policies, intellectual property rights (IPR) protections, FDI restrictions, tariffs, nontariff barriers, and market size. The methodology consists in estimating a gravity model of patent transfer with exporter-year fixed effects and country-pair fixed effects. The final section concludes the chapter.

## MEASURING LCT WITH PATENT DATA

Measuring technology transfer with patent data offers critical advantages. Patents contain important contextual information—such as the patent holder’s country of residence, the year the technology was invented, and the countries in which the technology was patented—as well as detailed technical information, which allows the patented technologies to be organized into highly specific categories. Moreover, the EPO’s PATSTAT database is comprehensive, allowing for the identification of patent transfers for any given technology between any pair of countries, whereas the available data on cross-country investment are extremely limited (Dussaux, Dechezleprêtre, and Glachant 2018).

Although analyzing patents offers many important methodological advantages, three caveats should be noted. First, although many transferred technologies are patented (Guellec and van Pottelsberghe de la Potterie 2001), some firms may instead rely on industrial secrecy—as well as other, more complex tools—to shield their intellectual property from imitation. Technologies that are transferred but not protected by a local patent will not appear in the dataset. Some firms may use a combination of industrial secrecy and patents to safeguard proprietary technologies; in these cases, local patents will still indicate that technology transfer is occurring, but they will not fully describe that technology. Second, stronger IPR protections could prompt inventors to switch from secrecy to patent protection, which would result in a larger number of patent transfers without affecting the total amount of technology transferred (Cohen, Nelson, and Walsh 2000). By contrast, Dussaux, Dechezleprêtre, and Glachant (2018) use data on international trade and FDI, which are not subject to the potential substitution between patented and unpatented technologies.<sup>3</sup> Finally, some patents are purely strategic, barring the use of certain technologies by competitors even when those technologies are not used by the firm that holds the patent. The inclusion of strategic patents in the dataset could therefore cause the analysis to overestimate the degree of technology transfer actually occurring. The significant monetary and administrative costs involved in the patent-filing process mitigate this risk, however, and empirical evidence shows that technologies are patented in an average of just two countries each (Dechezleprêtre et al. 2011).<sup>4</sup>

## DATA SOURCES AND ACCOUNTING METHODOLOGY FOR LCT

The EPO created the PATSTAT database in 2006. PATSTAT is organized according to the Cooperative Patent Classification (CPC) scheme, which was jointly developed by the EPO and the U.S. Patent and Trademark Office (USPTO).<sup>5</sup> The CPC includes a specific category of patents defined as “Technologies or applications for mitigation or adaptation against climate change.” These technologies

are identified by CPC codes beginning with Y02. The analysis presented in this chapter focuses on mitigation and excludes adaptation technologies. It covers the seven following LCT fields:

1. **Buildings.** Y02B—“Climate change mitigation technologies related to buildings, e.g. housing, house appliances or related end-user applications.”
2. **Carbon capture and storage (CCS).** Y02C—“Capture, storage, sequestration or disposal of greenhouse gases.”
3. **Information and communication.** Y02D—“Climate change mitigation technologies in information and communication technologies, i.e. information and communication technologies aiming at the reduction of their own energy use.”
4. **Energy.** Y02E—“Reduction of greenhouse gas emissions related to energy generation, transmission or distribution.”
5. **Manufacturing.** Y02P—“Climate change mitigation technologies in the production or processing of goods.”
6. **Transportation.** Y02T—“Climate change mitigation technologies related to transportation.”
7. **Wastewater treatment and management.** Y02W—“Climate change mitigation technologies related to wastewater treatment or waste management.”

The dataset covers over 800,000 patents filed between 1990 and 2015<sup>6</sup> under the seven LCT fields listed above. The largest number of patented technologies is in the energy, manufacturing, and transportation sectors, which is consistent with the weight of those sectors in total greenhouse gas (GHG) emissions. CCS, a recent and more limited field, accounts for the fewest patented technologies. About one-fourth of all patented LCTs are defined as “high-value technologies,” which have been patented in at least two patent offices. The ratio of high-value technologies to total technologies is broadly consistent across fields (table 3.1).

When a new technology is patented, the patent holder has one year in which to file patent applications in foreign countries. This period is known as the priority year, because the current patent holder can claim priority over other applicants. Patents on the same technology filed in multiple countries form a

patent family, but each patent family has only one priority patent. Restricting the analysis to priority patents helps ensure that each technology is counted only once. When a technology originally patented in country A is subsequently patented in country B, this is regarded as a technology transfer from country A to country B. Country A is defined as the inventor country and country B as the recipient country. Several studies in the literature use this approach (Dechezleprêtre et al. 2011; Dechezleprêtre, Glachant, and Ménière 2013; de la Tour, Glachant, and Ménière 2011; Eaton and Kortum 1996, 1999; Glachant et al. 2013; Maskus 2004).

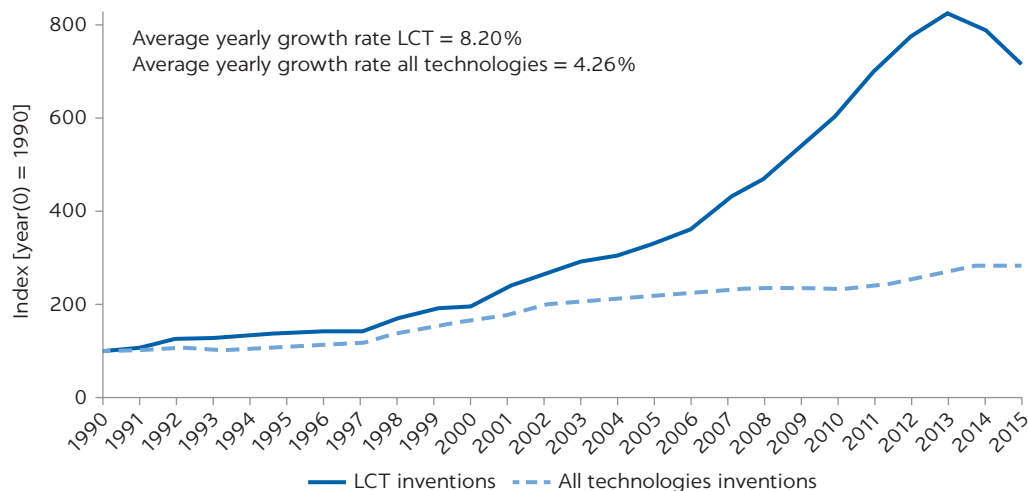
Differences in the requirements for filing a patent across countries create heterogeneity in patent quality. The analysis in this chapter mitigates qualitative differences by focusing on high-value technologies (see table 3.1),<sup>7</sup>—that is, patents filed in at least two countries tend to have greater economic value than do patents filed in a single country (Guellec and van Pottelsberghe de la Potterie 2001; Harhoff, Scherer, and Vopel 2003).

Although all other emerging economies are represented in PATSTAT, India is not included. To date, the Indian patent office has declined to make its data available publicly and free of charge. Consequently, PATSTAT includes Indian patents that have been transferred to other countries, but not foreign patents that have been transferred to India. To prevent this disparity from distorting the analysis, India is explicitly excluded from the dataset for this report.<sup>8</sup>

## THE TRANSFER OF LCTs

Between 1990 and 2015, the annual growth rate of LCTs averaged about 8 percent per year, roughly double the growth rate for all technologies, but it fell significantly between 2012 and 2015 (figure 3.1). This slowdown has been documented by other studies (for example, Dechezleprêtre 2017) and is not a

measurement error. Two factors drove the decline in the LCT growth rate observed between 2012 and 2015. First, innovation in LCT is influenced by the price of crude oil, which plunged during the period, making renewable energy less competitive against fossil fuels and weakening fuel-efficiency incentives. Second, public investment in renewable energy research and development peaked in 2009 and declined thereafter.<sup>9</sup> The global financial crisis put government budgets under pressure, shifting public funds away from research and development (R&D) toward recovery packages.

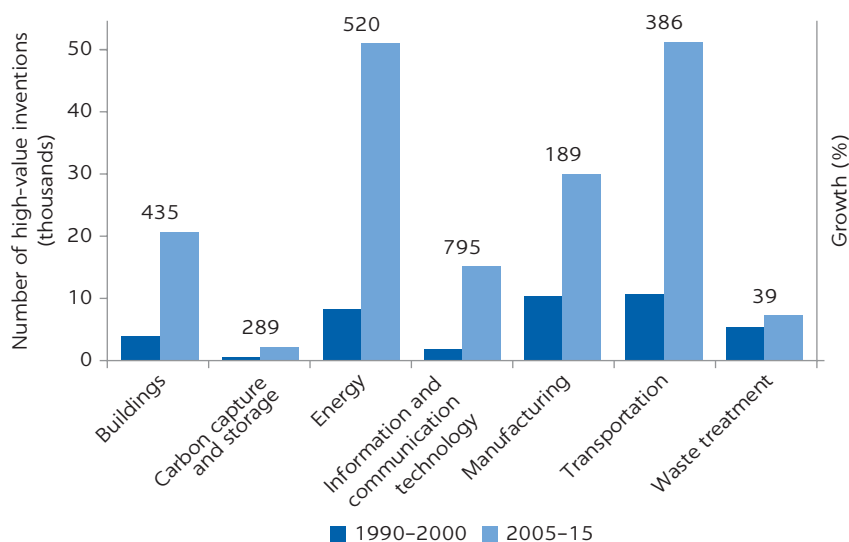
Between 1990–2000 and 2005–15, the total number of LCT innovations increased by 316 percent. Although the number of innovations increased across all LCT fields, some fields grew more quickly than others (figure 3.2). LCT innovations in information and communication technology (ICT) grew most rapidly, whereas LCT innovations in water management increased by only 39 percent. The energy, transportation, and manufacturing sectors accounted for the largest share of LCT innovations over the period.

LCT innovations are concentrated in high-income economies. Just five economies accounted for 73 percent of all LCTs invented between 2010 and 2015 (figure 3.3). Japan produced the largest share, followed by the United States, Germany, the Republic of Korea, and China. This order remains broadly similar across technological fields. France was one of the top-five innovators in transportation and CCS technologies, and Taiwan, China, was in the top five for ICT.

High-income countries produced at least 80 percent of LCT innovations in all technological fields. Lower-middle-income and low-income countries produced almost no LCT innovations during the period (figure 3.4).<sup>10</sup> This imbalance highlights the urgent need to accelerate international LCT transfer to lower-income countries.

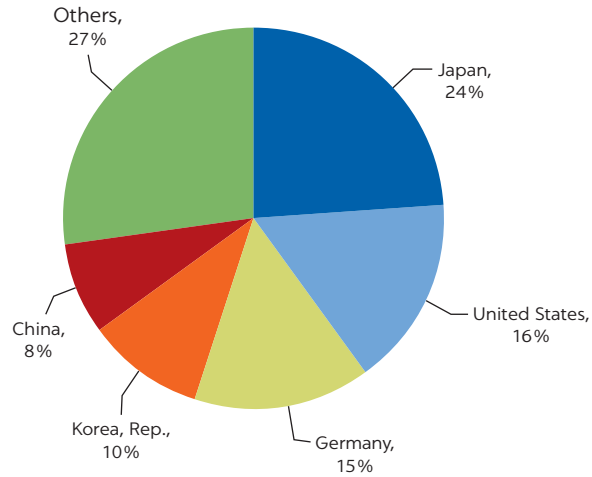
China is a global leader in LCT innovation. Between 2010 and 2015, China produced 8 percent of the world's LCT innovations, far more than any other developing country (table 3.2). China produced more than 15 times as many

Growth of LCTs, by field, 1990–2000 and 2005–15



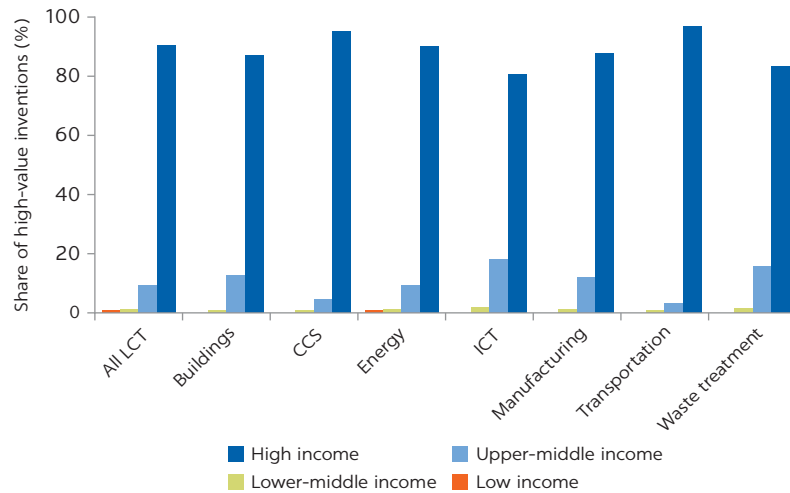

LCT innovations as the Russian Federation (0.5 percent), more than 25 times as many as Brazil (0.3 percent), and 77 times as many as Mexico (0.1 percent). Importantly, China’s contribution to global LCT innovation significantly exceeds its economic size. The ratio between China’s share of patented innovations and its share in global gross domestic product (GDP) is about 70:100. By contrast, Russia’s ratio is about 20:100, Brazil’s is about 9:100, and Mexico’s is less than 6:100. Together, Brazil, China, Russia, and South Africa contribute about 10 percent to global LCT innovation, but South Africa is not among the top-10 climate change mitigation innovators in the developing world.

Despite its leadership in LCT innovation, according to Medvedev (2019), China submits only a small percentage of its LCTs to overseas patenting offices. Moreover, the citation rate for China’s renewable energy technologies patents is

very low when compared to patents received by firms from Germany, Japan, and the United States.<sup>11</sup> Low patent quality may indicate that firms attempt to use patents to create barriers to entry for competitors, blocking freedom. Medvedev (2019) also report that both foreign and local firms in China complain about IPR breaches, the difficulty of enforcing claims, and gaps in regulations.

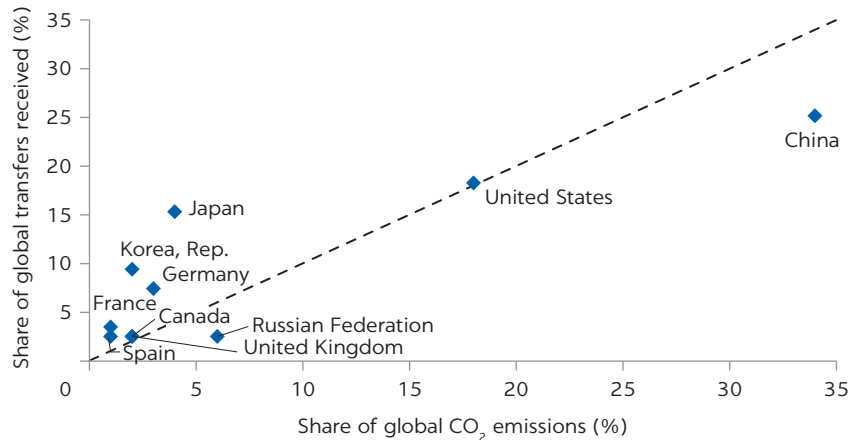
### LCT transfer to developing countries

The transfer of LCT to developing countries is crucial for two reasons. First, acquiring any new technology, LCT included, tends to have highly positive implications for productivity growth and the achievement of development objectives. For example, renewable energy technologies can play a critical role in the electrification of remote areas. Second, LCT transfer can decrease the cost of decarbonization in developing countries, which are currently projected to produce the bulk of carbon emissions over the next several decades (EIA 2016).

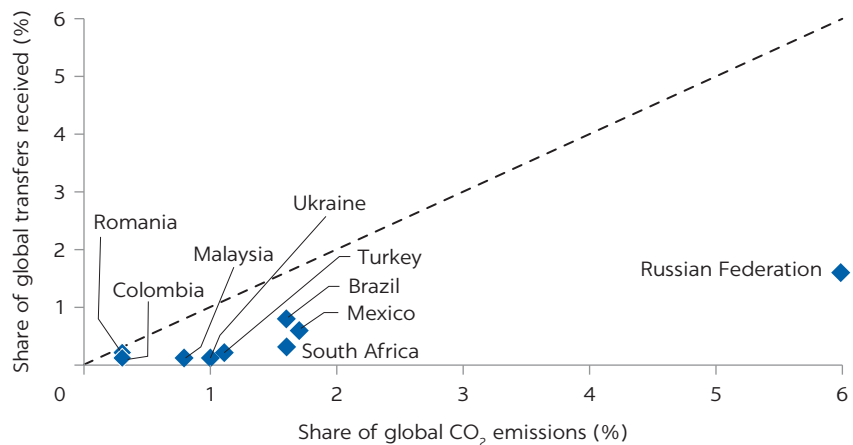
The PATSTAT data show negligible levels of LCT transfer to low-income countries. Between 2010 and 2015 roughly 71 percent of all patent transfers occurred between high-income countries, 23 percent were transfers from high-income to middle-income countries, and 4 percent were transfers from middle-income to high-income countries. Transfers between middle-income countries accounted for just 1 percent of the total, and almost no patents were transferred to or from low-income countries. Developing countries' share in LCT patent transfers has increased over time, however: previously—between 1990 and 1995—a full 91 percent of LCT patent transfers occurred between high-income countries.

The shares of LCT patents received by Germany, Japan, and Korea significantly exceed their shares of global carbon emissions, whereas those received by China and Russia are lower than their contributions to global carbon emissions (figure 3.5 and table C.1 in appendix C). The United States accounts for 18 percent of global carbon emissions and receives 18 percent of LCT patents. By contrast, China and Russia account for 36 and 6 percent of global carbon emissions, respectively, whereas they receive just 25.4 and 1.6 percent, respectively, of global LCT patents transfers.<sup>12</sup> Given China's enormous carbon output, accelerating LCT transfer to China will be vital to meet global climate targets.<sup>13</sup>

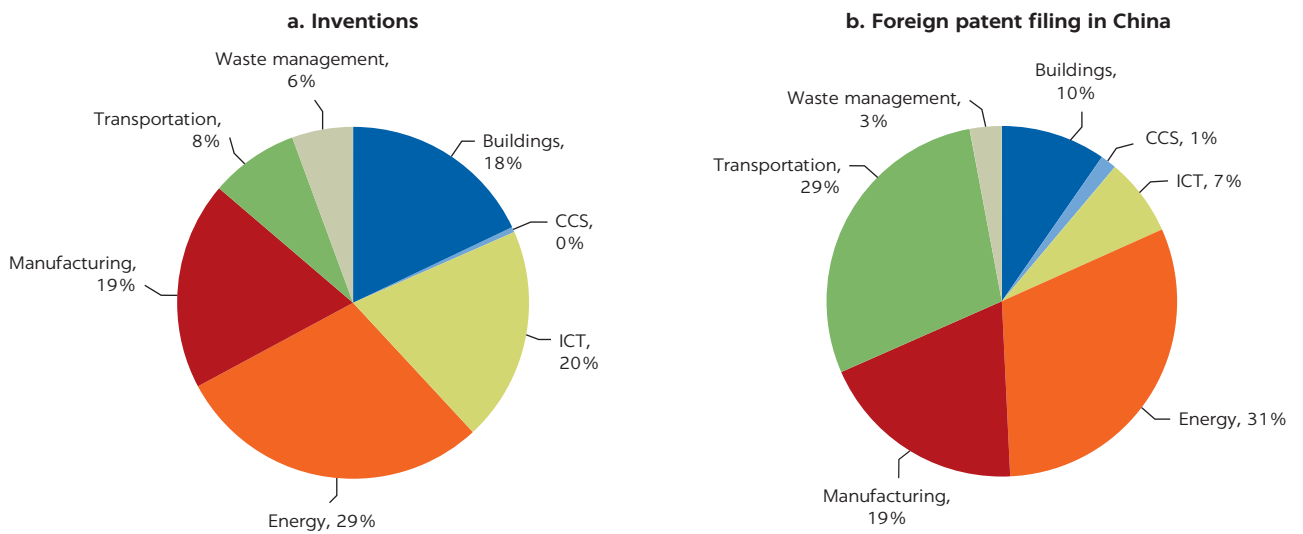
Other countries in the sample—Brazil, Malaysia, Mexico, South Africa, Turkey, and Ukraine—receive a lower share of LCT patent transfers relative to their significantly larger share of global carbon emissions. These countries should be considered priorities for accelerating LCT transfer (figure 3.6). By contrast, Colombia and Romania produce a share of carbon emissions that only modestly exceeds their share of LCT patent transfers.

**The roles of China and Russia in LCT transfer**

China and Russia specialize in different types of LCTs. Chinese LCT inventions focus on the energy sector (29 percent), ICT (20 percent), manufacturing

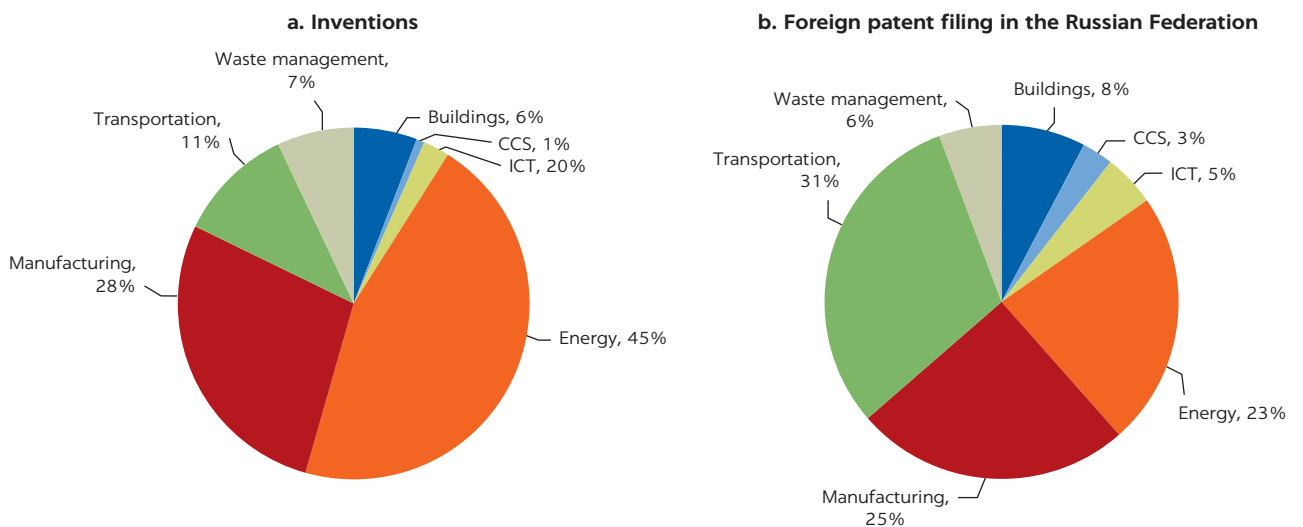
(19 percent), and buildings (18 percent) (figure 3.7a). Meanwhile, most foreign LCT patents registered in China focus on the energy sector (31 percent), transportation (29 percent), and manufacturing (19 percent) (figure 3.7b). Russia's LCT inventions are heavily concentrated in the energy and manufacturing sectors. Almost half of Russia's LCT innovations have applications in the energy sector, and over one-quarter have applications in the manufacturing sector (figure 3.8a). By contrast, the distribution of foreign LCT patent is more balanced (figure 3.8b). Like China, Russia receives a much larger share of LCT patents for transportation (31 percent) than it produces locally (11 percent).

Between 2010 and 2015, 93 percent of outbound Chinese LCT patent transfers were to high-income economies. Major recipients of Chinese LCT patents included the United States (31 percent), Japan (11 percent), and Korea (9 percent). Among developing countries, the only significant recipients of Chinese LCT patents were Russia (2 percent), South Africa (1.1 percent), and Brazil (1 percent) (figure C.1 in appendix C).

High-income economies also accounted for most of Russia's outbound LCT patents, with the largest share going to the United States (18 percent). China received the second-largest share of Russian LCT patents (16 percent), followed by Ukraine (3 percent), Brazil (1.7 percent), and South Africa (0.8 percent), which pushed the total share of developing countries to 23 percent of Russia's total outbound LCT patents. Like China, Russia files about 10 percent of its LCT patents in Japan and Korea (figure C.2 in appendix C).

High-income economies account for the vast majority of inbound LCT patents filed in both China and Russia. Between 2010 and 2015, firms from high-income economies filed more than 94 percent of inbound LCT patents in China and Russia (see figures C.3 and C.4 in appendix C). The United States alone accounted for 24 percent of the foreign LCT patents filed in both countries; however, the distribution of inbound LCT patents from other economies varied substantially. For example, Japan represented 31 percent of LCT patents filed in China but just 11 percent of those filed in Russia, whereas Germany accounted for 11 percent of LCT patents filed in China but 18 percent of those filed in Russia. Distance is a major determinant of international trade and FDI, the two main channels of international technology transfer, and the heterogeneity in inbound patents is consistent with the geographical distance separating the different countries, as well as their relative size.

### The role of India in LCT transfer

As discussed earlier, India has been excluded from our analysis because of its absence from the PATSTAT database. Despite that absence, India's contribution to LCT transfer, and global carbon emissions, is too important to ignore. This section uses data from the WIPO's Patentscope dataset, which includes

India. To identify LCTs in Patentscope, the analysis uses IPC codes selected by Dechezleprêtre, Glachant, and Ménière (2013) covering four technological fields: transportation, energy production, energy use, and methane capture. The number of patent families is used to proxy the number of LCT innovations, and an indicator of high-value innovations is used to account for differences in patent quality.<sup>14</sup>

The Patentscope data indicate that India accounts for 0.52 percent of total LCT innovations, making it the developing world's second-largest LCT innovator after China. India's share of global LCT patents is much smaller than that of China (1.51 percent), but significantly larger than those of South Africa (0.22 percent), Turkey (0.13 percent), and Russia (0.11 percent) (table 3.3). Importantly, the Patentscope data produce a ranking of LCT innovators in the developing world that is very similar to the ranking produced by the PATSTAT data (refer to table 3.2). The shares of the countries differ, however, because PATSTAT encompasses a wider range of LCT fields.

Like PATSTAT, the Patentscope data indicate that the share of carbon emissions among developing countries exceeds their share of patent transfers. This disparity is especially wide in India and Russia, which contribute 6 percent and 5.3 percent to global carbon emissions, respectively, but which receive just 1 percent and 0.2 percent of all LCT patent transfers. These findings indicate considerable scope to accelerate LCT transfer to India and Russia.

## DRIVERS OF LCT INNOVATION AND TRANSFER

### Drivers of innovation in LCTs

Changes in relative prices greatly influence LCT innovation.<sup>15</sup> High fossil fuel prices tend to increase demand for LCT substitutes, and this dynamic prevails whether the increase in fossil fuel prices is caused by policy decisions (for example, carbon taxes) or market conditions. Some firms that rely on fossil fuel-based technologies will switch to LCT alternatives, whereas others will invest in new LCT innovations. Because these decisions involve long-term changes in the structure of production, the anticipated trajectory of relative prices plays a critical role in determining their impact on LCT innovation and uptake (see Newell, Jaffe, and Stavins 1999 and Popp 2002 for empirical evidence).

Long-term trends in relative prices have especially important implications for innovation. Like other technologies, R&D in LCT often entails lengthy lead times, high levels of risk, and large sunk costs (Scherer, Harhoff, and Kukies 2000). In addition to a favorable projection of the future financial viability of LCT innovations, the availability of financing can have a major impact on R&D, especially among small and credit-constrained firms (Jaffe, Newell, and Stavins 2003). Governments often help this process by introducing incentives such as R&D tax credits and subsidies to encourage innovation.

IPR protections affect both innovation and technology transfer. Without sufficient protection, a firm's innovations can be appropriated by competitors, allowing them to reap the benefits of the innovation without incurring the R&D costs necessary to create it. IPR protections can internalize the benefits of R&D investment by granting a patent holder exclusive rights to commercialize an innovation for a defined period, usually 20 years. While encouraging investment in R&D, however, patents also give market power to the patent holder, which, in turn, can limit the diffusion of new technologies and slow international technology transfer.

The intensity of product market competition also influences innovation. Theoretical analysis (for example, Aghion et al. 2005) has shown that the relation between product market competition and innovation is not linear. At low levels of competition, an increase in intensity can induce firms to innovate in order to pull away from their close competitors. At high levels of competition, an increase in intensity can reduce innovation by weakening incentives for lagging firms to catch up to technological leaders. The latter effect is also more likely to prevail in "unleveled" industries, where few firms are in close competition with one another.

Innovation in LCT is inhibited both by the presence of positive externalities on the supply side and by negative externalities on the demand side. The challenge of internalizing the benefits of new technology is not unique to LCT;

however, LCT innovations must also compete with technologies that generate negative externalities. For example, a coal-fired power plant may give rise to serious environmental costs that are not reflected in the price of the electricity it generates. Unless these costs can be internalized through regulation, carbon-intensive technologies will enjoy an unfair advantage over LCTs (Jaffe, Newell, and Stavins 2005).

Empirical evidence shows that environmental regulations can induce innovation in LCT (see also Brunel 2019; Johnstone and Labonne 2006; Lanoie et al. 2011). Pollution-abatement expenditures also have been shown to encourage investment in LCT innovation (Brunnermeier and Cohen 2003; Jaffe and Palmer 1997; Lanjouw and Mody 1996). Some studies suggest that, although regulation plays an important role in LCT innovation, it is not the most important driver (Calel and Dechezleprêtre 2016; Popp, Hafner, and Johnstone 2011). Other studies have shown that environmental policies affect the emergence of high-quality LCT innovations only, whereas competition encourages the creation of low-quality LCT innovations (Nesta, Vona, and Nicolli 2014).

### Theoretical drivers of technology transfers

International trade and FDI are the most important channels for technology transfer.<sup>16</sup> Consequently, the factors that affect trade and FDI also affect the transfer of LCT, as measured by cross-border patent filing. The scope and scale of trade and FDI in LCTs reflect the characteristics of both the importing and exporting countries, though importing country characteristics are generally more important. The following drivers of technology transfer have been identified:

- **Restrictive trade and FDI policies unequivocally discourage technology transfer** (figures C.7 and C.8 in appendix C). Tariff and nontariff barriers inhibit imports of capital goods and the technologies they embody. Meanwhile, restrictions on FDI can discourage foreign firms from transferring productive technology to the domestic economy.
- **The effect of local capacity on technological absorption is ambiguous, because it entails two countervailing dynamics.** An adequate degree of local technological capacity is necessary to exploit the transferred technology; however, a very high degree of local technological capacity can increase the risk of imitation, potentially deterring foreign patent holders from transferring their technologies. Strong IPR protections can mitigate this risk, but only partially.
- **National environmental policies also entail two opposing effects on LCT transfer.** On the one hand, robust environmental protections can promote innovation and technology transfer by increasing domestic demand for LCT. On the other hand, environmental policies can also increase public investment in innovation, which may crowd out private investment and deter technology transfer. Because the stock of LCTs likely captures the former effect,<sup>17</sup> the empirical model used in this analysis likely underestimates the positive impact of environmental policies on LCT innovation and technology transfer.
- **Similarly, IPR protections have a theoretically ambiguous effect on LCT innovation and technology transfer.** Robust IPR protections can encourage technology transfer (this is the so-called market expansion effect)

by reassuring patent holders that their technology will be protected from imitation. Those protections can also enhance the market power of patent holders, creating monopolistic price distortions that limit the volume of sales and disadvantage local competitors. Consequently, the net impact of strong IPR protections on technology transfer is unclear (Maskus 2000).

### The methodology for estimating the determinants of LCT transfer

The effects of national policies and other country characteristics on LCT transfer are estimated using the following gravity model:

$TRANSFER_{ijkt}$  represents the number of patents in technology  $k$  filed in country  $j$  by inventors located in country  $i$ . Because this analysis focuses on technology transfer to developing countries, the recipient country  $j$  is restricted to developing countries.  $Ink_{jkt}$  is the log of the discounted stock of patented inventions in technology  $k$  in country  $j$  and serves as a proxy for country  $j$ 's absorptive capacities that are specific to technology  $k$ .<sup>18</sup>  $POL_{jt}$  is a vector that includes the stringency of IPR protections, the strictness of climate regulations, the level of FDI restrictions, the level of tariff barriers, and the level of nontariff barriers.  $X_{jt}$  is a vector of control variables that includes the flexibility of business, labor, and credits regulations; the income level of the recipient country measured by logged GDP per capita; and the size of its economy measured by logged population.  $\mu_{ikt}$  represents the exporter-year fixed effects. It captures all the characteristics of the country of the inventors that affect the transfer of LCT patents at any time. For instance, it controls for the amount of knowledge in technology  $k$  of the inventors located in country  $i$ .  $FTA_{ijt}$  is a dummy variable equal to 1 if country  $i$  and country  $j$  are in a free trade agreement. This analysis estimates three versions of the model (box 3.1).

### Data used in the empirical analysis

#### ***Cross-border patent transfer***

Data on cross-border patent filing and patented inventions come from PATSTAT. As described earlier in the section titled "Data Sources and Accounting Methodology for LCT," LCT patent filings are identified using the YO2 code of the CPC maintained by the EPO. Model (3.1) is estimated for eight technological fields: all LCT; buildings; CCS; ICT; energy generation, transmission, and distribution; manufacturing; transportation; and waste management. The data underpinning each potential determinant of LCT transfer are described in the following subsections.

#### ***Local capacity for technological absorption and innovation***

Local technological capacity is divided into two categories. The first category covers generic absorptive capacity, which allows for the exploitation of all kinds of technologies. The second covers specific absorptive capacities related to a given technological field. The number of researchers, R&D expenditure as a share of GDP, and enrollment in tertiary education can be used as proxies for generic absorptive capacities. Unfortunately, these data are unavailable for

Specification A adds a vector of gravity variables  $D_{ij}$  that includes the distance between the two countries and whether they share a border, have a common official language, or have a colonial tie. These variables are usual in gravity estimation and capture an important part of the variation in the transfer. Trade and foreign direct investment are inversely proportional to distance, and their magnitudes are greater between countries that speak a common language. These variables should similarly influence patents, which are another measure of technology transfer.

Specification B augments specification A with importer-year fixed effects  $\rho_{ik}$  that capture characteristics of the importing country that do not vary over time. Such characteristics include the degree of political

stability, the nature of the political regime, and the degree of remoteness between the importer  $j$  and other importing countries. Specification B is superior to specification A because  $\ln K_{jkt}$  and  $POL_{jt}$  can be correlated with  $\rho_{ik}$ , which are omitted in specification A.

Specification C includes country-pair fixed effects  $\delta_{ijk}$ , which capture time-invariant characteristics that influence cross-border patent filing from country  $i$  to country  $j$ . Such characteristics include the gravity variables  $D_{ij}$  and other omitted variables, such as the existence of a trade war between country  $i$  and country  $j$ . Specification C is superior to both specification A and specification B because  $\varepsilon_{ijkt}$  contains fewer omitted variables than  $v_{ijkt}$  and  $\omega_{ijkt}$ .

Because the dependent variable  $TRANSFER_{ijkt}$  is a count variable, model (3.1) is estimated using the Pseudo Poisson Maximum Likelihood estimator (Silva and Tenreyro 2006) to minimize the estimation bias and avoid truncating country pairs with 0 transfers. Robust standard errors are clustered at the country level.

Although the analysis accounts for many factors affecting the patents transfer, it is possible that there are omitted variables in the error terms. Because of the use of exporter-year fixed effects, country-pair fixed effects, and a large number of controls, not much scope exists to mitigate further endogeneity issues.

Finally, there is no evidence for multicollinearity in the empirical estimation because the correlation coefficients between all regressors do not go above 0.5 or below  $-0.5$  (table C.10 in the appendix C).

a large number of countries, and including generic absorptive capacities in the model would severely truncate the estimation sample and lead to estimation bias. By contrast, specific absorptive capacities can be proxied by the discounted stock of patented innovations in a given field, and PATSTAT encompasses nearly all patented innovations.

#### Intellectual property rights

IPR protections are measured using the IPR indicator in the Executive Opinion Survey (EOS) produced by the World Economic Forum (WEF). The EOS asks a representative sample of leading business executives in each economy to quantify, on a scale of 1 to 7, the strength of IPR protections.<sup>12</sup> The random sampling follows a dual-stratification procedure based on the size of the company and the sector of activity, which ensures that both large and small firms



representing the various economic sectors of the economy are captured in the final country-level score.<sup>20</sup> The 2011 EOS covered 142 economies accounting for 98 percent of global GDP, with an average of 98 respondents per country. As expected, IPR protections are strongly correlated with GDP per capita and with the patent protection index commonly used in the literature (Park and Lippoldt 2008).

The enforcement of IPR protections is measured using the WEF's IPR Index and the Fraser Institute's Legal Systems Index. This approach, which follows that of previous studies (Dussaux, Dechezleprêtre, and Glachant 2018; Maskus and Yang 2013), assumes that a weak legal system necessarily implies weak IPR protections, regardless of the formal stringency of a country's IPR laws. The Legal Systems Index is extracted from the Fraser Institute's annual reports on global economic freedom (Gwartney, Lawson, and Hall 2014). It is a composite index ranging from 0 to 10 that includes indicators of the legal enforcement of contracts, judicial independence, the impartiality of courts, and the integrity of the legal system. The IPR Index value is multiplied by the Legal Systems Index value, and the product is rescaled from 0 to 10.

### ***Environmental policies***

Data on the relative stringency of environmental policies come from Yale University's Environmental Performance Index (EPI).<sup>21</sup> The EPI ranks 180 economies on 24 performance indicators across 10 dimensions of environmental integrity: air quality, water quality, lead exposure, biodiversity, tree-cover loss, fisheries, climate and energy, air pollution, wastewater treatment, and sustainable nitrogen management in agriculture. The EPI score is a weighted average of the indicators in these 10 areas, with the largest weights accorded to air quality and climate and energy. Rescaling the EPI to a maximum of 10 enables comparisons with the estimated coefficients of the different explanatory variables. EPI scores are positively correlated with constant GDP per capita at 75 percent. Finland, Iceland, and New Zealand have the highest EPI scores, whereas China, the Arab Republic of Egypt, and Turkey have the lowest (see figure C.5. of appendix C).

### ***Foreign direct investment***

The relative restrictiveness of FDI policy is proxied by the "controls on the movement of capital and people" indicator from the Fraser Institute's 2015 Economic Freedom of the World report (Gwartney, Lawson, and Hall 2015). This indicator has three components: restrictions on foreign ownership and investment, capital controls, and the freedom of foreigners to visit. The first component is based on the WEF's Global Competitiveness Report (WEF 2018).<sup>22</sup> The second comes from the International Monetary Fund's annual report on exchange arrangements and exchange restrictions, which includes information on up to 13 types of international capital controls (IMF 2018a). The 0–10 rating is the percentage of capital controls not imposed as a share of the total number of capital controls listed, multiplied by 10. The third component measures visa requirements for foreign visitors using data from Lawson and Lemke (2012). China is the most restrictive economy in the sample, followed by Saudi Arabia, Ukraine, and the United States (see figure C.6 in appendix C). FDI controls in China, the United States, and Russia are, respectively, 93 percent, 64 percent, and 37 percent higher than the sample average.



### Trade policies

The restrictiveness of trade policies reflects the impact of both tariffs and nontariff barriers to trade. The indicator for tariffs comes from the Fraser Institute's 2015 Economic Freedom of the World report. Tariffs are measured by the revenue from trade taxes as share of total export and import values, as reported in the International Monetary Fund's Government Finance Statistics Yearbook and International Financial Statistics report, combined with the unweighted mean of tariff rates (IMF 2018b). Countries with the highest indicator scores for tariff barriers include Argentina, Egypt, Korea, and Russia; and the scores for Egypt, Korea, and Russia are more than twice the sample average. The indicator for nontariff trade barriers also comes from the Economic Freedom of the World Report and is based on data from the WEF's Global Competitiveness Report (WEF 2018).<sup>23</sup> Ecuador has the highest indicator score for nontariff barriers, followed by Egypt, Argentina, and Columbia. Nontariff barriers in Argentina, Ecuador, and Egypt are at least 120 percent higher than the sample average (see appendix C).

### Control variables and the coverage of the sample

Data on population size and GDP per capita come from the World Bank's World Development Indicators. The gravity variables come from the GeoDist database of the Centre d'Etudes Prospectives et d'Informations Internationales (CEPII). The estimation sample covers every year between 2006 and 2015.<sup>24</sup> A detailed description of the data sources for all explanatory variables is included in appendix C (table C.2), along with the summary statistics (table C.3).

The sample of countries used in the model (3.1) estimation is smaller than the sample used in the previous sections because of two limitations. First, countries that received no LCT patent transfers are automatically dropped from the sample when estimating the gravity model (3.1), and the model relies on within-country variation to recover its parameters. The model cannot estimate a parameter for countries with no variation, as is the case for low-income countries. The second limitation reflects the availability of the explanatory variables used in model (3.1). The analysis includes 42 developed countries and 33 developing countries that represent 97 percent and 67 percent, respectively, of the GDP of their respective income groups (table 3.4).<sup>25</sup> The developing countries include 22 upper-middle-income countries that represent 92 percent of their group's GDP, and 11 lower-middle-income countries that represent 17 percent of their group's GDP. No data are available for low-income countries. For lower-middle-income countries, the exclusion of India due to absent data on inbound patent transfers greatly reduces the sample's coverage in terms of GDP and population.<sup>26</sup>

## The determinants of LCT transfer to developing countries

In this section, we mainly discuss the estimation of specification C, which is the specification that best mitigates endogeneity issues. Specification B is displayed to show the robustness of the results and that time invariant characteristics such as distance have an expected negative effect on LCT transfer. Specification A, which is more exposed to omitted variable bias, is reported in table C.6 in appendix C.

Specific local capacity for technological absorption has no effect on LCT transfer from high-income economies, but it has a modestly positive effect on LCT transfer from developing countries. On average, the stock of patented LCT technologies has no statistically significant effect on LCT transfer from high-income economies (table 3.5, specification C). However, a 10 percent increase in the stock of patented technologies increases LCT patent transfers from developing countries by 3 percent (table 3.6, specification C). It should be noted that these results apply only to specific local capacity, which is measured by the discounted stock of patented LCTs produced domestically, because the data on generic local capacity are very limited.

Stringent environmental policies inhibit LCT transfer to developing countries when specific local capacity is accounted for. This finding applies to LCT patents originating in both developed and developing economies. An increase of one standard deviation in the stringency of environmental regulation reduces LCT transfers from developed economies by 65 percent and transfers from developing countries by 78 percent. This negative effect may stem from the fact that the model controls for the stock of LCT innovations, which is itself influenced positively by environmental policy stringency. Therefore, the remaining variation in the stringency of environmental regulation could reflect the crowding-out effect of public support on private innovation and associated patent transfers. In other words, environmental policy stringency may be a measure of LCT supply.

Strong IPR protections have no significant effect on LCT transfer from either high-income or developing economies. This result suggests that the market-power effect and the market-expansion effect described earlier tend to offset each other on average.

FDI restrictions hinder LCT transfer from both high-income and developing economies. Controls on the movement of capital and people have a substantial negative impact on the number of LCT patents transferred by both high-income and developing economies. An increase of one standard deviation in FDI restrictions reduces transfers from high-income economies by 23 percent and transfers from developing countries by 41 percent.

High tariffs also deter LCT transfer from both high-income and developing economies, but nontariff barriers have the opposite effect. An increase of one standard deviation in the tariff barriers indicator decreases LCT patent transfers from high-income economies by 15 percent and transfers from developing countries by 26 percent. An increase of one standard deviation in the nontariff barriers indicator increases transfers from developed economies by 30 percent and transfers from developing countries by 22 percent.

The positive impact of nontariff barriers is counterintuitive, but it has at least one possible explanation. High nontariff barriers may encourage firms to interact with foreign markets via FDI rather than trade. Because FDI tends to be more knowledge-intensive than trade in capital goods, the negative effect of nontariff barriers on trade is more than compensated by the positive effect of nontariff barriers on FDI—hence, the positive effect of nontariff barriers on patent transfers. Note that this interpretation works for receiving countries having a reasonably large market, a necessary condition for a profitable investment.

Do tariff barriers encourage firms to choose FDI over trade? High tariffs increase the price of imported products, which leads to lower import volume. That is the negative effect we have estimated in our model. In contrast, nontariff barriers can have a more prohibitive effect on trade. For instance, imports quotas set a limit on the quantity of goods that can be imported. When a quota is met, FDI is the only way to exploit the technology further. Other examples of nontariff barriers that might encourage FDI over trade are domestic subsidies that incentivize foreign firms to operate domestically to level the playing field with competitors. This shift from trade to FDI is more likely to occur when trade costs are high. When including an interaction term between nontariff barriers and the distance between the two trading partners as a proxy for trade costs, we find that the positive effect of nontariff barriers on patent transfer increases with the distance. This result provides some evidence for our interpretation.

Larger market sizes positively influence LCT transfer. Economies with growing populations receive more patent transfers from developing countries, and wealthier economies receive more transfers from both high-income and developing economies. A 1 percent increase in GDP per capita is associated with a 1.2 percent increase in patent transfers from both high-income and developing economies.

The outsized impact of China on key variables may affect the estimation results. China's contribution to LCT innovation and patent transfers dwarfs that of other developing countries, and China has particularly restrictive inbound FDI policies. However, an estimate of model (3.1) using specification C and excluding China produces results that are highly similar to those presented above (see table C.8 in appendix C).

## Results by LCT field

Separately estimating the results for each LCT field yields several important findings. First, the results at the field level are generally consistent with the overall results.<sup>22</sup> Second, substantial heterogeneity exists between results by technology fields and economies of origin (table 3.7). For instance, an increase of one standard deviation in the tariff barriers indicator reduces manufacturing-related LCT transfers by 17 percent from high-income economies and by 32 percent from developing countries. By contrast, ICT-related LCT transfers are unaffected by tariffs.

The analysis finds two significant differences between LCT transfer from high-income economies and LCT transfer from developing countries. First, the magnitude of the determinants is more important for patent transfers from developing countries than it is for transfers from high-income economies. Second, the effect of local capacity for technological absorption is negative for transfers originating in high-income economies and positive for transfers

originating in developing countries. This finding suggests that LCT produced in developing countries tends to complement LCT imported from other developing countries, but not LCT imported from high-income economies.

Conditional on adequate capacity, more stringent environmental policies *reduce* patent transfers from high-income economies in all technologies by 65 percent and for transfers from developing countries by 78 percent.<sup>28</sup> Surprisingly, greater nontariff barriers *increase* LCT patent transfers in all technology fields from both developed and—more significant—developing countries. For high-income economies, stronger IPR protections reduce transfers of LCT used in buildings by 24 percent; higher tariffs and FDI controls *deter* LCT transfers in all technologies by 15 percent and 23 percent respectively. For developing countries, higher tariffs and FDI controls inhibit LCT patent transfers by 26 percent and 41 percent, respectively. Finally, an increase of 1.0 percent in GDP per capita boosts LCT patent transfers from both high-income and developing countries (refer to table 3.7, “Transfers from high-income economies” and “Transfers from developing countries”).

### Effects of relaxing FDI controls and lowering tariffs

Simulations for Brazil, China, and Russia—the three largest carbon emitters in the developing world<sup>29</sup>—indicate that moderately easing FDI controls and lowering tariff rates could greatly increase the transfer of LCT. The impact of relaxing FDI controls is 50 percent greater, on average, than the impact of lowering tariffs, because these countries restrict their capital markets more tightly than their goods markets. A 10 percent decrease in FDI restrictions boosts LCT transfer from high-income economies by 11 percent in China, 7 percent in Russia, and 6 percent in Brazil. Meanwhile, LCT transfer from developing countries increases by 23 percent for China, 16 percent for Russia, and 12 percent for Brazil. A 10 percent decrease in tariffs increases LCT transfer from high-income economies by 7 percent in Russia, 4 percent in Brazil, and 2 percent in China; LCT transfer from developing countries increases by 13 percent for Russia, 7 percent for Brazil, and 4 percent for China (table 3.8).

These findings indicate that easing FDI controls potentially through international investment agreements could significantly accelerate LCT transfer to developing countries.<sup>30</sup> International investment agreements<sup>31</sup> are an important tool for reducing FDI restrictions, but progress appears to have plateaued in China and Russia. Both countries have ratified investment agreements with four of the world’s top LCT innovators: China, Germany, Japan, and Korea. Neither, however, has ratified such an agreement with the United States (table 3.9). The share of economies that have investment agreements with China and Russia has increased significantly over the past 20 years.<sup>32</sup> Although the number of those agreements is informative, their impact on FDI restrictions can vary significantly. For example, the agreement between China and Germany contains “negative-list reservations,” which explicitly exclude certain sectors and industries from its terms.

Domestic policy changes can also facilitate LCT transfer by easing restrictions on the movement of capital and people. China's FDI regulations divide all industries into four categories: encouraged, permitted, restricted, and prohibited (Liu 2017).<sup>32</sup> In industries considered strategic to China's development, the government encourages FDI by offering government subsidies, tax incentives, and regulatory waivers. FDI in restricted industries is subject to specific regulations, including majority ownership by Chinese shareholders. FDI in prohibited industries is forbidden. Most LCT-related industries are in either the encouraged or permitted categories (see table C.10 in appendix C). Some industries, however, such as the construction and operation of nuclear power plants and power grids, are in the restricted category.

China's new foreign investment law—which will come into effect in 2020—is designed to facilitate FDI in industries categorized as encouraged or permitted. Before the new law, foreign investments in encouraged and permitted industries had to comply with certain requirements and get approval, which could take up to six months. The new law has eliminated the approval process for encouraged and permitted industries and replaced it with a simple registration system (Edelberg 2017; Liu 2017). By easing the administrative burden of FDI, the new law is likely to positively affect inbound LCT transfer.

## CONCLUSIONS

Confirming the results of chapter 2, the analysis in this chapter shows that LCT innovations remain concentrated in high-income countries and that almost three-quarters of all LCT transfers occur between high-income countries. Using a dataset of patents from 75 countries observed from 2006 to 2015, this chapter identifies five main drivers of LCT transfer to and from developing countries. Restrictive FDI policies and tariffs inhibit LCT transfer, whereas nontariff barriers, large markets, and local capacity for technological absorption encourage it. Separately analyzing LCT patent transfers originating in high-income and developing economies reveals that these factors have a stronger impact on LCT transfer from developing countries.

The analysis also demonstrates that modestly easing FDI restrictions and lowering tariffs can significantly accelerate LCT transfer. China's new FDI law sets a positive example for other developing countries by easing the administrative burden faced by foreign investors in many LCT-related industries. Meanwhile, the finalization of the EGA, which aims to decrease tariff rates on environmental goods, could significantly increase LCT transfer among WTO member states, as advocated in chapter 2, if negotiations resume and conclude successfully.

It is important, however, to recall the limits of the present study. Although cross-border patent filing is a good indicator of international technologies transfer, it is also an imperfect measure—for several reasons. First, some firms may file strategic patents without actually transferring technology. Second, the number of high-value patents transferred is a count variable, which implicitly assumes that all inventions have the same technological content. Third, the measures of tariff, nontariff, and FDI barriers used in the empirical estimation are the same for all technologies and not specific to LCT<sup>34</sup> and may produce measurement errors in the variables used.<sup>35</sup> Finally, data constraints exclude certain countries—such as India—from the analysis, which greatly reduces the sample's representativeness.

5. The CPC system is an expanded version of the International Patent Classification (IPC) system developed by the World Intellectual Property Organization (WIPO). Previous analyses, notably Dechezleprêtre, Glachant, and Ménière (2013), used the IPC system to identify LCTs; however, the IPC system was not designed for this purpose, and it does not include a dedicated code for LCTs. LCTs can be identified in certain categories—such as renewable energy, motor vehicles, and construction inputs—but several important types of LCTs used in the manufacturing sector are excluded, and the IPC does not identify LCTs used in the agricultural sector. Whereas the IPC covers only 13 LCT subfields, the CPC includes 33 LCT subfields containing dozens of codes.

For instance, the likelihood that the number of patents transferred between two countries will equal zero is much higher for CCS than it is for energy. Therefore, the number of country pairs used in the field-level regression is always lower than in the aggregate regression.

# 4 The Rise of Emerging Economies as Leaders in Low-Carbon Innovation

## INTRODUCTION

The previous chapters have discussed how a number of emerging economies have succeeded in developing the capacity to absorb, imitate, and indigenously create technology. These countries are now important players in global markets, disrupting the traditional paradigm of North–South technology transfer and introducing new models of South–South technology exchange.

This chapter discusses elements of this transformation with a focus on China, which has achieved remarkable progress in leveraging both technology transfer and domestic innovation to support its transition to low-carbon development. The first section describes the rise of the wind, solar, and ethanol industries in a few emerging economies that have transformed themselves from technology importers to technology innovators and exporters. The second section focuses on a single low-carbon industry, electric vehicles (EVs), in which China has emerged as a global leader. Next, the chapter examines the case of a Chinese EV firm, Build Your Dreams (BYD), and compares it to that of a similarly innovative U.S. firm, Tesla. The last section draws some conclusions.

## THE EVOLVING ROLE OF LCT TRANSFER AND INNOVATION IN EMERGING ECONOMIES

The experience of the Republic of Korea, a former emerging economy that is now an industrialized nation, offers important lessons for countries striving to develop their capabilities to absorb and adapt foreign technology. In the 1960s, the Korean government encouraged technology transfer through production arrangements with foreign firms, reverse engineering of imported equipment, and technical training provided as part of turnkey plant investment. Weak intellectual property rights (IPR) protections encouraged imitation and adaptation, whereas foreign direct investment (FDI) played only a modest role in building Korea's technological capacity. In the 1970s, the government shifted to an outward-looking development strategy that forced Korean industries to compete in international markets. Competitive pressures created a strong incentive to adopt new technologies, and Korean industries began investing heavily in

technological development and adaptation. In the 1980s, Korean firms became increasingly focused on innovation and made large-scale investments in their domestic research and development (R&D) capabilities. National economic policies played a major role in the country's technological advancement; as the scale and complexity of the domestic technology sector increased, the government moved from setting rules and standards to providing concrete targets and supportive financing.<sup>1</sup>

### **The rise of the wind industry**

Like Korea, a number of emerging countries started off as importers and adapters of low-carbon technology (LCT) and became innovators, producers, and exporters. Wind, ethanol, and solar industries provide good examples of this transformation.

The manufacturing of wind turbines and related equipment began in Europe in the late 1980s and 1990s, supported by public policies aimed at developing renewable energy sources (Urban 2018). Starting in the early 2000s, Brazil, China, India, and South Africa began increasing their wind energy manufacturing capabilities. This process was driven by the high transport costs for large turbine components combined with surging domestic and regional demand for wind power (CEMAC 2017) and the need to diversify energy sources.

China began developing its wind power industry by importing technology from European firms through licensing agreements and joint ventures (Ru et al. 2012). German–Chinese technological cooperation included joint R&D projects, which resulted in the design of wind turbines on the multimewatt scale. But soon Chinese firms realized that the imported technology could not suit their needs, and they used their own knowledge and capabilities to create wind turbines tailored to specific local conditions in China, such as low-wind-speed turbines for use in desert regions marked by extreme heat, dryness, and sand exposure. Initially supported by feed-in tariffs, which were recently replaced by an auction system, the industry grew rapidly; China now has the highest installed wind capacity in the world and ranks among the leading countries in publications on strategic wind energy components. Chinese companies manufacture turbines and other large, complex wind power products at prices well below those of major Western manufacturers (Lam, Branstetter, and Azevedo 2017).

India was also late to enter the wind power sector, but it rapidly established itself as one of the world's top producers of wind power generation and distribution systems. Like Chinese firms, Indian firms worked closely with foreign counterparts to assimilate existing technologies and managed to generate new innovations, creating wind turbines designed to suit the Indian context. This “interactive learning” process, combining technology transfer with domestic innovation, generated benefits for both Indian firms and their foreign counterparts (Lundvall 1985).

Local content requirements slowed down the growth of South Africa's wind industry. In 2011, South Africa launched the Renewable Energy Independent Power Producer Procurement Program (REIPPPP), which was intended to support the development of renewable energy, help address the energy supply crisis, and mitigate emissions. The procurement process required project developers to engage at the local level, compensate affected communities, and buy a certain percentage of their equipment locally. Local content requirements

were expected to support local industrial development and create jobs, but they have been controversial policy instruments—in South Africa and elsewhere—because their impact on jobs depends on how they are implemented. The value of the REIPPPP was to attract private investors in relatively new sectors thanks to a well-designed and transparent procurement process. The program was less successful, however, in fostering the growth of a local wind industry. High-technology components such as blades continued to be imported. Local manufacturers could not supply turbines and had difficulties proving the required two years of experience. Moreover, investors hesitated because of the perceived lack of government commitment to renewables and the small size of the South African market (Rennkamp and Westin 2013).

In Brazil, the rise of wind energy generation after the 2001 crisis was the result of a strategy to diversify the energy mix, supported by policies and subsidies programs (in 2002 and 2004) and credit programs from the National Development Bank. Brazil is now the largest wind energy market in Latin America, and companies such as Petrobras are moving into the offshore market. The key innovation supporting the development of the sector was the introduction of exclusive renewable energy auctions, which reduced prices, made the market competitive, and attracted foreign companies.

### **Ethanol and solar industries**

In addition to its leadership in wind power, Brazil has emerged as a leading producer of sugarcane-based ethanol for the transportation industry. Sugarcane has been transformed into alcohol for centuries, and ethanol production draws on this age-old technology. In Brazil, the widespread use of ethanol fuel began as a reaction to the variability of oil prices and it culminated in the creation of flex-fuel engines that can run equally well on gasoline or ethanol. Brazil's success with sugarcane ethanol (box 4.1) underscores the key role that consistent, long-term policy support plays in the development of LCT. The ethanol industry was supported through changing political administrations, oil-price shocks, and economic crises, with an array of fiscal and industrial incentives that were maintained until the industry matured. Over time, Brazil developed substantial technological and scientific expertise in ethanol-based technologies, which it began exporting, particularly to Africa, through a combination of technology transfer and private sector investment that became known as “ethanol diplomacy” (Dalgaard 2012).

Expanding its leadership beyond wind power, China is now a leader in solar photovoltaic (PV) systems, a technology developed in the United States but now manufactured predominantly in China. Solar PV has been considered a strategic industry in China since the 2006–10 five-year plan and has benefitted from generous public subsidies. After a crisis in 2011–12, however, the industry was restructured and subsidies became more selective. China is currently the largest producer in the world of solar PV cells (see figure 4.1).

China's experience with solar water heaters is another example of its transformation from a technology importer to an innovator. In the 1980s, China imported flat plate collectors from Canada, but this technology did not function well in the Chinese context. Chinese engineers responded by developing evacuated tube technology, an inexpensive alternative that better serves the needs of the Chinese market. Today, 95 percent of all solar water heaters in China use the



## BOX 4.1

**Brazil's success with sugarcane ethanol**

Brazil has been producing sugarcane-based ethanol since the 1970s, when President Ernesto Geisel initiated the National Alcohol Program (ProAlcohol) in response to the 1973–74 oil crisis. The program was designed to reduce Brazil's dependence on oil imports while addressing the collapse of sugar export prices. ProAlcohol worked closely with the state-owned oil company, Petrobras, to address financing challenges and develop innovations that would allow the shared use of existing infrastructure (for example, technologies that would enable the same pipelines to carry both oil and ethanol while avoiding corrosion or undesired mixing). Ethanol was initially blended with gasoline at rates of 5–10 percent, which was safe for unmodified gasoline engines and lightly modified gas stations. The government incentivized ethanol production by providing low-interest loans to expand sugar mills and distilleries, establishing guaranteed prices set at the average cost of production, and creating demand through blending mandates. Petrobras, which had experience as a gasoline retailer, was granted a monopoly on ethanol distribution.

The 1979 oil crisis spurred a second phase in the ethanol program. Foreign and domestic automakers were pressured to manufacture ethanol-only vehicles, and by 1985 practically all new vehicles ran on pure ethanol. Ethanol pump prices were fixed at 59 percent of the price of gasoline, and ethanol-only vehicles were subject to lower sales taxes and licensing fees than conventional vehicles. Petrobras also built a

distribution and pump infrastructure for pure, as opposed to blended, ethanol.

Because oil price projections remained high, however, little effort was made to increase the efficiency of domestic ethanol production. Tumbling oil prices in 1986–87, just as Brazil was experiencing one of its worst economic crises, forced the government to reduce guaranteed prices for ethanol to below the cost of production. Meanwhile, ethanol output fell as sugar prices recovered and exports rebounded. The ethanol industry was compelled to increase production efficiency, but the market remained constrained by technical limitations, because the maximum ethanol blend that could be used in gasoline-powered cars was just 25 percent.

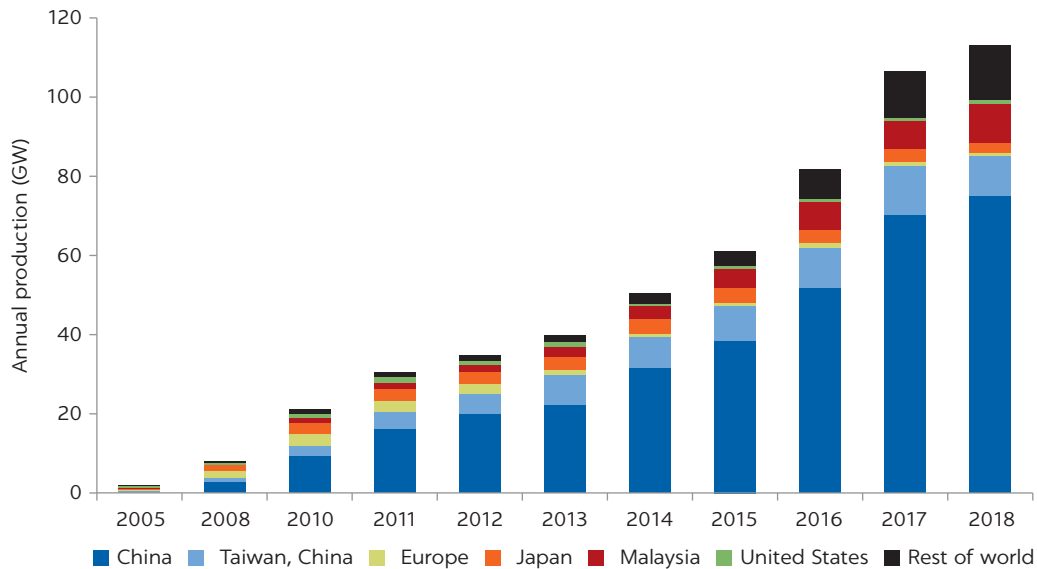
In 2003–04, Brazil's automotive sector launched flex-fuel technology, which radically altered the ethanol market by enabling car owners to use whatever fuel or mix of fuels they wanted. This innovation was introduced by the Brazilian subsidiaries of major international car companies such as Fiat, General Motors, and Volkswagen, which drew on both foreign technology and local research and development. Government incentives ensured that flex-fuel vehicles were priced competitively with traditional gasoline-powered automobiles. To promote the sale of flex-fuel vehicles, the authorities used many of the same policies that had previously bolstered sales of ethanol-only vehicles, including favorable tax treatment at the point of purchase and reduced annual licensing fees.

evacuated tube design, and Chinese firms hold 95 percent of the patents for core technologies used in solar water heaters worldwide.

The development of solar PV cells and solar water heaters—two equally successful industries—is instructive. Although China is the world's largest investor, producer, and exporter of solar PV, the diffusion and installation of solar PV remains a challenge because of a number of social and technical barriers, including grid connectivity. Conversely, in the case of solar water heaters—where fewer of these barriers exist—China has the world's largest installed capacity (REN21 2011). These low-cost standalone systems have been very popular and constitute largely overlooked agents in the transition from fossil fuels to low-carbon energy (Tyfield, Ely, and Geall 2015).

Finally, as discussed in chapter 2, emerging countries are not only becoming innovators but are also transferring technology to developing countries at the same or lower level of development. Is South–South LCT transfer any different from the traditional North–South LCT transfer? Ideally, South–South technology transfer could offer unique advantages, because developing countries share similar characteristics and may benefit from opportunities for collaborative capacity building. Some examples of South–South collaboration are reported in appendix D. Although too few to draw general lessons, they highlight that regardless of its origin, technology transfer takes place within a country-specific political, economic, and social environment that influences the type and amount of technology transferred, who participates in the decision-making process, and who benefits from the new technology. The studies also reveal that, to be sustainable, technology transfer requires not only an adequate policy framework but also an inclusive public consultation process. The rest of this chapter discusses the development of the EV market as a case study to illustrate China’s success in technology adoption and innovation; it then compares the strategy and performance of one of China’s largest battery and EV producers, BYD with that of an equally successful U.S. EV producer, Tesla.

## THE EMERGENCE OF A GLOBAL ELECTRIC VEHICLE MARKET

The dynamic and growing EV industry is a major development in LCT. Initially driven by the energy crises of the 1970s and 1980s, and by the U.S. state of California’s push for more fuel-efficient, lower-emissions vehicles, EV production took off in the late 1990s. The major EV designs include battery-powered electric vehicles (BEVs), plug-in hybrid electric vehicles (PHEVs), and fuel-cell

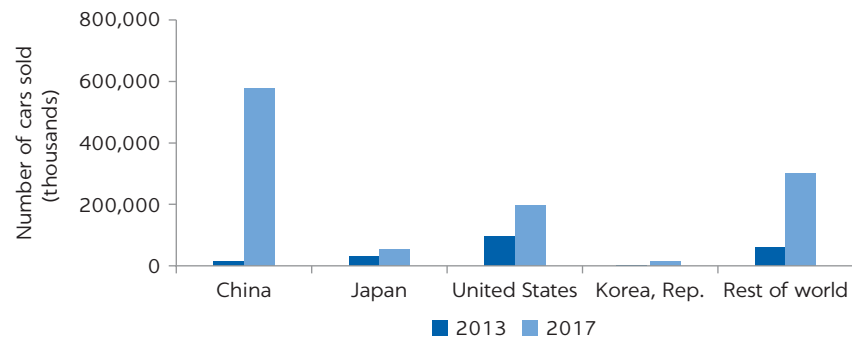

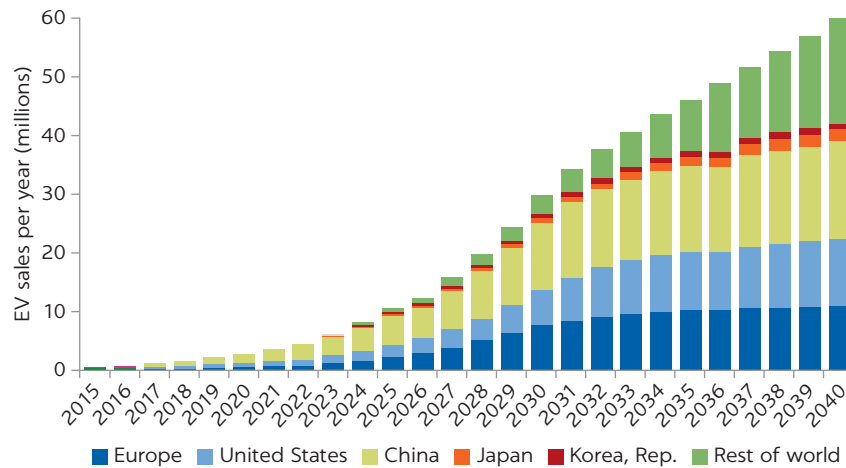
**FIGURE 4.3**

electric vehicles (FCEVs). EV sales and production are largely concentrated in China, Europe, Japan, and the United States (see figure 4.2 and figure 4.3). Together, these four markets account for more than 97 percent of global EV sales and 93 percent of production (Lutsey et al. 2018). Surging global demand, progress in building the charging infrastructure, and an ever-expanding array of vehicle models are the key drivers of the EV industry.

Norway, which has the highest number of EVs per capita in the world,<sup>2</sup> aims to have zero-emissions vehicles account for all new cars sold by 2025, and France and the United Kingdom have announced that new gasoline and diesel cars will be banned by 2040. Other countries in Europe, however, are lagging. Among emerging countries, China is expected to lead the EV revolution. According to BloombergNEF (2018) projections, by 2025, 19 percent of all car sales in China will be electric, compared to 14 percent in Europe and only 11 percent in the United States. By 2040, the share of EV sales is expected to reach 60 percent in China. Worldwide EV sales will surge to 30 million in 2030 (figure 4.4).

India, the second-largest emerging economy in the world, is far behind in developing its EV industry. In terms of size, India's automobile industry currently ranks fifth in the world, but its EV industry is in its nascent stages. The overall cost of producing EVs is high because India imports most of the inputs (such as battery packs), and the country has a near absence of charging infrastructure despite initiatives to set up community charging stations.

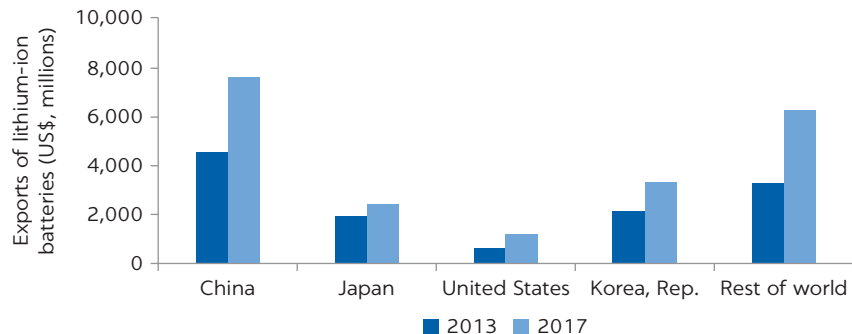
**New electric car sales, by country, 2013 and 2017**

Moreover, India produces electricity mainly by burning coal, which defeats the purpose of introducing EVs to reduce greenhouse gas emissions. In early 2019, however, India launched the “National Mission on Transformative Mobility and Battery Storage” to support clean, connected, shared, and sustainable mobility initiatives, and a “Phased Manufacturing Program” to support setting up of large-scale, export-competitive integrated batteries and cell-manufacturing giga plants, as well as localizing production across the entire EV value chain. The two programs are intended to run until 2024.

### The rise of China’s EV industry

The rapid expansion of China’s EV industry was initially underpinned by growing concerns about pollution and energy security, but it also reflects key features of China’s industrialization strategy. Over the past 20 years, China has become the world’s largest passenger vehicle market, with annual automobile sales rising from fewer than 1.0 million units in 2001 to 22.7 million in 2018 (Yeung 2019). Although the growth of vehicle ownership is an important part of China’s economic development, it has also driven a sharp increase in carbon emissions and local air pollution. Thus, in 2009, the Chinese government decided to vigorously develop its EV industry as a means of simultaneously reducing air pollution, moderating oil consumption, and positioning China as a technological leader in the global automotive industry.

The following analysis uses Porter’s Diamond Model to shed light on the factors that have driven China’s emergence as a major force in the global EV industry.<sup>3</sup> The analysis points to four determinants of China’s comparative advantage:

- **China has an abundant endowment of the productive factors necessary to succeed in the EV industry**, and its extensive trade network enables producers to obtain resources that cannot be sourced domestically. China has large lithium reserves, but it also imports high-quality lithium from Africa and

South America. Besides lithium, EV batteries also require a cathode, which is usually made of metals such as nickel and cobalt, as well as a graphite anode. In 2016, China accounted for 66 percent of global graphite production and 35 percent of consumption. To control costs, Chinese companies have been acquiring cobalt and lithium assets around the world. The mining firm China Molybdenum recently spent US\$2.6 billion to purchase the rights to the Democratic Republic of Congo's Tenke mine, which is believed to hold the world's largest concentration of cobalt. In addition to its vast natural resources and extensive trade links, China has a large and diverse workforce, and it ranks in the top third of countries in terms of human capital. Moreover, the government's earlier push to develop a domestic automotive sector has provided the new EV industry with engineers and workers who already possess car-manufacturing experience. Chinese firms have access to a range of finance options, including venture capital, and the government has invested heavily in the country's industrial infrastructure.

- **Chinese EV producers benefit from the presence of a well-established cluster of related industries.** China's automotive sector includes over 10,000 auto-parts factories, and local suppliers can produce all of the key components for EVs, such as batteries, motors, and electric control systems. In the early stages of the EV industry's development, China either imported highly complex parts, such as engines, or produced them through joint ventures between foreign and Chinese firms. China has since developed the domestic capability to manufacture all the essential elements of EVs.
- **China's EV sector benefits from a thriving domestic market for automobiles, which is far less saturated than most auto markets in advanced economies.** In 2017 a total of 29 million cars were sold in China; however, China still has just 80 vehicles per thousand people compared to 770 per thousand people in the United States. The considerable margin for growth in China's auto market leaves ample space for alternatives such as EVs. In addition, because the dominance of conventional vehicles is far less entrenched in China than it is in many advanced economies, Chinese consumers are more willing to accept EVs and face lower switching costs.
- **China's automotive sector is concentrated, but regulatory changes are expected to increase competition.** In China, hundreds of car companies produce thousands of models, but the top-10 manufacturers dominate 88 percent of the market, with the top-two firms taking about 20 percent each. The elimination of foreign-ownership restrictions on special purpose vehicles and EVs in 2019, which will be followed by the liberalization of regulations on commercial vehicles in 2020 and passenger cars in 2022, should increase market contestability and intensify competitive pressures.

### **The role of China's industrial policies in the rapid development of its EV industry**

In the early 2000s, China's efforts to develop the EV industry focused on establishing the R&D capacity necessary to overcome critical barriers related to price, infrastructure, and battery technology. Early efforts to support R&D for core EV technologies were included in the 1986 High-Tech Development Plan (known as the "863 program"),<sup>4</sup> which continued through several Five-Year Plans.

The 863 program required cofinancing from the private sector, so most applicants for program funding were automakers partnered with research institutions (Kokko and Liu 2012). After nearly 10 years of R&D promotion efforts, the government began to focus its support on EV production. The Ministry of Science and Technology announced the Strategic Plan for New Energy Vehicles in 2001. Three years later it established the vertical programs on fully electric battery-powered vehicles, gas-electric hybrids, and fuel-cell vehicles, as well as the horizontal programs focusing on battery technology, electric motors, and electronic control systems. These programs provided the framework for building the domestic technological capacity that would underpin the rise of China's EV value chain during the next 10 years.

Engineering the systemic changes necessary to develop a mass-market EV industry proved extremely challenging. In 2008, China launched a pilot program to accelerate the introduction of EVs, initially in 10 cities, each of which was expected to introduce 1,000 EVs within three years. EVs were exempted from the 10 percent purchase tax on new vehicles, with a maximum total financial incentive per vehicle equal to 60 percent of the vehicle's price. Despite intense government support, including tax and price subsidies and infrastructure investment, the experiment failed to achieve its objectives.<sup>5</sup> Zhang et al. (2014) ascribe this failure to weaknesses in EV subsidy policies, local protectionism, inadequate charging infrastructures, and opportunistic behavior by cities and individuals. The pilot's key lesson was that the transition from conventional vehicles to EVs would require not just vision, strategic direction, and government support, but also much higher subsidies and incentives as well as tighter coordination among auto manufacturers, battery developers, infrastructure providers, and consumers.<sup>6</sup>

EV production accelerated in late 2013, when the government significantly increased subsidies to EV manufacturers and developed a network of charging facilities and services based on unified standards. By 2015, China had become the world's largest EV market. In the same year, the Chinese government launched "Made in China 2025," a 10-year industrial plan to make China a global high-tech leader by developing 10 high-tech industries, including new EVs. The 12th Five-Year Plan (2016–20) reaffirmed the government's commitment to the EV industry by including it among six emerging industries prioritized for governmental support.

China's policies in support of the EV industry—from central and local authorities—can be qualified as comprehensive (stretching from R&D to charging stations and consumers), strategic, and aggressive. The EV industry has been supported by subsidies in all countries (box 4.2 describes the key policies adopted in the U.S. EV industry); however, China's subsidies to the industry were huge. According to the Ministry of Industry and Information Technology, by 2018 total central government subsidies for EV purchases reached US\$13 billion, despite delays of some subsidy payments. Local government subsidies may have been much higher, but no comprehensive estimates are currently available.

The Chinese government's generous support for the EV industry also led to unintended consequences. In 2016, a nationwide investigation covering 90 companies and 401,000 EVs sold between 2013 and 2015 revealed that manufacturers could cheat the system by faking sales or downgrading key parts, such as batteries and motor controllers. The government publicly identified the companies involved in the scandal and scrutinized its EV subsidy policies. Reforms in

## BOX 4.2

**U.S. electric vehicle policies**

In the United States, as in China, financial incentives, including tax credits and tax exemptions, have played a major role in the expansion of electric vehicle (EV) technology. The U.S. federal government offers a tax credit for plug-in EVs purchased after 2009; that credit ranges from US\$2,500 to US\$7,500 per vehicle on the basis of battery capacity and gross vehicle weight rating. The full credit is available until a manufacturer sells 200,000 EVs, at which point it begins to phase out.

Over half of all U.S. state governments use rebates, tax exemptions, and tax credits to promote EV purchases. For example, California offers rebates for light-duty zero-emissions vehicles and plug-in hybrids, and low-income families are eligible for an extra US\$2,000 in incentives. Washington and New Jersey exempt EVs from motor vehicle sales

and use taxes. More than 10 American states—including California, Colorado, Florida, and New York—allow EVs to use high-occupancy vehicle lanes. More than 10 states offer rebates and tax credits for installing charging stations, and as of 2017 the United States had 47,130 charging outlets.

In addition, the federal government's Advanced Research Project Agency–Energy has funded EV projects focusing on batteries, automotive controls, and efficient EV chargers. Fleet procurement is another major EV-promotion policy employed by the United States, especially in large municipalities. Battery-powered EVs made up about 1 percent of all U.S. vehicles sold in 2017, and this share is projected to increase to 12 percent by 2050 in part because of supportive state policies and falling battery costs.

2017 reduced EV subsidy levels, tightened technical requirements, and introduced stronger oversight and enforcement mechanisms.

In March 2019, China announced a new scheme that almost halves the existing subsidies and raises the threshold for a vehicle to be eligible for these subsidies. The new scheme also cancels local-level passenger EV subsidies to encourage fair competition across regional markets and requires local governments to add more charging stations and hydrogen refueling stations, as well as providing better services. Lithium-ion battery manufacturers are now required to have at least 8 gigawatt-hours of production capacity to qualify for subsidies (Sanderson, Hancock, and Lewis 2019), and manufacturers of advanced batteries, including lithium-ion and nickel metal hydride, are exempt from the 4 percent consumption tax. The government has also restricted EV incentives to vehicles with batteries manufactured in China, prompting foreign battery companies to establish China-based production facilities or joint ventures with Chinese firms.

To expedite the transition from conventional vehicles, the central government has established that 20 percent of new vehicles would be plug-in EVs by 2025. Meanwhile, following the central government's lead, many local authorities are requiring that a certain percentage of new government vehicles be EVs. Shenzhen, a major industrial center, completely transitioned its fleet of more than 16,000 buses to EVs, and by May 2018 it had 13,000 EV taxis in service. Many cities have also promoted the installation of charging stations to encourage private EV ownership. For example, Beijing has set a target of building more than 435,000 chargers by 2020, and Shanghai subsidizes

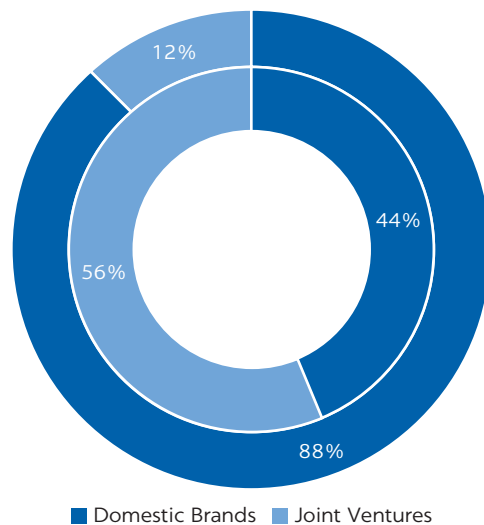


30 percent of all investment in specialized and public chargers. Since 2019, manufacturers selling at least 30,000 conventional vehicles must have a minimum of 4–5 percent of their sales in EVs. Manufacturers that do not meet this requirement will be fined or must buy credits from other manufacturers. Local governments could receive up to US\$14 million to build charging stations if they meet certain conditions, and several provinces and cities have announced additional subsidies (up to 30 percent of the total investment) to support the installation of charging stations.

**Indigenous innovation originated from domestic firms, not from joint ventures**

China’s industrialization policies have resulted in an unusual development pattern of the country’s automotive market. In China, multinational automakers dominate the conventional vehicle industry, whereas domestic firms dominate EV production (figure 4.5). This pattern contrasts with the development of auto industries in other emerging economies, where production often focuses on serving international automotive supply chains with cutting-edge technologies and where domestic production of these technologies, such as EVs, is generally limited (Helveston et al. 2017). In China, joint ventures with international firms represent only 12 percent of the EV market, and indigenous firms represent the rest. This feature is partly the result of the Trade-Technology-for-Market (TTM) policy, which has been the cornerstone of China’s industrialization strategy since the early 1980s. Devised by Deng Xiaoping, the TTM policy requires foreign firms in strategic sectors to form joint ventures with Chinese state-owned partners. Foreign firms are obliged to share technology with their Chinese counterparts in exchange for access to the Chinese market. During the

early stages of the TTM policy's implementation, high tariff barriers<sup>7</sup> sharply limited the scope for auto imports, making joint ventures one of very few ways for foreign automakers to access the Chinese market (Howell 2018).

The TTM policy has long been the subject of criticism from China's trading partners. In March 2018, the Office of the U.S. Trade Representative published a report documenting China's "unfair technology transfer regime for U.S. companies" (USTR 2018). The report highlights the auto industry as an area in which compulsory technology transfer is rampant, and it singles out the EV subsector as a place in which "you're simply not going to be able to sell that product in China unless the local partner has mastered the ability to leverage the technology to produce it going forward."

Meanwhile, Chinese critics have argued that the TTM policy has encouraged Chinese firms to rely on imported outdated technologies instead of investing in domestic research. For example, under a 1984 joint venture between Volkswagen and Shanghai Automotive, the latter developed the capacity to build cars based on German technology, and it continued to produce them under a market monopoly until the 2000s. Because of its limited capacity to create new technologies, Shanghai Automotive produced the same increasingly outdated models for almost 20 years. In response to this challenge, the Chinese government has refocused attention from technology transfer to domestic R&D since 2006, and the timing of this shift has coincided with the development of the country's EV industry.

The joint venture model enabled major foreign automakers to dominate China's mid-range to high-end auto market, whereas smaller Chinese firms focused on small, low-cost vehicles and the emerging minicar segment. This pattern of industry segmentation reflects three key features of the Chinese automotive sector. First, joint ventures dominate China's conventional vehicle market because foreign firms can earn high profit margins by licensing and selling older technologies while withholding cutting-edge innovations. Second, few joint ventures can produce EVs while complying with local regulations for EV manufacturing facilities and the requirement that EV batteries be produced in China. Consequently, EVs produced through joint ventures tend to be expensive and are often sold at a loss as taxi fleets rather than to private consumers. Third, the limited use of joint ventures in the EV subsector opened market opportunities for independent Chinese firms, which were able to capture a large domestic market share thanks to a decade-long process of building R&D capacity. Meanwhile, China's conventional automakers continue to rely on their foreign partners for innovation and to focus their R&D efforts on adapting foreign technologies to the Chinese market (Helveston et al. 2017).

The Chinese government's highly active role in the development of the EV sector has given rise to concerns about the long-term sustainability of the industry. The government's incentive policies may have created a protected EV market for independent domestic firms, and this protection could ultimately have negative implications for efficiency and technological advancement, especially as joint venture requirements are relaxed (Helveston et al. 2017).<sup>8</sup> The government's plan to remove the 50 percent cap on foreign ownership of joint ventures by 2022 will effectively end the TTM policy in the automotive sector. Once the cap is lifted, most joint ventures in the Chinese auto industry will likely transition to full foreign ownership. For instance, Tesla's first plant in

China is already wholly owned by Tesla. Meanwhile, Chinese firms that previously partnered with foreign companies will be forced to compete in the market under their own brands.

## **BYD AND TESLA: THE CONTRASTING TRAJECTORIES OF INNOVATIVE ELECTRIC VEHICLE FIRMS IN CHINA AND THE UNITED STATES**

### **BYD: From imitation to innovation**

This section analyzes the experience of a Chinese automaker, BYD, as a successful example of a firm that has made a transition from technology importation to local innovation and how this transition affects the Chinese market. The next section compares BYD's experience with that of Tesla, the legendary U.S. company that has dominated the U.S. EV market in the past 10 years.

BYD is a major Chinese automaker based in Shenzhen, Guangdong Province. Founded in 1995, BYD started out as a battery maker and entered the automobile business in 2003. The company has diversified into areas such as cell phone assembly and solar cell manufacturing. The establishment of BYD's conventional vehicle business followed the standard model of inbound technology transfer and local adaptation. In 1995, chemist Wang Chuanfu learned that Japanese battery producers and electronics firms were transitioning from nickel-cadmium (NiCd) batteries to nickel metal hydride (NiMH) and lithium-ion batteries, which require a more complex, higher-value-added production process. Realizing that the manufacturing base for NiCd batteries could be moved to China, Mr. Wang founded the Shenzhen BYD Battery Company Limited with an initial investment of US\$300,000.

The company's first revolutionary act was to replace the capital-intensive Japanese style of production with a labor-intensive style more suited to the Chinese manufacturing sector. With a team of 20 employees, Mr. Wang dismantled the batteries produced by competitors (Burkitt 2017) and learned to reverse engineer the technology. Soon, BYD became the preferred battery supplier for large cell phone companies such as Motorola. By 2002, BYD employed 17,000 workers and had become one of the world's top manufacturers of both NiCd and lithium-ion batteries.

As the battery market for electronics matured and BYD faced increasing competition from new Chinese rivals, the company expanded into the domestic EV industry, perceiving the nascent sector as a way to leverage its manufacturing capabilities while creating new demand for batteries. BYD's initial approach to the auto industry mirrored its approach to battery production: manufacturing processes substituted labor for capital, and foreign products were reverse engineered to expand in-house production capabilities. Although quality control was an issue during the early stages of BYD's entry into the automotive sector, the company developed special tools and worker-training programs to improve its performance. BYD managers regarded these early challenges as part of an ongoing learning process through which BYD adapted international production methods to reflect local conditions (Wang and Kimble 2013).

BYD's automotive wing initially focused on three main business lines: conventional vehicles, fully electric vehicles, and hybrid vehicles. BYD targeted the low-cost, family-oriented passenger vehicle segment, and its first car model, the F3, came off the production line in 2005. In 2008, BYD unveiled the first plug-in hybrid to be produced at a commercial scale anywhere in the world. Despite having a fully electric range of over 60 miles, BYD's hybrid was not as glamorous as the Tesla Roadster, which debuted the same year. BYD struggled with low sales between 2010 and 2012, but it continued working on an innovative technology. In 2011 it introduced the G6 model, which used an engine and transmission system developed in-house. BYD engineers subsequently created a "dual-mode"<sup>9</sup> plug-in hybrid that was cheaper and more efficient than the Toyota Prius at the time. This model required no reverse engineering, because BYD already had the capacity to produce batteries, electric motors, and electronic control systems—the three core EV technologies.

BYD then began producing EV models based on its own internally developed lithium-ion-phosphate battery. This battery boasted a safer design than previous technologies and did not require cobalt or nickel, which were in short supply in the Chinese market. The Chinese government's generous subsidies for domestically produced EVs apply only to models that use Chinese-built batteries, making local components especially important. More recent energy-density requirements have prompted Chinese battery makers to push their technological limits even further.

BYD's focus on R&D sets it apart from other Chinese companies, and its integration of multiple complementary product lines is unique among EV producers. In January 2015, BYD announced that the world's first three-engine, four-wheel drive, dual-mode sport utility vehicle, the Tang, was available for preorder. The Tang's three engines make it able to reach speeds of over 100 kilometers per hour within five seconds. By 2018 BYD had more than 12,000 domestic patents and more than 8,000 international patents (in areas such as environmentally friendly, fire-safe iron phosphate chemistries and advanced EV drive and energy recovery systems). In 2013, BYD received the "Outstanding Patent Innovation and Industrial Design" award from the World Intellectual Patent Organization. BYD's patent for EV batteries also received the China Patent Association's Award of Excellence.

BYD is currently the only company in the world that can design and produce all the essential EV technologies in-house—batteries, electric motors, and electronic control systems and charging facilities—and it has the capacity to coordinate investments and innovate across the entire EV value chain.<sup>10</sup>

In 2015, BYD opened its first Latin American factory in Campinas, Brazil, mostly to avoid import tariffs both in Brazil and across much of the Latin America region, which allowed the company to introduce some of the first all-electric buses to the Brazilian and regional markets. The Campinas factory manufactures and assembles long-range electric buses as well as iron phosphate battery packs. It began production in 2018, coinciding with the launch of a new electric bus model.<sup>11</sup> BYD plans to gradually increase the share of local technology used in production from less than 50 percent to 70 percent by 2022. In addition, BYD opened a new electric bus production facility in the U.S. state of California in October 2017, and it has decided to relocate its European electric bus production from China to plants in Hungary and France.

## Tesla: From vision to reality

Tesla is one of the most inspiring examples of American entrepreneurship in the past 20 years. Founded by two Silicon Valley engineers, Martin Eberhard and Marc Tarpenning, the firm is named after the 19th-century scientist Nikola Tesla, who invented the induction motor and alternating current power transmission that make the EV industry possible. Shortly after Tesla Motors was incorporated in July 2003, Elon Musk became Chairman of Tesla's Board of Directors and was tasked with overseeing all aspects of the design and manufacturing of EVs and battery products. Musk, a visionary innovator and entrepreneur, identified strongly with Tesla's mission to "accelerate the world's transition to a sustainable energy future" by producing affordable, mass-market EVs and battery products.<sup>12</sup> The company soon became a major player in the EV industry.

In 2008, Tesla unveiled the Roadster, a two-seater electric sports car that was immediately successful despite its extremely high price tag. The Roadster was six times more efficient than conventional cars and produced just 1/10th of the pollution. It was also the first car to use lithium-ion batteries. In 2012, Tesla released the Model S, a seven-seater EV with an operational range of 208–265 miles that could compete in the premium sedan category. The Model S was named Motor Trend's Car of the Year, underscoring its ability to compete with conventional vehicles.

Tesla introduced several innovations that contributed to build its image as a "disruptive" firm.

- **Seeking alliances and partnerships to overcome the lack of automotive expertise.** To develop the Roadster's concept, Tesla held an international design competition—won by Lotus, a well-known sports car company. Tesla used existing conventional automotive technology developed by Lotus to complement its EV-specific innovations (the power train and batteries). Moreover, it was also able to use the Lotus plant in the United Kingdom to fit the production of Tesla Roadsters. In 2010, Tesla collaborated with Toyota to develop a second-generation sport utility vehicle under the Toyota Motors brand. Tesla provided the power train, software, and battery technologies; Toyota built the remainder of the vehicle. The partnership allowed Tesla to have access to a new production plant and to learn from Toyota's engineering and production systems, helping Tesla reduce production costs and build its automotive expertise.
- **Innovating on battery technology.** Soon after the release of the Roadster, Tesla partnered with Panasonic to improve its battery technology. Tesla's goal was to increase the maximum range of its vehicles while reducing their overall cost. Panasonic invested US\$30 million in Tesla, and that investment helped the company meet its margins and cost targets. In 2011, the two companies again joined forces to develop a new generation of nickel-based battery cells that were later incorporated in the Tesla Model S. Later, the company developed a battery cell capable of holding 31 percent more energy than the original Roadster cell, but in the same size and at a lower cost.
- **Multipling charging stations.** In 2012, Tesla established its first six "supercharger" stations in California. By 2015, Tesla had installed 2,000 superchargers in almost 400 stations in Asia, Australia, Europe, and North America.

- **Direct sales and no advertisements.** Tesla does not advertise or sell its cars through traditional dealers. Instead, it sells directly to consumers through its website and offers test drives at dedicated Tesla Stores.
- **Making patents available to all.** Tesla launched a most remarkable initiative in 2014, the opening of all its patents, including those for batteries and power trains. This decision reflected Tesla's vision as much as its commercial ambitions. Tesla initially regarded patents as a necessary defense against the risk that other car companies would copy its technology and reproduce it on a mass scale. By 2014 it had become apparent that this was not happening: global EV output remained marginal, representing only about 1 percent of total vehicle sales. To realize its vision of an environmentally sustainable global auto industry, Tesla decided to disclose all its patents. This decision was based on the idea that firms should share their technologies and explore new approaches to intellectual property management, spinoffs, licensing, and other methods that may enable companies to better absorb external ideas (Chesbrough 2003). Tesla was convinced that the shift from conventional vehicles to EVs, would not occur simply through isolated experiments. A real transition would require a comprehensive ecosystem supported by close collaboration between battery producers, automotive manufacturers, providers of charging infrastructure, and software developers.

Starting in 2008, Tesla, although innovative and successful, faced serious financial challenges. Elon Musk used a combination of his own wealth, venture capital, bank and government loans, investments by other automakers, and the U.S. stock and debt markets to transform Tesla's vision into a reality. The company struggled to reduce the price of its EVs and capture a larger share of the consumer market. Despite serious production challenges and continuing financial problems, however, Tesla has repeatedly outperformed traditional car companies in the stock market.

## CONCLUSIONS

This chapter has discussed some examples of LCT transfer and innovation in a small number of emerging economies, which account for a large fraction of existing LCT deployment. The chapter finds that emerging countries are rapidly deploying LCTs, innovating on the transferred technologies, and introducing new institutional changes that challenge the use of conventional technologies. China stands out as having made the fastest progress in LCT deployment, innovation, and production. Given its large size, China has a key role in contributing to the global transition to low-carbon, more sustainable patterns of development.

China's experience with acquiring technology through joint ventures was critical to its early industrialization, but in recent years that practice has yielded increasingly mixed results. In an industry marked by rapid technological upgrading, joint ventures can discourage foreign parent companies from transferring the latest technologies, and can also create a disincentive for domestic firms to invest in R&D. The relative lack of interest among foreign automobile companies in developing the EV market gave Chinese firms, such as BYD, space to grow.

China succeeded in the EV market because of its ability to learn from mistakes, make adjustments, and move forward. The first pilots were marked by several difficulties that made it impossible to attain the government's objectives. Thus, the policy targets were changed, the industry revised its strategies, and it eventually succeeded in producing cheaper and better-designed EV models—to meet domestic preferences. Although subsidies to promote EV sales were initially expensive and untargeted, they were essential for the industry to take off. The industry is now sufficiently strong to survive the upcoming replacement of most subsidies with targeted regulatory initiatives.

Finally, the contrasting but equally successful experience of two EV companies, BYD in China and Tesla in the United States, provides some insights into different evolutions of the world EV industry. Both companies are led by visionary innovators but differ in their strategies and in their vision on how the global market should develop. Although BYD is the more successful firm—in terms of EV sales—Tesla's most important contribution to the future may be its “open innovation” approach to IPR. Allowing competitors to benefit from a firm's innovations may offer a way for the EV industry to rapidly take hold and develop.

## NOTES

1. Appendix D describes how Korea became a global leader in the rapidly growing market for energy storage systems.
2. The Norwegian success story is first and foremost due to a substantial package of incentives developed to promote zero-emission vehicles into the market. Subsidies have included the following: no purchase/import taxes (1990–), exemption from 25 percent value added tax on purchase (2001–20), no annual road tax (1996–), no charges on toll roads or ferries (1997–2017), and a maximum charge of 50 percent of the total amount on ferry fares and on toll roads for EVs (2018–). The government has recently decided that after 2021 the incentives will be revised and adjusted parallel with market development.
3. The model provides a framework for understanding competitive advantage at the national and firm levels (Porter 1990). The four points of the “diamond” represent the determinants of comparative economic advantage: (i) factor endowment, which includes the natural resources, skilled labor, technology, and infrastructure necessary to compete in a given industry; (ii) demand conditions, which influence the quantity of a good or service that will be purchased at different price points; (iii) the presence of related industries, which generate complementarities and facilitate the development of economies of agglomeration; and (iv) firm strategy and market competition, which reflect how firms are created, organized, and managed, as well as the structure and contestability of a given market. In addition to these four factors, government policies and idiosyncratic shocks can significantly affect competitive advantage among firms and industries.
4. The 863 program was launched in 1986 to accelerate the development of high-tech industry and R&D capacity through three successive Five-Year Plans, with the goal of promoting domestic innovation and enhancing China's international competitiveness.
5. The pilot was expanded to 24 cities; however, by 2012 the total number of EVs introduced each year in those 24 cities had reached just 10,000.
6. EV subsidies are directly allocated to manufacturers, and consumers pay the retail price minus the subsidies. In 2010, a subsidy ranging from US\$635 to US\$7,941 was available for each PHEV purchased, and a subsidy of US\$9,530 was available for each BEV. The subsidies covered about 40–60 percent of the costs of EVs. When the subsidy program expired in 2012, the central government took six months to renew it. In 2013, the subsidies for each PHEV were adjusted to US\$5,600 and subsidies for each BEV ranged from US\$5,600 to US\$9,530 depending on a vehicle's driving range. The subsidies decreased by 5 percent in 2014 and by 10 percent in 2015 according to the 2013 standard. The subsidy program was renewed again in 2016—up to US\$8,736 for each BEV and up to US\$4,765 for each PHEV.



- It decreased by 20 percent in 2017 and 2018 according to the 2016 standard, and by 40 percent in 2019 (Lu 2018).
7. Tariffs on imported vehicles ranged from 180 to 220 percent through 1994 and from 70 to 150 percent through 2001 before dropping to 30 percent through 2005 and 25 percent thereafter.
  8. Howell (2018) and Gallagher (2006) also find that the joint venture model has had an adverse effect on domestic innovation capacity in the automotive sector.
  9. “Dual mode” indicates that a vehicle can switch from fully electric to gasoline power.
  10. BYD also produces a comprehensive range of solar energy technologies. BYD plans to open its first overseas solar energy R&D center in Brazil, as a partnership with the State University of Campinas. BYD aims to become the first company in Brazil to offer a comprehensive zero-emissions energy system that integrates solar generation, storage, and transportation technology.
  11. The new model was designed in partnership with Brazilian bus and coach manufacturer Marcopolo and uses a BYD rolling chassis with a Marcopolo Torino body. The partnership with Marcopolo allows BYD to contribute its strongest technologies—the power train and batteries produced by the Campinas factory—without needing to build the local production capacity necessary to create an entire vehicle.

# 5 Policies to Support Low-Carbon Technology Transfer

## INTRODUCTION

The aim of this chapter—the last of the report—is to provide actionable advice to policy makers seeking to transfer low-carbon technologies (LCTs), either inward through import and diffusion or outward through innovation, production, and export. As previous chapters have shown, addressing climate change creates an urgent need for LCT transfer, but economic transformations take time, especially in energy (chapter 1). Meanwhile, the LCT transfer process (proxied for by trade, patents, and foreign direct investment [FDI]) is at present dominated by developed and a few developing countries, but it has seen some progress (chapters 2 and 3). Although experiences among countries remain unique and context-specific, there is much to learn from the few countries that have successfully leveraged industrial and innovation policies<sup>1</sup> to take advantage of the emerging global value chain for LCT (chapter 4). Taking these findings forward, this chapter seeks to provide answers to the question of how developing countries can deploy LCTs at scale while capturing parts of the growing global value chain in LCTs.

The first section of the chapter discusses LCT in the context of the need for large-scale deployment to mitigate climate change while meeting growing energy demand. Next, the chapter presents deployment itself as a potential opportunity for economies seeking export-led growth to become LCT producers and exporters. The third section discusses the critical roles of human capital and state capacity to deploy and develop LCTs, which are unevenly distributed among developing countries. The fourth section introduces policies, practices, and procedures for LCT deployment and production, outlining the need for optimal policy mixes to be tailored according to objectives (LCT deployment versus LCT production) and context (for example, state capacity, income levels, market size, and policy feasibility). Next, recommendations are provided to policy makers and their supporters. The sixth and final section summarizes and concludes the chapter.

## NECESSITY OF LCT TRANSFER

Achieving the Paris Agreement’s objectives of limiting climate change to 1.5°C or below 2°C entails Herculean efforts in the coming decades. The so-called carbon law provides a road map toward global decarbonization, requiring that global greenhouse gas (GHG) emissions be halved every decade from 2020 onward (Rockström et al. 2017). This level of reduction requires a fundamental transformation of many human systems, particularly those related to energy. It would entail massive changes in fuels (renewables versus nonrenewables) and technologies (low versus high carbon), alongside “different infrastructure, urban planning, consumer products, consumption patterns, built environments, business models, professional training programs, investments and policies” (IEA and IRENA 2017).

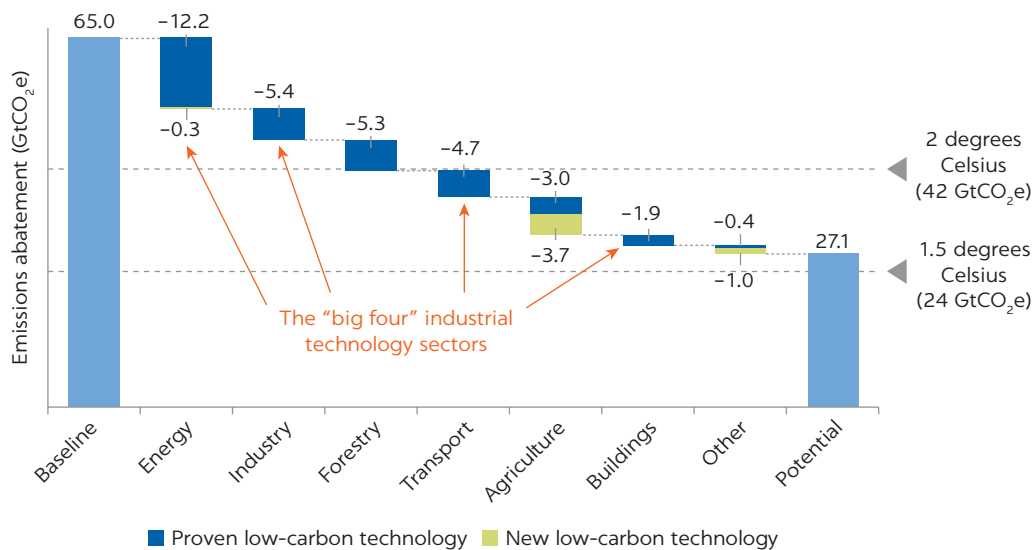
Given the scale of the LCT deployment implied by such a radical transformation, however, skepticism is warranted. Energy transitions, for example, tend to be complex and unpredictable processes (chapter 1). These transitions appear to have “no magic formula” and tend to be “path-dependent, rather than revolutionary, cumulative rather than fully substitutive” (Sovacool 2016). For example, very low-tech forms of energy (animal, wood, and steam power) remain prevalent throughout the world, not having been fully replaced by fossil, nuclear, or renewable energy (RE) sources.

Current trends give a mixed picture as to whether the energy transition can be achieved at the scale needed. For example, on the energy supply side, this transition requires additional installed RE capacity of about 300 gigawatts (GW) each year to 2030, but in 2018 only 180 GW were added. On the energy demand side, investments in energy efficiency have slowed (IEA 2019). Across both demand and supply sides, private incentives and public policies are sending mixed signals: “current market and policy signals are not incentivizing the major reallocation of capital to low-carbon power and efficiency that would align with a sustainable energy future” (IEA 2019).

In addition, the specific technologies likely to be needed for achieving the 1.5°C or below 2°C target—for example, carbon removal and sequestration of GHGs from the atmosphere—remain unproven, and presently receive insufficient investment. These technologies have relatively little scholarship and knowledge production, let alone commercial applications, to support them (UNEP 2017). As a result, many of the emissions pathways prevalent in policy analysis (for example, three of the four “illustrative model pathways” in IPCC 2018) rely on a series of as-yet unproven technologies.

Despite the scale of the challenge in narrowing the gap between existing and needed LCT deployment and policies for a global low-carbon transition, there are grounds for optimism. First, achieving most of the emissions reductions needed is feasible through the rapid diffusion of *existing* technologies (figure 5.1). UNEP (2017) states that maintaining more than a 66 percent chance of containing global warming to 1.5°C requires that annual global GHG emissions not exceed 24 gigatons by 2030.<sup>2</sup> Without new mitigation policies, emissions are expected to rise to about 65 gigatons of CO<sub>2</sub> equivalent (GtCO<sub>2</sub>e) in 2030, implying a gap of roughly 41 GtCO<sub>2</sub>e. These figures are stark: the gap to 1.5°C is larger than current annual global emissions of CO<sub>2</sub>, which were 36 gigatons in 2016 (UNEP 2017).<sup>3</sup> Most of these emissions reductions, however, can be achieved by globally deploying commercially proven LCTs. In four major sectors alone—energy, industry, transport, and buildings—deployment of existing LCTs can narrow the gap by almost two-thirds (24 GtCO<sub>2</sub>e in 2030).

A rapid global deployment of existing technologies to mitigate climate change does entail structural changes that will require a dramatic increase in the supply of capital, intermediate, and consumption goods. These goods include RE capital equipment, electric vehicles, and energy-efficient building components and appliances (figure 5.2), in addition to the various support services needed to build and maintain them. For policy makers who believe in strategically targeting sectors for economic development objectives (for example, via industrial or innovation policies)<sup>4</sup> and who believe mass deployment of LCTs to be likely, this represents a massive opportunity.

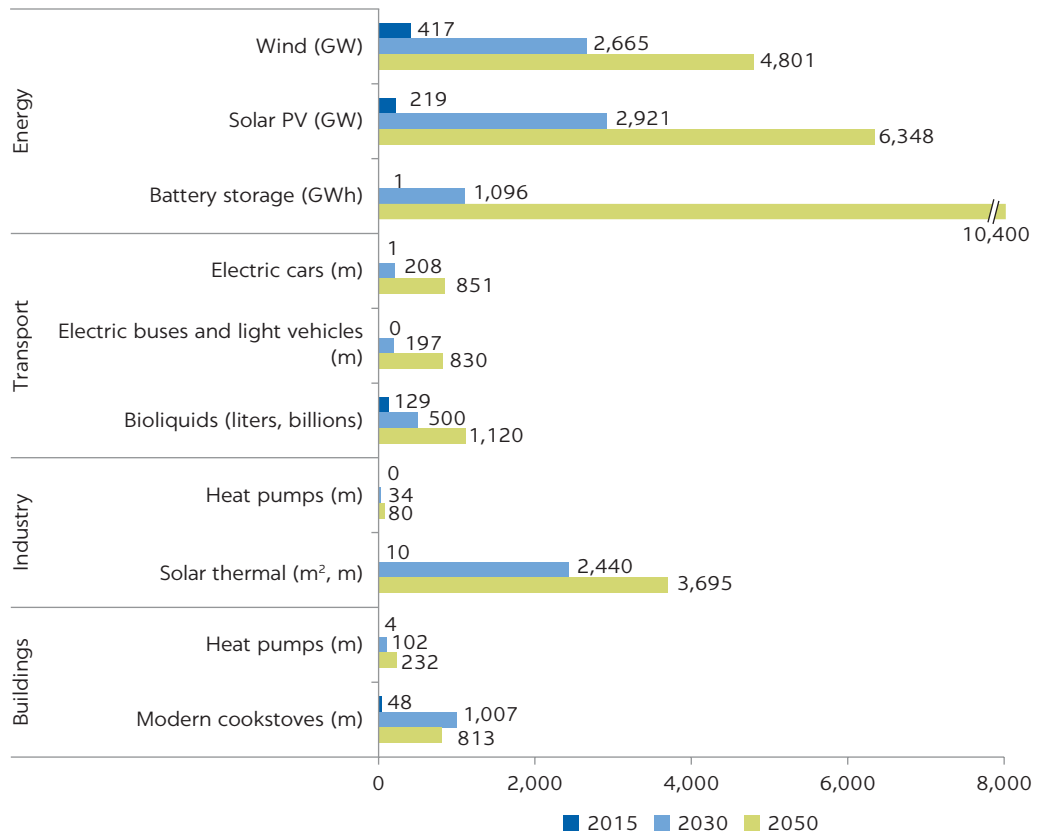
A second reason for optimism is that, despite the unprecedented nature of the transition challenge, some LCTs are already progressing rapidly in terms of cost, deployment time, and scale, in addition to the steady increase in transfers of LCTs across borders (chapter 2). The costs to install RE, for example, have declined precipitously in recent years (IEA 2019). Between 2010 and 2018, costs per GW of installed capacity declined for utility solar photovoltaic (by 78 percent), energy storage (54 percent), onshore wind (22 percent), and offshore wind (8 percent). Gross investment in renewables has stalled, but mostly because of this cost decline. Adjusted for prices, annual investment in renewables rose by 55 percent between 2013 and 2018 (figure 5.3 and figure 5.4).

Meanwhile, the average time taken to install 1 GW of RE declined by more than a quarter: from 2.6 years in 2013 to 1.9 years in 2018. Battery manufacturing capacity is surging, and is expected to reach 400 GW capacity by the mid-2020s, up from a 2018 level of 70 GW (IEA 2019). Heat pump sales are growing steadily, by 10 percent annually and as a share of global building heating equipment (currently 2.5 percent).

A third positive sign is the increasing amount of investment globally in LCT research and development (R&D), including in sectors where emissions are

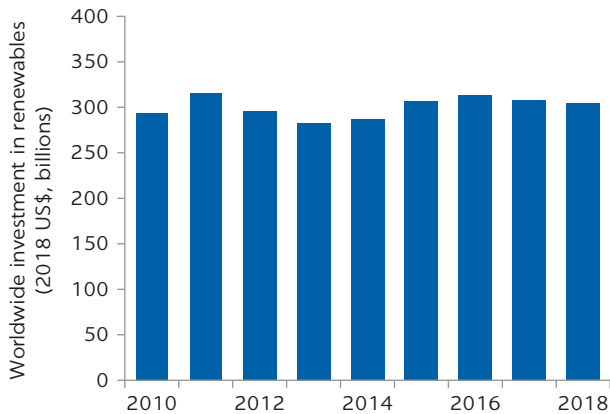
**A rapid increase in the global stock of low-carbon capital goods is needed by 2030 and 2050**

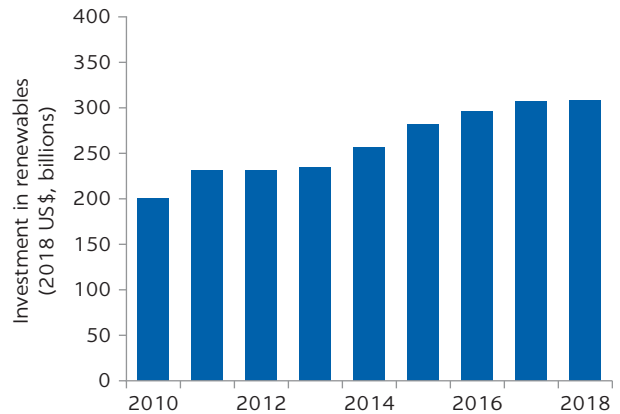
**Renewables investment has remained stable at about US\$300 billion a year**

difficult to abate (transport) or have the potential to be transformational (storage). For venture capital, 2018 was a record year for investments in clean energy companies, with US\$6.9 billion worth of deals, up from a US\$2.7 billion average for 2007–11. The bulk of this increase was in transportation—one of the most difficult technologies for which to abate emissions. In addition, investment in energy storage has surged, rising 55 percent to reach US\$4 billion in 2018. In these two sectors, companies with complementary inputs are increasingly joining forces.

Overall, the scale of the challenge of mass global deployment of LCTs should not be understated. It remains far from clear whether the “techno-optimistic” or “techno-pessimistic” view of technology’s role in mitigating climate change will turn out to be accurate. Despite these challenges and uncertainties, however, the proven nature of many existing LCTs, along with positive trends in certain technologies, means there is significant space for policy to support LCTs, thereby making a global low-carbon transition more likely.

### **Opportunity of LCT transfer**

The global transfer—and deployment—of LCTs is not only a necessity but also an opportunity, on three fronts. First, the policies needed to deploy LCTs could also raise output, employment, innovation, and firm competitiveness. Traditionally, economic analyses have portrayed climate change as a global commons problem, with diffuse benefits of reduced climate damages and concentrated costs from mitigation policies; however, developments in the literature—some recent, others long running—have questioned this logic.<sup>5</sup> Overall, when designed and implemented well, the same policies that induce firms to deploy LCTs could also be good for the economy. This thinking inverts the notion of a necessary trade-off between climate and economic objectives: by embarking on reforms designed to foster LCT transfer, countries can also raise output, employment, innovation, and even firm competitiveness.

Second, many policies that aim to accelerate the deployment of LCTs have other welfare benefits, also known as “development co-benefits.” GHG abatement policies tend to also reduce local air and water pollution, providing substantial benefits to human health (Vandyck et al. 2018; West et al. 2013).<sup>6</sup> In addition, when motor fuel prices align more with their social optimum (for example through a carbon tax), costly road accidents and congestion tend to decline (Burke and Nishitateno 2015; Burke and Teame 2018; Chi et al. 2013; Parry, Walls, and Harrington 2007; Santos 2017; Santos et al. 2010). Reductions in fossil fuel consumption can provide a boon for fossil fuel-dependent countries, helping support energy security objectives and shielding economies from fluctuations in global oil prices (IEA 2014; Krupnick, Burtraw, and Markandya 2000; OECD 2000).

Third and finally, global deployment of LCTs offers an opportunity for the increasingly large number of countries seeking export-led growth. LCTs could themselves be a strategic sector, for two reasons: they tend to be relatively sophisticated (as noted in chapter 1, they have specific characteristics, including a higher level of complexity and sophistication, compared with high-carbon technologies); and LCTs offer potential for huge growth in deployment globally, and therefore in trade.

Many economists argue that the theoretical justification remains for active intervention in response to technology market failures (Rodrik 2008; Stiglitz 2010, 2018), that no country has developed without such measures (Yülek 2018),

and that many if not most of the transformational technologies have involved the state's proactive use of its own resources to support specific sectors (Mazzucato 2015). Old industrial policies emphasized import-substitution measures that—it is argued—hindered competition, dampened market signals, involved little active encouragement for technological innovation, and incentivized corruption and cronyism. By contrast, new industrial policies emphasize export-orientation, incorporating clear, quantifiable goals for investment in sophisticated (or complex) industries (Hausmann et al. 2014; Yülek 2018), strong incentives for steady improvement through competition, and investment in complementary infrastructure to help firms achieve the needed scale economies (Cherif and Hasanov 2019).

For LCT, a burgeoning literature addresses “green industrial policies” (Altenberg and Assmann 2017). Using a specific set of policies, especially those involving carbon pricing, governments can help shift economic structure toward low-carbon models. These policies include sunset green industrial policies, which support the deployment and production of LCTs, alongside complementary sunset policies that support those negatively affected by a low-carbon transition (Hallegatte, Fay, and Vogt-Schilb 2013). This could require a mission-driven and entrepreneurial state, making strategic investments in key green technologies (Mazzucato 2016; Mazzucato and Semieniuk 2016).

Despite increasing discussions in the literature, evidence remains patchy on which types of industrial policies (including green policies) are most effective. While technology market failures remain, so too do governmental failures. “Directed technical change” (Acemoglu 2002), including toward environmentally friendly technologies (Acemoglu et al. 2009), is possible but potentially difficult. Developing countries cannot simply “import” the needed strategic plans from donor agencies, and doing so could even backfire.<sup>7</sup> Governments should therefore choose for themselves whether to adopt green industrial policies to deploy or produce LCTs, remaining cognizant of the risks of action (through the mismanagement of rents and perverse incentives generated) as well as the opportunity costs of inaction (through missing an opportunity for export-led growth; refer to the section titled “Government objectives” later in this chapter).

## NATIONAL CAPABILITY FOR LCT TRANSFER

Having shown the necessity and opportunity for LCT transfer, the chapter turns to developing a typology of LCT transfer and defines and tests which capabilities are needed by countries for importing, diffusing, producing, and finally exporting foreign technologies, including LCTs. Specifically, this section proposes a typology for defining the varying stages of technology transfer (for all technologies), identifies the potential inputs needed for countries to achieve deeper and more complex levels of LCT transfer, and tests empirically whether these proposed inputs are predictive of LCT imports, deployment, and exports across and within countries.

### What are the stages of technology transfer?

As previous chapters have discussed, it is not enough to simply import a given technology; technology has not been “transferred” until it is widely used and

understood by domestic firms and households (domestic diffusion). In addition, technologies themselves are seldom homogeneous or static: they vary over time with subsequent innovation, including in the importing country. From the perspective of importing countries, the type or quality of transfer matters. Technology transfer can be deemed as occurring along a scale, with stages ranging from initial adoption through indigenous invention and production of the improved or altered technology.

These stages of technology transfer, going from import to domestic production with potential export, are hereafter referred to as the *technology-transfer staircase* (figure 5.5). The staircase ranges from early stages of technology import (adoption and domestic diffusion) to domestic production (imitation, collaborative innovation with foreign firms, or fully indigenous invention) with the possibility for subsequent export. Under this framework, a country that has climbed to a higher step can be said to have transferred the foreign technology more.

Each step has differences in origin and strategy for obtaining the technology, as well as control and ownership of any subsequent innovation on top of that technology (table 5.1). Adoption and domestic diffusion mean reliance on foreign sources of the technology with no control over any subsequent innovation process or ownership of that process's output. By contrast, collaborative innovation between domestic and foreign firms (for example, through joint ventures or other collaborative arrangements) may confer some control and ownership over subsequent innovation outputs.

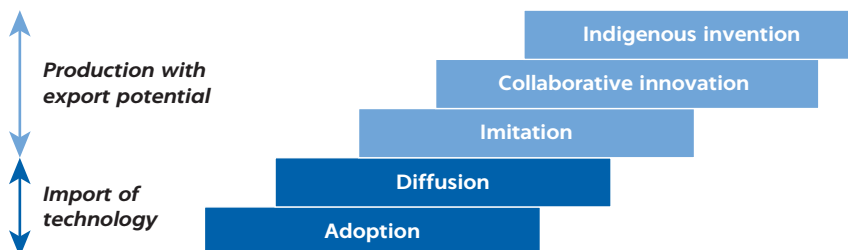
### Why climb?

Countries can “climb the staircase” through deeper levels of diffusion of foreign technology, increasing levels of domestic production, or increasing sophistication of domestic innovation. For developing countries, this climb can be desirable for the following reasons:

- **Entering the technology-transfer staircase through the *adoption and diffusion of foreign technology* can confer large economic benefits.** For all countries, generating technologies internally can be significantly more costly than simply importing those technologies. As a result, the importation of foreign technologies can confer significant domestic cost savings and

productivity benefits. This possibility represents a positive externality “of truly historic proportions,” allowing countries to pursue a process of “Schumpeterian catch-up” (Cirera and Maloney 2017).

- **Climbing to higher steps through *domestic technology production* entails deeper levels of industrialization, which is strongly linked to economic development.** Industrialization—defined here as rapid growth in the manufacturing sector—can help accelerate productivity growth, and therefore economic growth. For instance, for countries that have outperformed others in the past three decades, more than two-thirds of their gross domestic product (GDP) growth is “attributable to a rise in productivity correlated with industrialization: an annual average productivity gain of 4.1 percent versus 0.8 percent for the other developing economies” (McKinsey Global Institute 2018). As some have observed, all developed countries have gone through a stage of rapid productivity growth driven principally by the manufacturing sector (Mazzucato 2015; Yülek 2018).
- **Climbing to the final steps through *increasingly sophisticated levels of indigenous innovation* confers multiple benefits to domestic firms and workers.** The production structures of industries vary widely, as does the value added by firms nested along value chains. Generally, firms closer to the innovative parts of the value chain (that is, on higher steps of the technology-transfer staircase) receive higher returns, which allows them to invest in more innovation (Yülek 2018). Increasing levels of sophistication in innovation require deeper levels of skills and knowledge among firms and workers, which entail deeper stocks of organizational and human capital. These deeper stocks help support higher levels of income and nonincome welfare gains.

In short, climbing the technology-transfer staircase can help countries achieve sustainable, low-carbon development. Climbing the staircase means getting closer to the technological frontier, catching up through the diffusion of foreign technologies, and reaping the benefits of productivity growth from increasing levels of domestic production and sophistication of innovation outputs.<sup>8</sup> For LCT in particular, the global deployment of LCTs may provide an unparalleled opportunity for countries to climb the staircase rapidly through domestic deployment and production for export (see the earlier section titled “Opportunity of LCT transfer”).

## Will countries climb?

Climbing the staircase is neither inevitable nor necessarily a linear process. Multiple market failures mean that firms and households in many developing countries do not adopt widely available technologies, despite the potentially large gains from doing so (the “innovation paradox”; refer to Cirera and Maloney 2017). For LCT, other market failures may lead to low diffusion, whether from foreign or domestic sources, and any diffusion tends to be spatially heterogeneous. For example, firms and households may have imperfect information about potential energy saving investments, and may underinvest in energy efficiency measures, despite the potential for large savings—a phenomenon known as the “energy efficiency paradox” (Allcott and Greenstone 2012; Häckel, Pfosser, and Tränkler 2017; Jaffe and Adam 1994). In addition, when energy efficiency technologies are diffused, their spatial distribution within countries is nonuniform, reflecting heterogeneous socioeconomic, contextual, and local policy conditions (Morton, Wilson, and Anable 2018).

Similarly, there is no guarantee that domestic firms and workers will innovate on top of the technology they have imported. As previous chapters have mentioned, the literature debates the quality and quantity of technological spillovers from trade and FDI. A firm importing technology—or even producing and exporting that technology—through FDI may not have any ownership or control over it or any subsequent innovation process, and low knowledge spillovers (for instance due to all workers being from the technology source country) could result in only few firms and workers benefitting from the imported technology.

## How can countries climb?

Importing, producing, and innovating technology rely on a complementary set of inputs, such as human, physical, and organizational capital. The absence of these inputs can more than offset the gains from Schumpeterian catch-up, which may explain why so many developing countries underinvest in importing and diffusing foreign technologies, despite the potential gains (Cirera and Maloney 2017). Moreover, developing countries find it harder to climb. Without a sufficient level of these inputs, countries may not be able to catch up; but, perversely, countries with lower levels of these inputs may also be less able to implement measures to increase their inputs (the “innovation policy paradox”; Cirera and Maloney 2017).

The following complementary inputs are referred to as *national capability*:

- **Human capital (workers)** includes the quality of workers in terms of educational levels, health, and composition (such as age). Human capital can potentially be imported through migration, but the ability to attract highly skilled workers varies across countries, tending to be lower in developing countries.
- **Organizational capital (firms)** includes absorptive capacities as well as managerial skills among firms. It can be imported through FDI, though learning-by-doing spillovers from FDI vary.
- **Institutional capital (states)** includes the quality of governance institutions, such as the legal and policy-making framework and administrative effectiveness. This type of capital cannot be imported.

- **Physical capital (economies)** includes the quality of buildings and infrastructure (such as transport and energy reliability) as well as complementary infrastructure needed for LCT (for example, electric vehicle charging hubs). It can be imported via, for example, domestic and foreign construction firms, which is costly and takes time.
- **Financial capital (markets)** includes access to financial resources from domestic firms, and, in the case of innovation, the ability to access patient long-term capital. Access also varies by technology (risk levels and capital intensity). Financial capital can be imported through access to international private and public climate finance, though multiple nontechnological aspects may raise the costs of this external finance (for example, political risk and exchange rate risk).

Subsequent steps of the technology-transfer staircase require deeper and more complex levels of these complementary inputs (table 5.2). Firms and workers need a range of skills, from the most basic to the capacity to innovate and develop new products. States need to be more effective to help firms and workers become more technologically sophisticated, with deeper levels of complementary physical capital such as infrastructure required. Given the larger risks present at the earlier stages of innovation (the top of the staircase), more patient financial capital is required from investors and governments (Mazzucato 2015).

Presumably, the requirement for deeper levels of complementary inputs should be the case for LCTs, as it is for other technologies. Although LCTs have a set of defining features compared with other technologies (such as higher capital costs; refer to chapter 1), these features tend to imply that even deeper levels of inputs would be required to diffuse and produce LCTs. Few studies, however, have explicitly tested the link between such inputs and LCT diffusion and production.

## NATIONAL CAPABILITY MATTERS FOR LCT TRANSFER

To examine whether national capabilities are linked to deeper levels of LCT trade and deployment, the analysis tests in two stages. First, it operationalizes measures of the national capability and links them observationally to metrics of LCT transfer (import and export of LCT<sup>2</sup> per capita), as well as to general innovation outcomes. This stage allows for better identification of factors that matter *across* countries. Second, the analysis uses multivariate regression, with controls for country and year fixed effects, to identify what factors matter for rising to higher levels of the technology-transfer staircase (proxied through deeper levels of LCT trade and deployment) *within* countries over time.

National capabilities are operationalized using different proxies. Human capital is proxied for by either the World Bank's Human Capital Index, which compares countries on metrics of education and health, or the United Nations' Human Development Index, education subindex, which ranks countries by educational outcomes.<sup>10</sup> Organizational capital is proxied by the United Nations' Competitive Industrial Performance Index, which compares the competitive performance of domestic firms, particularly manufacturing firms, across countries.<sup>11</sup> Institutional capital is proxied for by the World Bank's Worldwide Governance Indicators Government Effectiveness index scores, which capture perceptions of the quality of public services, the civil service, the quality of policy formulation and implementation, and the credibility of the government's commitment to such policies.<sup>12</sup> Physical capital uses productive capital per capita (which includes physical capital such as infrastructure and buildings) from the World Bank's Changing Wealth of Nations dataset (Lange, Wodon, and Carey 2018). Last, the depth of financial capital is proxied by domestic credit to the private sector as a percentage of GDP.<sup>13</sup>

The extent to which countries diffuse and produce LCT is proxied using different measures (table 5.3). LCT trade intensity (imports and exports of LCT per capita) provides some evidence as to how much LCT is being transferred to that country (via imports) as well as produced by that country (exports). Similarly, domestic RE deployment (installed renewable capacity per capita) should also give some supportive evidence as to domestic LCT deployment.

Finally, the potential for a country to innovate on top of existing LCT should depend on its ability to innovate generally, and hence innovation outputs (the Global Innovation Index–Innovation Output subindex scores) are also examined across countries.

### **Across countries: Exports, imports, and general innovation**

Across economies, national capability appears to matter for all stages of LCT transfer. Importing and operating technologies require some basic level of capability among firms and workers, and the environment they operate in. Accordingly, economies with higher institutional, organizational, and physical capital tend to import more LCTs (figure 5.6) though financial capital is not a strong predictor. Additionally, the same four factors are also strongly associated with exports of LCTs: economies with more human, institutional, organizational, and physical capital tend to export more LCTs (figure 5.7). Economies with more innovation also tend to have higher levels of these capital measures (figure 5.8), in addition to financial capital (figure 5.9).

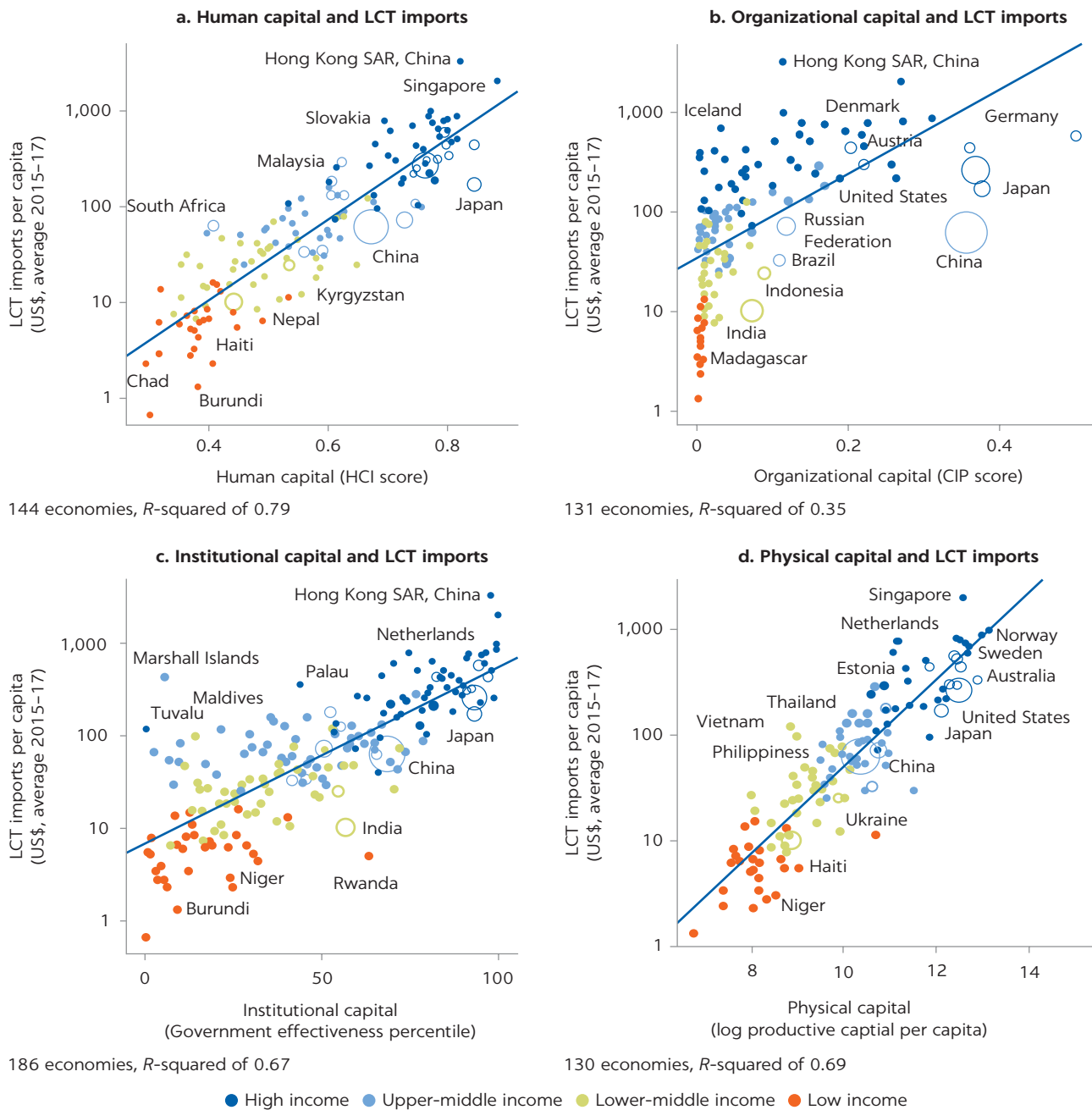
Five observations can be made. First, the different types of capital—human, organizational, institutional, and physical—appear to matter for both LCT trade and for innovation. These factors are heavily correlated with LCT exports, imports, and innovation performance. Combined into normalized scores, they can, for example, explain 87 percent of the variance in innovation outputs across countries (figure 5.10). This finding supports the idea that such complementary inputs matter for innovation.

Second, human capital emerges as the strongest predictor of LCT trade and innovation performance, although institutional capital and physical capital are also highly correlated with LCT trade and innovation. Organizational capital and financial capital appear to be the weakest predictors, which could perhaps indicate that firm-level knowledge and access to finance are less stringent constraints to climbing the technology-transfer staircase than skills of workers.

Third, developed economies have much more national capability (inputs), and tend to trade more LCTs and be more innovative (outputs). This finding is in line with other studies that have shown, for example, that economies with better institutions export more complex products (Berkowitz, Moenius, and Pistor 2003; Teza, Caraglio, and Stella 2018). As a result, although the global deployment of LCT could be an economic opportunity, it could also be the case that developed economies are best placed to take advantage of it.

Fourth, within developing economies, there is significant heterogeneity, with China emerging as a major outlier, both in terms of LCT exports and in innovation performance. This finding reemerges when considering another dimension of LCT trade: green complexity potential (GCP) of exports (Mealy and Teytelboym 2018). Broadly, GCP measures how close an economy's exports are to other green (that is, low-carbon) goods. An economy with high GCP and high performance in innovation should theoretically be well placed to take advantage of the global deployment of LCT. China emerges as a major outlier (figure 5.11) among developing economies, in having both green complex exports and high innovation performance. India, Malaysia, Thailand, Turkey, and Ukraine are also comparatively well placed, but they lag far behind China in terms of innovation performance or green complexity of exports.

**LCT import intensity across economies**

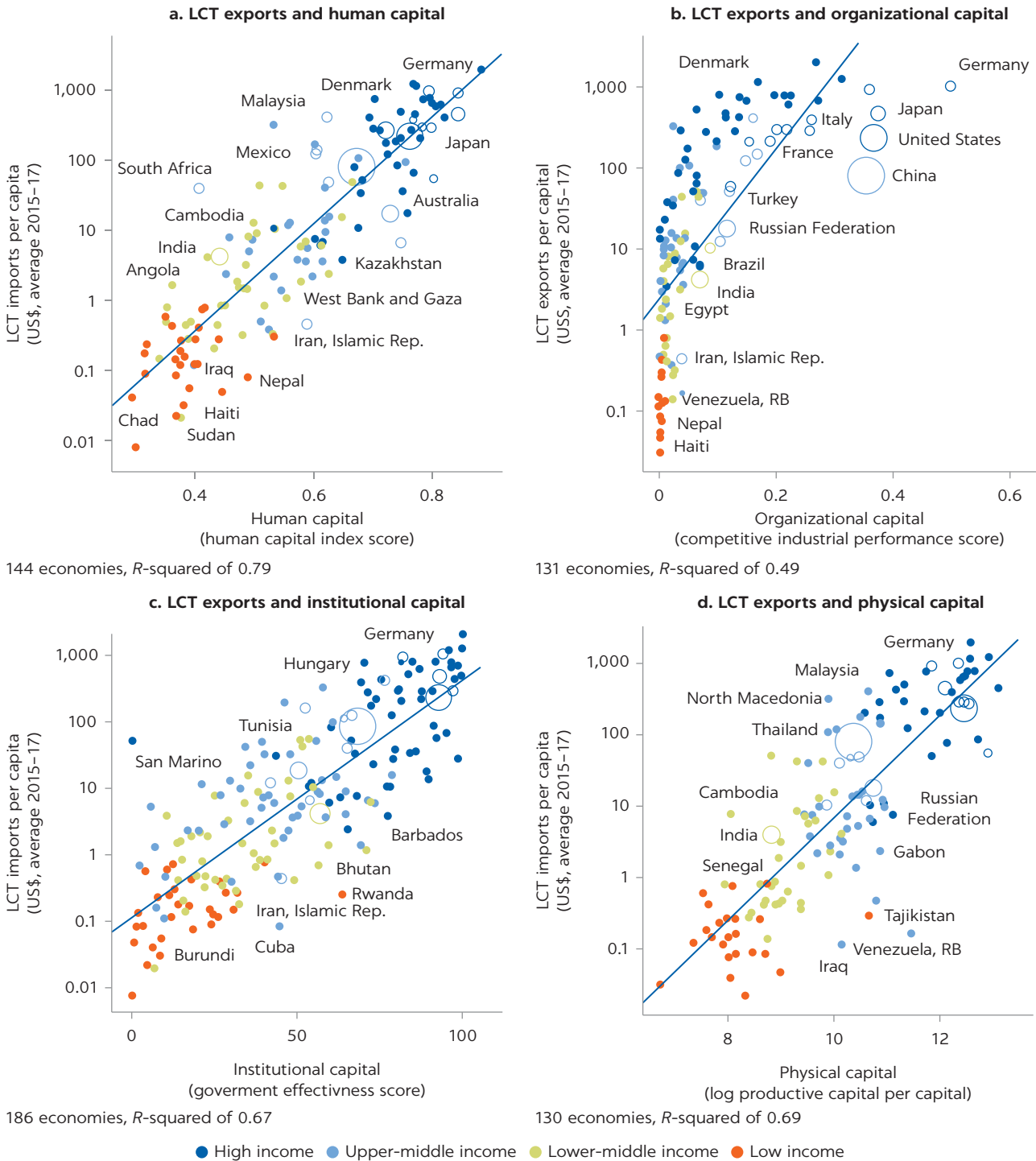

Fifth, despite being an outlier on LCT exports, China underperforms relative to what could be expected given its level of organizational capital (panel b in figure 5.7). The same is true in terms of China’s general innovation performance relative to its organizational capital (panel b in figure 5.8), though it outperforms relative to its human, institutional, and physical capital base. China is well placed to take further advantage of global deployment

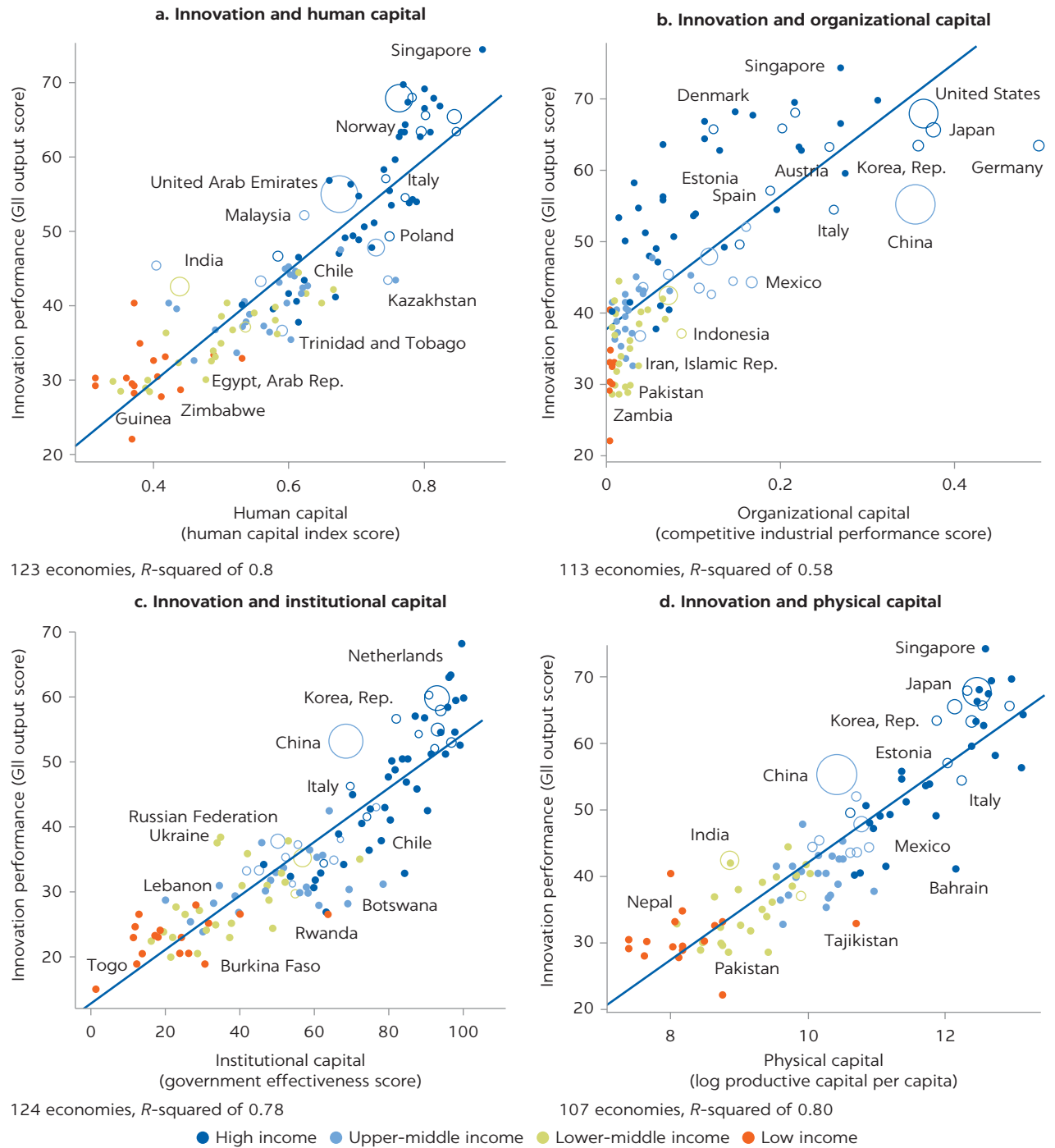
LCT export intensity across economies

**Innovation performance across economies**

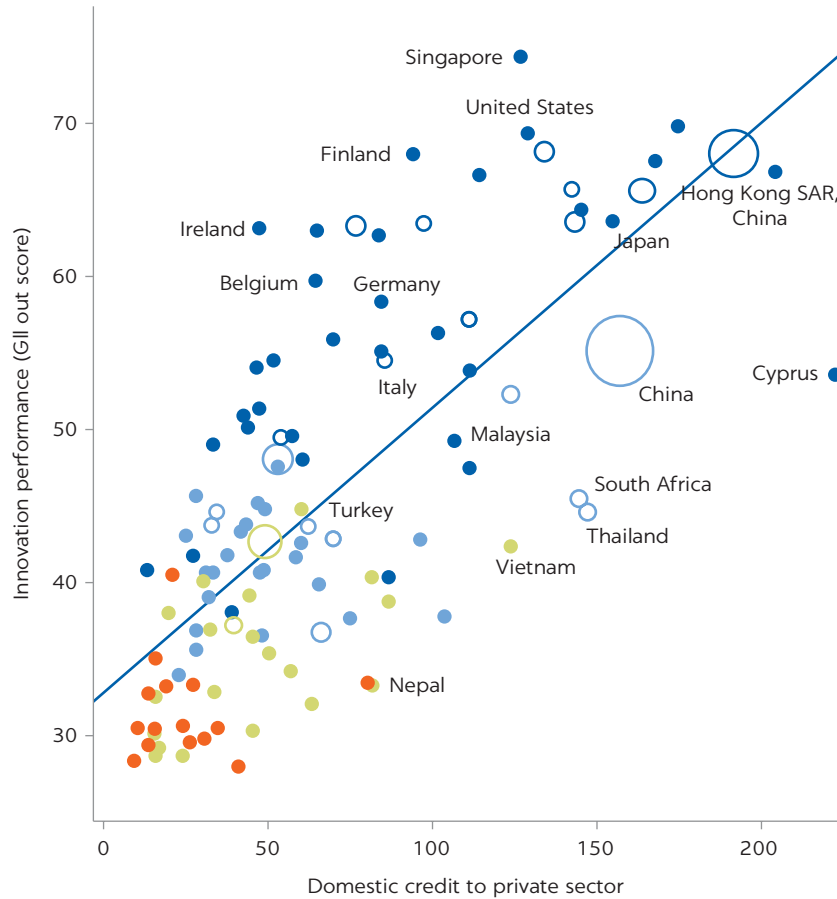

of LCTs, but other economies may have room to catch up through interventions to augment their capital base. Indeed, although China’s LCT exports continue to grow, other countries such as Mexico, Turkey, and Vietnam are also increasing their LCT export intensity (figure 5.12).

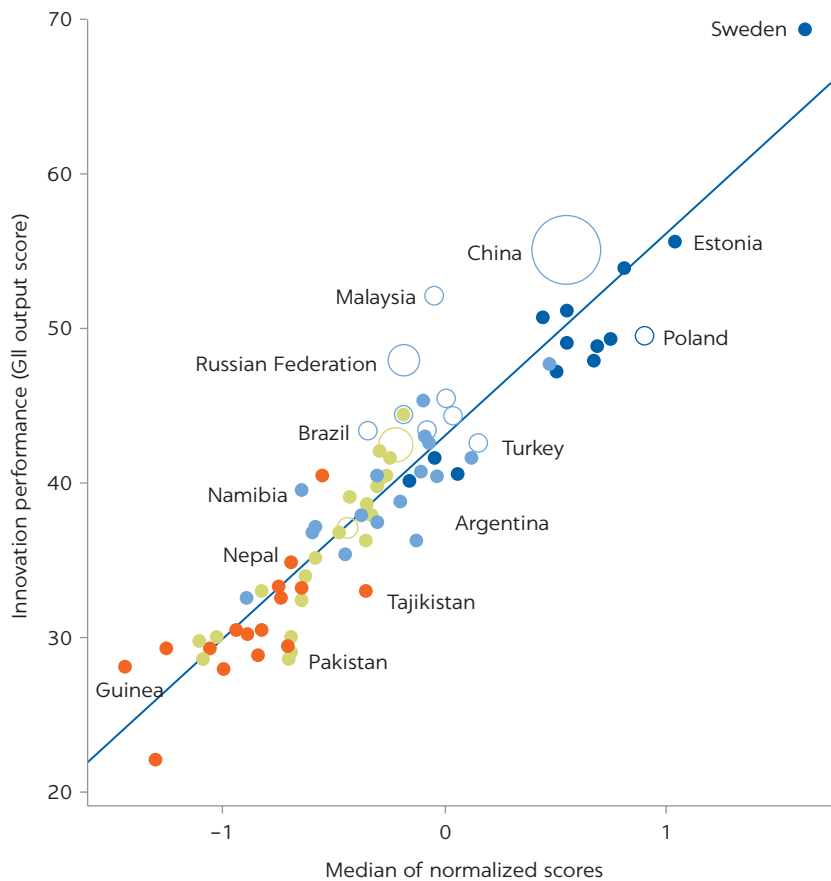
Observations across economies in one time period, however, are not sufficient for determining which type of capital matters most for increasing LCT trade intensity (as a proxy for LCT transfer) within economies. The next section therefore assesses which of the national capabilities matter most for changing LCT trade intensity within economies.

**Within countries across time: LCT trade**

Whereas the previous section identified factors that appear to matter across countries in one time period, this section analyzes the same factors within

● High income ● Upper-middle income ● Lower-middle income ● Low income

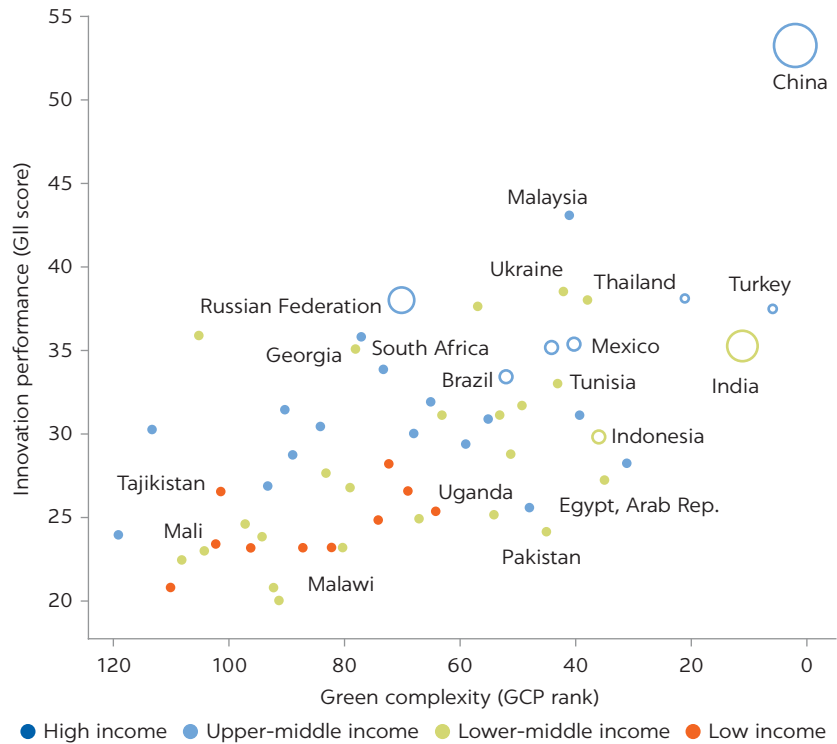

countries across several time periods. Using a panel dataset comprising 90,000 observations across countries, within-country analysis of the links between national capability and LCT transfer metrics is conducted through multivariate regression controlling for time and country fixed effects. This regression estimates the effect on measures of LCT trade depth from identified proxies for national capability (see table 5.4).

Taking this approach offers interpretive benefits. Fixed effects regressions (using the “within” estimator) control for unobserved, time-invariant heterogeneity across countries and years. As a result, interpretation can be made as to which national capability inputs matter most for LCT transfer within countries over time, with more assurance that unobserved (albeit, time-invariant) confounders have been controlled for (Imai and Kim 2019; Mummolo and

Note: Bubbles represent relative CO<sub>2</sub> emissions in 2014. GCP = green complexity potential; GII = Global Innovation Index.

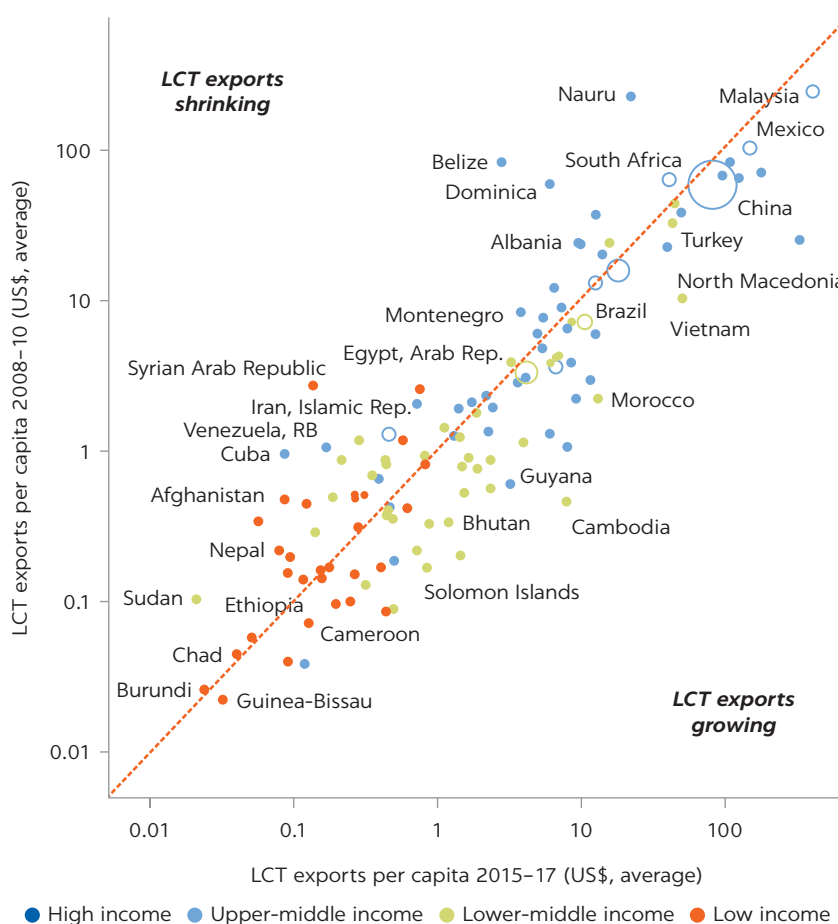
Peterson 2018). The downside of this approach is some loss in statistical power due to the limitation of variation within countries. Nonetheless, it still yields statistically significant results on the links between national capability and identified metrics for LCT transfer (table 5.5).

Six observations can be made about these results. First, for LCT transfer, economic growth matters, especially for exports. A 10 percent increase in GDP within a country is associated with about a 3 percent increase in LCT imports and a 9 percent increase in LCT exports (hereafter, unless otherwise stated, holding other factors constant). This finding reinforces the finding in chapter 3 that market size and economic growth matter for exports of LCT patents. One explanation could be that, for countries with a growing domestic market, LCT deployment and production objectives become complementary: having a larger domestic market makes it more likely that domestic firms can achieve scale economies needed to become competitive in producing LCT.

Second, human capital appears to be the most important factor for accelerating LCT transfer within countries. A 10 percent increase in human development (Human Development Index, education subindex) scores is associated with about a 6 percent increase in LCT imports and a 16 percent increase in LCT exports. This finding is robust to using alternative measures to proxy for human capital, such as the Human Capital Index scores. Human capital therefore appears to be among the most important factors in allowing countries to increasingly import, diffuse, and export LCT.

Third, the depth of physical capital stocks matters for LCT trade. A country growing its per capita stock of gross fixed capital by 10 percent can expect to increase imports of LCT by about 7 percent and exports by about 4 percent. This finding underpins the important role that infrastructure plays in the transfer of LCTs. Having a deeper base of productive capital may be an important precursor to importing LCTs that rely on preexisting infrastructure, such as electric vehicles that depend on the existence of available and reliable electricity. This same capital may also be needed by firms seeking to develop and export LCTs.<sup>14</sup> That the growth in LCT trade with respect to growth in capital is below unity may also indicate, however, that existing physical capital–deepening efforts are

not especially low-carbon at present. For a low-carbon transition to take place, countries need to increase the low-carbon intensity of existing efforts to deepen physical capital—that is, through policies aimed at accelerating the deployment of LCTs.

Fourth, organizational capital matters for LCT exports, but not necessarily for LCT imports. A country experiencing a 10 percent bump in competitive industrial performance can expect to export about 6 percent more LCT but to import only about 1 percent more LCT. This finding suggests that countries wanting to export more LCT should focus on improving their broad industrial competitiveness. The factors that matter for LCT exports appear to be the same factors that matter for industrial competitiveness generally.

Fifth, institutional capital (government effectiveness) does not appear to matter that much. Institutional capital is mildly positively associated with LCT exports but not with LCT imports. A country whose government becomes 10 percent more effective (in terms of Government Effectiveness Index scores) can expect to export about 2 percent more LCT. This effect is not nearly as strong as that of human capital. It does point, however, to the role that governments have in at least not preventing technology transfer through their own ineffectiveness—for instance, by allowing unchecked corruption to prevent firms from investing in new technologies or workers to invest in their own education. This role is in addition to their central role in proactively raising other forms of national capability, especially human capital.

Sixth, financial development does not have an important effect on LCT transfer. Domestic capital provided to firms is found to be statistically significant only for LCT imports, but the effect is very small: a 10-percentage-point increase of GDP in domestic credit to the private sector is associated with a 0.04 percent increase in LCT imports. Other studies also find that financial market deepening does not have a strong effect on RE deployment (Pfeiffer and Mulder 2013). To the extent that finance constrains LCT transfer, efforts to support specific climate finance<sup>45</sup> may be warranted; however, this suggests that the extent to which finance per se holds back LCT transfer may be overstated. For LCT transfer, raising core capabilities—such as education levels of workers and organizational effectiveness of firms—may be more effective at accelerating LCT diffusion and development than simply increasing access to finance. The most important policy question for accelerating LCT, therefore, may not be “Who will finance it?” but, rather, “Who will have the skills to design, build, and operate it?”

Despite these findings, four caveats are warranted. First, the above analysis may still be subject to statistical bias if, for example, confounders vary with time, whereas reverse causation (for example, that LCT imports cause increases in human capital) appears unlikely but cannot be ruled out (Imai and Kim 2019). Second, given the low variation of dependent variables within countries over time (for example, Government Effectiveness scores do not change much, perhaps reflecting the path-dependent nature of institutional quality), interpretation should be confined to marginal changes, rather than huge, systemic changes in national capability (Mummolo and Peterson 2018). Third, quantitative approaches have inherent limits compared with qualitative methods, such as surveys or case studies. Qualitative methods, although harder to generalize, can incorporate a richer variety of contextual considerations, especially when considering the interactions with policies (Kemp and Pontoglio 2011). Finally, the above analysis of capabilities says nothing about

how those capabilities can change over time. Specifically, it does not tell us much about policies.

Given the necessity and opportunity for LCT deployment, what policies can developing countries implement to accelerate LCT diffusion or production? The next section turns to policies, highlighting how developing countries can enact policies to import and diffuse, as well as potentially produce and export, LCTs. First, the section discusses the varying initial conditions of developing countries, with country “types” identified. Second, it outlines varying objectives of countries. Third, it introduces a policy typology that links country types to objectives. The following section therefore turns to a more qualitative assessment of policies, identifying instruments that countries can implement to achieve their specific objectives for LCT diffusion or production.

## **POLICIES FOR LCT TRANSFER**

### **Policy rationale and features: Market failures**

The economic justification for government intervention in technology traditionally focuses on market failures that lead to socially suboptimal levels of investment in technology (table 5.6). Put simply, multiple market failures hold back technologies on every step of the technology-transfer staircase (from import of foreign technologies all the way to indigenous invention and export). These failures prevent firms from investing in developing and transferring technologies that would otherwise be socially desirable.

All market failures are not equal: they vary in their significance across the technology development chain. Market failures can be partial or complete, or even nonexistent, for specific technologies (Krupnick et al. 2010). For example, network externalities may be a more significant barrier for investment in utility-scale solar (which relies on the preexistence of a reliable electric grid) than for off-grid solar systems (which are stand-alone). Financial frictions may be more important for deployment stages, where private finance seems to matter more, than in the early innovation stages where state-owned or state-controlled companies play a more significant role (Mazzucato and Semieniuk 2016).

In addition, our knowledge of these market failures, and the degree of consensus on their importance, is also not equal. Less is known, for instance, about the deployment and diffusion stages of innovation (the first steps on the technology-transfer staircase) than about the R&D stages (Mazzucato and Semieniuk 2016). The importance of intellectual property rights, and the effectiveness of measures designed to protect intellectual property, remains controversial (refer to chapter 1 and to Rai, Schultz, and Funkhouser 2014). Finally, in the realm of imperfect information and inattention, the energy efficiency paradox has been hotly contested, with some studies questioning its existence (Allcott and Greenstone 2012; Allcott and Knittel 2019; Jaffe and Adam 1994), and others showing evidence of such an effect (Coste et al. 2019).

### **Government failures**

Market failures, which lead to underinvestment in LCT within and across countries, justify government intervention. These market failures can be tackled by

pushing down costs (for example, through R&D subsidies), pulling up demand (such as through feed-in tariffs), or through informational interventions such as green labelling and public information campaigns. The particular instruments that are suited to overcome market failures are highly context-specific and will change over time (Altenberg and Assmann 2017).

Five caveats are noteworthy, however. First, developing countries are in a disadvantageous position when it comes to both diffusing and producing LCTs. As earlier sections of this chapter have highlighted, despite the potential opportunity—and necessity—for all countries in globally deploying LCTs, developed countries are better placed with deeper stocks of the needed inputs for trading and producing LCTs. Compounding this disparity is the reality that developing country policy makers face more market failures impeding innovation and perversely have less capability to address them (the “innovation policy dilemma”; Cirera and Maloney 2017).

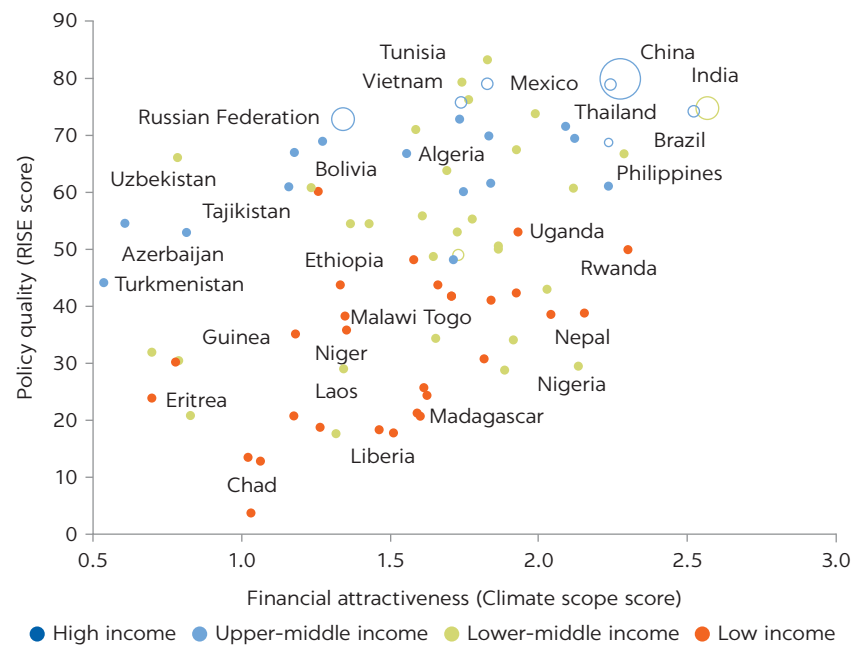
Second, developing countries have very different starting positions. For instance, China is a significant outlier in terms of innovation outputs and the intensity and complexity of its low-carbon exports compared with other developing countries (figure 5.13). It therefore has an advantageous position compared with other countries for the production and export of LCTs (latter stages of the technology-transfer staircase). In general, countries that are more well-placed to take advantage of LCT export opportunities are those that are already innovative.



Countries are also in different starting positions in terms of their ability to import and diffuse LCT (figure 5.13). For RE specifically, countries vary in their attractiveness to private investors and in the quality of existing policies for renewables. China is again at the frontier among developing countries, but it is joined by Brazil, India, Mexico, and Thailand. From a climate mitigation perspective, it is good news that these countries are at the upper end of the RE deployment spectrum: together, these countries account for two-thirds of developing country emissions. Some countries are less attractive to private investors in RE or have policy environments less conducive to RE deployment. Many Commonwealth of Independent States countries, for instance, have moderate or high policy quality but low financial attractiveness for RE investment, so they may fail to attract financing. By contrast, many countries in Africa and South Asia have moderate financial attractiveness but lack the policy quality required for a large-scale ramp-up in renewables deployment.

Third, the traditional focus on market failures as a justification for intervention obscures a central reality: governments have already been intervening and failing. To the extent that states and markets are codependent, as well as path-dependent, existing institutional structures help predetermine future economic outcomes (Mazzucato 2015). The fact that helping accelerate LCT diffusion and development invariably requires policy changes points to the insufficiency of existing interventions: globally, policy is currently biased in the direction of unsustainability.

Worse, because of the path-dependent nature of investment, historical policy failures have helped lock in a carbon-intensive structure of economic production well into the future (“carbon lock-in”). Economies and the policy mixes that direct them “co-evolve” (Edmondson, Kern, and Rogge 2018). Economies are complex systems, and the technological frontier changes slowly on the basis of historical incentives. Accordingly, the fossil fuel subsidies mentioned earlier have helped lock in a global path of carbon-intensive economic development (Grubb 2014), and create what some have called a “techno-institutional complex” of fossil fuel–dominated energy mixes (Unruh 2002; Wilson et al. 2012). As a result, corrective interventions need to be much stronger—and potentially costlier—than they otherwise would have been.

Fourth, LCT faces strong obstacles in the form of multiple market failures. For example, carbon-intensive energy production leads to negative externalities (such as air pollution and climate change), which are not internalized in prices. Only 20 percent of global GHG emissions is covered by a carbon price well below the US\$40–80 required by 2020 for achieving the Paris Agreement goals, for example (High-Level Commission on Carbon Prices 2017; World Bank 2019). In addition, as with all technologies, firms investing in low-carbon energy production technologies may not be able to internalize all of their benefits and will therefore tend to underinvest.

As a result, a single policy instrument may not be effective in isolation or may need to be so stringent as to be overly costly. For example, a corrective tax—such as a carbon price set at the right level from incumbent carbon-intensive energy producers—may not be high enough to allow low-carbon energy producers to innovate, enter the market, and compete. As a result, even with a carbon tax, the energy sector may not decarbonize. Further, relying only on taxes as an instrument may necessitate overly high carbon taxes to allow new low-carbon market entrants.

The existence of multiple market failures of LCT necessitates multiple interventions through policy mixes. For negative environmental externalities—whereby prices do not reflect social costs from energy production—a corrective tax or tax-like instrument (like an emissions trading scheme) may be the most effective instrument warranted. For knowledge spillovers—whereby firms cannot internalize all the benefits of innovation—subsidies for low-carbon R&D may also be needed. Finally, for scale economies and network effects, the government may need to provide strong support through preferential feed-in tariffs while investing directly in complementary infrastructure, such as electricity grids that can support the heterogeneous characteristics of renewables. As a result, policies need to be combined into mixes, varying in terms of both their economic efficiency and their political and administrative feasibility, across country contexts (IEA 2017b).

Fifth, in enacting policies to address market failures, governments can also fail. Government policy is not set in stone, and can be subject to amendments, changes, or even complete reversals. Firms and households know this in advance, and therefore incorporate the risks of policy changes into expectations of future revenues and costs (Dixit, Pindyck, and Dixit 1994), and they underinvest relative to what they would have without this uncertainty. As a result, some claim that “government-induced policy risk is the biggest deterrent to [low-carbon] investment worldwide” (Stern 2016). By contrast, reducing uncertainty about the future for firms by ensuring that policies are credible, reliable, and consistent can help accelerate LCT diffusion (Pfeiffer and Mulder 2013).

Overall, the strong case for government intervention to support LCT diffusion and production comes with certain stipulations. Countries come from diverse starting positions, so policies should be tailored to country circumstances and policies that, at present, are biased toward fossil fuel-intensive consumption and production. To be effective and efficient, policies must also be packaged in mixes of supporting measures addressing multiple, separate market failures. These policy mixes should be as consistent and reliable as possible to maximize their effect on fostering positive incentives toward LCTs. When enacting such policy measures, governments need to carefully manage any economic rents generated, to ensure that policy support is temporary—and known to be temporary—rather than permanent.

### **Government objectives**

Governments have diverse objectives, including for LCT transfer. Some governments may simply want to deploy RE specifically to meet rising energy demand. Many countries in the world with the lowest energy access, at present, also have among the highest potential for solar energy, especially in Africa (Kabir et al. 2018). Deployment of solar-based renewables would be a win-win in these contexts, raising access to energy while mitigating climate change. Similarly, countries may seek to deploy energy efficiency technologies to induce investments in those very technologies, thereby helping domestic firms become more cost competitive (Coste et al. 2019).

Government objectives for LCT transfer can include deployment, production, or both. Countries seeking to deploy LCT may be called “strong deployers.” By contrast, governments in other countries may see LCT as predominately an opportunity for export-led growth. Such countries may wish to develop domestic industries in LCT, thereby potentially reaping productivity gains from industrialization. These countries might be labeled “strong industrializers.”

Last, governments may want to deploy and produce LCT jointly. Objectives of domestic LCT production and deployment can be synergistic, especially for large countries. For large markets, deployment can mean the generation of a large domestic market, which benefits LCT producers through the achievement of scale economies. Countries seeking to achieve both deployment and production of LCT might be called “green industrializers.” Despite multifaceted government objectives, these three simplified categories can help countries identify policy mixes for LCT transfer.

### **Policy typology**

A plethora of policies can be identified to help facilitate the deployment or production of LCTs. At the lower end of the technology-transfer staircase (import and diffusion of foreign LCT), policies can be identified to overcome the market failures that prevent LCT deployment. To address negative externalities, policies such as carbon pricing and environmental taxes can help rebalance incentives away from fossil fuel-intensive technologies and toward LCT. For imperfect information and inattention, governments could engage in informational campaigns, subsidies for energy efficiency investment, and direct regulatory measures (like performance standards).

At the upper end of the staircase (indigenous invention), policies can be identified to address negative externalities that prevent investment in innovation and

development of industries. For instance, innovation policies such as R&D subsidies, publicly supported venture capital and government-backed loan guarantees can help firms overcome increasing market failures due to knowledge spillovers, increasing returns to scale, and network externalities (a summary of 1,600 empirical studies on innovation policies can be found in appendix E, “Empirical Evaluations of Innovation Policy Instruments.”) For governments seeking to proactively support specific sectors, policies can be identified for a controversial area of policy making: industrial policy.

Policies for LCT transfer can be distinguished on two dimensions: the instrument mechanism (systemic, demand-pull, and tech-push) and the type of national capability they primarily raise (human, organizational, institutional, physical, or financial capital).

First, on the mechanism of instruments, policies can accelerate technology transfer by fostering a more supportive environment at the system level (systemic policies), creating demand for technologies (demand-pull), or more proactively supporting the supply side of technologies (“tech-push”; Rogge and Reichardt 2016). For example, demand-pull feed-in tariffs increase the expected future revenues of renewables investment, creating more demand for solar panels and wind turbines. By contrast, tech-push regulations, like mandates for clean technologies in power generation (for example, sulfur dioxide scrubbers in coal- and gas-fired power plants), force the adoption of specific technologies.

Second, policies affect different levels of national capability needed for technology transfer. For example, expenditure policies that provide subsidies for energy efficiency investments can raise capability among firms by expanding firm-level knowledge and absorption of such technologies. By contrast, direct provision of complementary infrastructure, such as smart grids or electric vehicle charging stations, raises the level of physical and institutional capital—that is, the business environment faced by firms.

Note that this typology is neither mutually exclusive nor collectively exhaustive. Policies can have multiple mechanisms and affect multiple types of national capability. For example, tax policies can raise the human and organizational capital needed for LCT transfer (by making energy efficiency savings more salient and increasing adoption and therefore knowledge of LCT), while also raising institutional capital (as national and local governments gain knowledge of such technologies through absorption). Distinguishing policies according to their primary mechanism and the national capability targeted can help policy makers better target recommendations towards specific objectives, technologies, and countries.

Accordingly, the next section further develops this policy delineation, providing recommendations to policy makers on optimal policy mixes given their diverse objectives and circumstances.

## RECOMMENDATIONS

Whether governments are seeking primarily to deploy LCT (initial steps of the technology-transfer staircase) or produce LCT (higher steps) will elucidate the general policy mix they should adopt. For instance, governments seeking LCT deployment should focus on policies that facilitate the first two steps of the technology-transfer staircase (adoption and diffusion), focusing principally on demand-pull policies. Governments seeking LCT production should focus on

implementing policies that facilitate rising to the upper steps of the technology-transfer staircase (imitation to indigenous invention), which entail mostly tech-push policies. Countries seeking both deployment and production should focus on further strengthening systemic policies beyond those entailed by seeking deployment and production alone. This section provides recommendations for policy makers based on their respective objectives for LCT. General recommendations are provided on policy mixes, followed by specific suggestions for policy makers seeking LCT deployment or production, or both.

### **1. Be consistent, coherent, credible, comprehensive, and strategic**

As noted earlier, the multiple market failures in technology markets give rise to a need for combining policies together into mixes. Key design features of the mix and of each instrument matter, potentially more than the selection of policies in the mix (Kemp and Pontoglio 2011). There is a burgeoning “sustainability transitions” literature on such policy mixes, which blends findings from environmental economics, policy studies, and national innovation system or technological innovation systems studies, identifying a number of core components for ensuring the effectiveness of policy mixes (Cunningham et al. 2013; Kern, Kivimaa, and Martiskainen 2017; Rogge and Reichardt 2016; Schmidt and Sewerin 2018).

Policy makers must first carefully consider the stringency of each instrument and balance across instruments. Relying only on a single instrument may not facilitate the government’s desired end objective, or that instrument may need to be so stringent as to carry politically unacceptable costs. In addition, an unbalanced policy mix—that is, one that overly relies on one or two instruments—is less likely to address all the issues relevant for policy objectives, and hence is less likely to be effective (Schmidt and Sewerin 2018).<sup>16</sup> In order to be effective, policy mixes should be balanced across instrument types in relation to the objective (Hallegatte, Fay, and Vogt-Schilb 2013). For instance, policy stringency could vary relative to the perceived scale of the market failure the mix seeks to address.<sup>17</sup>

Second, policy mixes should be internally consistent and the processes underlying them coherent. Policy mix consistency is the property of alignment between the objectives of the instruments, individually and collectively. Mixes should provide a diagnosis of the problem, identify the beneficiaries of the intervention, and compose instruments that reinforce rather than contradict each other (Cirera and Maloney 2017; Kern and Howlett 2009). Policies can often send contradictory signals to markets. For instance, many countries have subsidies for fossil fuels as well as for LCTs, which can undermine the overall effectiveness of policies at achieving their objectives. Policy process coherence here refers to alignment between the processes of design, implementation, and enforcement of policies with their underlying objectives (Rogge and Reichardt 2016). To achieve an effective mix, policy makers need the capability to create consistent policies, and governance structures need to implement and enforce them in a manner aligned with the mix’s underlying objectives (Kemp and Pontoglio 2011).

Third, policy mixes should be both credible and comprehensive. They need to be credible by being both durable and, *ex ante*, perceived to be durable, which entails both well-signaled intention and substantive action by policy makers (Rogge and Reichardt 2016). To be comprehensive, mixes should comprise

enough instruments to address all the relevant market failures, in addition to any institutional or system failures.

Fourth, to help ensure policy credibility, policy mixes should take account of political economy dynamics. For instance, the policy mix could be designed to create incentives among beneficiaries to maintain political support for the policy over time (Edmondson, Kern, and Rogge 2018) while avoiding concentrated costs on organized and politically powerful actors.

Fifth, instruments in the policy mix should collectively target areas where they can make the most impact. Because of technology market failures—for instance, the existence of scale economies and network effects—nonlinearities exist in LCTs, which can significantly affect their deployment or production. For RE, however, the existence of “tipping point” costs can mean that renewable capacity can be deployed rapidly, or not at all. For example, in South Africa, renewables costs have declined so significantly (along with energy efficiency improvements) that new RE installations will “provide more than sufficient capacity to cover projected demand and decommissioning of [coal] plants” (Department of Energy 2018).

Sixth, policy mixes should be designed and implemented as part of a long-term strategic vision. Strategic plans, and their long-term signaling, are important for reducing uncertainty while providing a sense of direction to households and firms, especially when it comes to investments in new technologies that entail large risks and up-front capital costs like some LCTs (Grubb 2014; Mazzucato 2016). Increasingly, governments and others are using long-term plans to encourage LCT deployment and production (Altenberg and Assmann 2017).

## 2. Get systemic policies right

Policies in the mix can be defined by their primary mechanism (systemic, demand-pull, or tech-push) and the national capability they most affect (table 5.7). Countries should first focus on getting the overarching systemic policy environment right. For all countries, irrespective of their specific objectives, it is important to get the underlying systemic framework aligned with the overall policy objectives. Otherwise, targeted measures are likely to be ineffectual. For example, if fossil fuels are heavily subsidized, then labeling programs are unlikely to be effective at driving deployment and targeted grants ineffective for helping firms make low-carbon innovations. As a result, all countries should work to ensure that systemic incentives facing the private sector are aligned with the overall policy objectives before embarking on demand-pull or tech-push policies.

As a priority, all governments should get energy prices right through fiscal policy. Pricing is the most important single instrument for affecting systemic, economy-wide change through the incentivization of LCT deployment or production (Parry et al. 2014). By reducing or eliminating fossil fuel subsidies and implementing carbon pricing, governments can systematically shift the incentives faced by firms and households—not only encouraging statically efficient reduction of emissions through abatement in least-cost locations but also helping foster dynamic efficiency by encouraging investment in innovation. Faced with increasing input costs for fossil fuel-based energy, most firms and households will choose either to abate emissions (for example, through import and adoption of existing LCTs) or to otherwise pay the tax. Some will choose,

however, to innovate in LCTs, for example creating more-efficient energy capital goods or cheaper low-carbon energy supply goods.

By contrast, nonpricing instruments—such as performance standards or technology mandates—may not provide the dynamic incentives needed for innovation. As a result, such nonpricing measures may lock in existing technologies, forestalling a more efficient and socially desirable low-carbon transition. By contrast, tax policies can help firms and households deploy LCT while also fostering innovation. These policies push the technological frontier itself (Grubb 2014; IEA 2017b), while also pushing firms toward the existing technological frontier. As a result, all policy makers should prioritize getting energy prices right through socially efficient taxation.

That said, pricing policies cannot address all market failures, and political economy obstacles to pricing remain large in many countries. Significant opposition to pricing reforms may exist because of, for instance, the salience of fossil fuel energy, the politically powerful position of fossil fuel-based and energy-intensive sectors, or often misplaced concerns over the distributional effects of such reforms (Baranzini et al. 2017; Dolphin, Pollitt, and Newbery 2016; Hallegatte, Fay, and Vogt-Schilb 2013; Mathys and de Melo 2011). As a result, nonpricing instruments remain important complements to pricing policies.

Nonpricing systemic reforms can also help accelerate LCT deployment and production. Investing in human capital, particularly in educational outcomes, is

especially important for increasing the capability of firms and households to deploy and produce LCTs. Such investment could be funded, for example, through environmental taxes (for example, on CO<sub>2</sub>, fine particulate matter, and sulfur dioxide). Externalities can offer a less economically distortionary source of revenues compared to capital or labor taxes, which can be especially costly in developing countries by increasing informality (Bento, Jacobsen, and Liu 2018; Erasmo and Moscoso 2012; Heine and Black 2019; Loayza 2018).

In addition, countries should pursue low-carbon capital deepening. Given the pervasive presence of multiple market failures in LCT and the need for complementary infrastructure—because of scale economies and network effects—countries should invest directly in low-carbon infrastructure. This infrastructure includes low-carbon public transportation and renewable-friendly energy infrastructure, which can provide a basis for LCT deployment and production while also raising governmental knowledge and awareness (institutional capital).

Last, developing countries should seek to foster private investment in LCT deployment through derisking mechanisms. As noted above, firms in developing countries tend to underinvest in technology, including in LCT. Access to finance plays an important part: although the returns to investment in technologies should be higher in developing countries than in developed countries, in fact several perceived and actual risks reduce expected returns for investors (Waissbein et al. 2013). As a result, financing costs may be prohibitively high, rendering investment in LCT. Countries therefore need derisking instruments to crowd in the private sector (Waissbein et al. 2013). Derisking instruments seek to remove the underlying causes of policy risks, such as uncertainty in RE policy design or institutional volatility. Examples include loan guarantees, public equity co-investments, and political risk insurance.

No one-size-fits all approach exists for derisking, given the diversity of market conditions and capability across countries. For example, UNDP (2017, 2018) analysis suggests that in Tunisia the largest sources of additional risk to equity investors into renewables are grid/transmission risk (an additional 1 percentage point to the cost of equity) and currency/macroeconomic risks (1 percentage point), whereas in neighboring Lebanon the highest-cost risks are political (1.7 percentage points) and power market risk (1.5 percentage points). Because of this heterogeneity, countries should seek to identify the underlying risks faced by potential LCT investors (for example, in renewables) and implement matching policy and financial derisking instruments.<sup>18</sup>

### **3. For LCT deployment, mix demand-pull and technology-push policies**

Beyond the needed base of systemic policies, especially pricing, policy makers seeking LCT deployment should vary demand-pull and tech-push policies by the specific technology. Countries have built up a rich experience of policies for low-carbon deployment, and broadly find that different technologies respond to policies in varying ways. Generally, LCT deployment requires strong demand-pull policies, but effective policies vary by technology type and may need to be supplemented by tech-push policies in the short or long term. For example, LCTs in energy and transport appear to respond more strongly to certain types of demand-pull policies in the short term, though policy makers should also implement tech-push policies for the long term. By contrast, industrial and



building LCTs may respond more strongly in short-term deployment to tech-push policies, though strong demand-pull policies are needed in the long term.

In the energy sector, removing coal provides a particularly promising opportunity to reap welfare gains in the short and medium term. A major polluter in terms of both local air and water pollution Coal negatively affects the health of local populations, with costs often concentrated on the poorest (Hsiang, Oliva, and Walker 2018), and contributes significantly to global GHGs (Cohen et al. 2017; Landrigan et al. 2017). In addition, many countries import coal, making local power supply costs dependent on globally volatile coal prices. Accelerating energy access while phasing out coal in developing countries would lead to significant improvements in health and welfare, helping governments achieve their Sustainable Development Goals (SDGs) for universal energy access (SDG7), reducing the severe impacts of air pollution (part of SDG3), and mitigating climate change (SDG13).<sup>19</sup> Without reforms, these high-carbon assets and the welfare costs they inflict will likely remain locked in.

A policy mix for reversing the lock-in of coal in the power sector could look as follows. First, government should set a public commitment to a coal phaseout date. Doing so would send a strong signal to markets, preventing investment in additional coal energy assets, which would be at risk of stranding. Second, countries should ensure that prices reflect the social costs of coal-sourced electricity through fossil fuel subsidy reform and taxes like those on CO<sub>2</sub>, fine particulate matter, and nitrous oxide. These reforms would send further signals to investors of the direction of the domestic energy system. Third, countries should embark on power sector reforms conducive to market entry for RE suppliers. Reforms could include tweaking energy auctions to allow for bidding across hours of the day when renewables are especially cost-competitive (for example, during daylight hours for solar), priority and “clean-first” dispatch of renewables in the power sector, and investment in complementary infrastructure like energy storage facilities (box 5.1). Fourth, countries should seek to directly regulate existing plants through, for example, fleet-wide GHG emissions performance standards, and regulated lifetime and carbon capture and storage retrofit mandates (IEA

#### BOX 5.1

### Reforming power markets for renewables

Power market design is one of the major impediments to deployment of renewables. Many developing countries have monopolistic electricity markets at one or more points on the electricity production chain (generation, transmission, and distribution), in addition to long-term (often 20 to 35 years) power purchasing agreements, some of which contain “take or pay” clauses. These frictions prevent entry of renewable energy supply technologies, which have relatively high variability in their levelized costs, as well as up-front capital costs. As a result, the current power sector design in many countries does not suit the large-scale deployment of renewable power.

Reform of the energy market to allow low-carbon technology penetration includes general reform of pricing structures in addition to deeper flexibilization measures. General reforms include energy auction tweaks that introduce spot price signals for investors, to allow pricing based on marginal costs rather than long-term power purchasing agreements. Such reforms can improve the efficiency and reliability of the system overall (for examples from Peru and the Philippines, see Rudnick and Velasquez 2019a, 2019b) and also make the power market more conducive to renewables investment (IEA 2019).

2017a, 2017b). Fifth, governments should provide direct support measures to those negatively affected by the phaseout of coal, including those affected by mine closures (World Bank 2018).

For technologies with low-carbon energy demand, countries should focus on the demand-pull measures mentioned earlier while fostering a domestic market in energy supply companies. Energy efficiency technologies can help address concerns about energy access, security, and environmental protection jointly (Aznar et al. 2019). Such technologies, however, face strong obstacles to penetration: firms may be unaware of the cost savings potential from adopting such LCTs. In addition, firms may be capital-constrained. More efficient energy pricing—for example, through environmental taxation—can help make such cost savings more salient, but informational and capital constraints may remain nonetheless. Energy service companies (ESCOs), buttressed by public informational campaigns (for example, standards and labeling), can help address these frictions through the procurement and installation of energy efficiency technologies as well as the finance to cover them (Fang, Miller, and Yeh 2012; Lee et al. 2003). Governments could also create super ESCOs, which serve as public entities established to help firms realize efficiency gains while also fostering the development of private sector ESCOs (Sarkar and Moin 2018). Joint efforts and partnerships by government, utilities, the private sector, nonprofits, and academia to supply energy efficiency technologies to low-income households can help raise institutional and human capacity (Aznar et al. 2019), both of which are especially important for LCT deployment (refer to the earlier section titled “National Capability for LCT Transfer”), and can help support energy access and distributional objectives.

In the long term, governments should focus on scaling up complementary infrastructure for low-carbon energy supply and demand technologies. Measures include deeper investment in energy storage technologies, better metering networks, and more efficient, integrated, and responsive grid infrastructure (smart grids). Storage and end-use technologies will become increasingly important as renewables penetrate the power sector. Countries should look to invest in long-duration energy storage, including novel forms like flow batteries (Winsberg et al. 2017).<sup>20</sup>

#### **4. For LCT production, focus on tech-push policies and the long term**

Countries seeking to produce LCTs should focus on tech-push, or innovation, policies. A plethora of policies exists to support innovation, and a long literature examines their effectiveness empirically, albeit mostly in developed countries. Unfortunately, despite this history, knowledge on what works remains low for innovation in general and LCT production and export in particular. Invariably, countries embarking on tech-push policies will be taking risks. In spite of the risks, countries can benefit from three broad lessons.

First, countries seeking to climb the technology-transfer staircase and produce and export LCT need deeper levels of capability and more strategic and long-term planning. Innovation and production are notoriously difficult to predict and direct, but countries with higher capability tend to be more innovative. In addition, countries that deepen their physical infrastructure and, especially, raise their human development levels tend to export more LCT.

At the top of the technology-transfer staircase, commercialization and export of indigenous inventions require even deeper demand-pull and tech-pull policies. A pervasive gap exists between new inventions and their commercialization, which prevents new technologies from being widely diffused domestically or exported. Countries with firms reaching this last step on the technology-transfer staircase may need a final push in policy terms to help firms leap this gap. Specifically, this push may entail even deeper demand-pull and tech-push policies. As with industrial policies generally, however, policy makers will need to compare the potential benefits of supporting such early-stage inventors with the risks they create by generating rents.

Second, countries should eschew the ambition to pursue technologically neutral policies (box 5.2). Some policy makers have sought to make innovation policies neutral under the rationale that governments fail and should avoid picking winners. In reality, past and current policies have consistently favored fossil-fuel policies. In addition, technologies face different levels of market failures, with entrant technologies facing more of such obstacles than incumbent technologies. As a result, a technologically neutral approach could simply lock in existing technologies, including fossil fuel-based and energy-intensive technologies. Instead of seeking to *pick* winners, countries hoping to be strong industrializers should instead seek to *create* winners.

#### BOX 5.2

### Why technological neutrality is not neutral

One design feature often sought by policy makers seeking technological diffusion or innovation is technological neutrality, but existing approaches to technological neutrality are rarely neutral. Newer technologies face more and deeper market failures than incumbent technologies. As a result, policies that profess technological neutrality favor incumbent technologies, locking in more mature technologies and forestalling technological change by locking out new technologies (Azar and Sandén 2011; de Mello Santana 2016; Schmidt et al. 2016).

For example, biomass-based power generation (“biopower”) is both more mature than solar photovoltaic and wind and easier to integrate into existing electricity systems. Biomass can be co-fired with coal in existing coal-based power plants and is less intermittent and dispatchable than solar or wind power. As a result, when policy mixes are relatively more neutral, markets tend to choose biopower over wind and solar technologies (Schmidt and Sewerin 2018). A technologically “neutral” approach therefore ends up favoring both more mature technologies (biopower) and supporting incumbent technologies (coal). In addition, by favoring lower-cost abatement options,

technological neutrality may fail to effect the deeper decarbonization required for achieving the Paris Agreement goals (Vogt-Schilb, Meunier, and Hallegatte 2018).

Tackling this problem requires new paradigms that quantify the scale of failures in technology markets. New technologies face multiple compounding market failures, which can forestall the pace of technological change. Addressing these market failures, however, entails some degree of targeting, which is difficult given imperfect information available to policy makers and the uncertainty of the pace and direction of technological change. In addition, overcoming barriers to new technologies requires public investments in the needed complementary infrastructure to overcome network effects and externalities. Such infrastructure investments are costly and irreversible, entailing a loss of “option value” (Avner, Rentschler, and Hallegatte 2014). Economists, and the policy makers they support, should therefore seek new, innovative ways to quantify market failures to aid efforts to accelerate innovation, especially in low-carbon technology, where the necessity and opportunity for deployment are both high.

Creating winners entails adopting a more proactive approach to technology, cognizant of the risks involved with directing technological change. One potential approach is through targeting of specific LCT subsectors with complex products, dense backward and forward linkages, and high-growth potential. Other criteria include learning depth (depth of technology spillovers) and uncertainty over future market size. These and other criteria could be systematically incorporated into targeting of sectors. For example, battery storage technologies are strategic, because they have high global market potential, learning and technological depth, dense links in the value chain, and relatively more growth certainty compared with other LCTs (for example, hydrogen fuel cells). Although imperfect and imprecise, approaches such as these can help policy makers seeking to endogenously innovate, produce, and export LCT to more systematically target sectors for tech-push policies.

Third, governments should focus on facilitating technology intermediaries such as accelerators and technology centers. Governments should not attempt to be artificially technologically neutral given the large differences in market failures faced by different technologies, but they should also not seek to pick winning firms themselves. As noted earlier, picking winners generates large rents and creates perverse political economy incentives through vested interests. Despite justification for government intervention, “creative destruction” is a necessary process in innovation. As a result, governments should seek to create winners through technology intermediaries, such as technology centers or institutes and accelerator programs. These intermediaries can help firms and workers generate the capabilities needed for innovation, such as managerial and absorptive capacities, while fostering positive knowledge spillovers (Cirera and Maloney 2017). In this way, the proactive support of technology intermediaries, and the innovation ecosystems they are embedded in, can help create low-carbon winners while avoiding the risks of generating rents within specific firms.

## **5. For both deployment and production, deepen demand-pull and systemic policies**

The objectives of deploying and developing LCT are not mutually exclusive; for many contexts, they are complementary. Firms and households that deploy LCTs are much more likely to understand and therefore innovate on top of those technologies. For LCT transfer to developing countries, the ultimate goal of technology transfer should be not only deployment, but also “to enhance their endogenous capabilities, which will enable future innovation and ensure long-term adoption of low-carbon technologies” (Liu and Liang 2011). Countries that want to deploy LCTs may also want to produce them, and vice versa.

Countries seeking to both deploy and develop LCT (“green industrializers”) should further deepen their demand-pull and systemic policies. By incorporating higher carbon pricing levels, supported by complementary policies to minimize any trade-offs while addressing hard-to-abate sectors, countries can help foster joint deployment and production of LCT. Further, by supplementing these policies with deeper demand-pull policies, they can help domestic firms realize the scale economies needed to achieve competitiveness in LCT.

Deeper demand-pull policies will be most effective in large markets. As chapter 2 and this chapter have shown, market size matters for both deployment and production of LCT. This could be because, for large countries, the goals of deployment and production are complementary: countries with large markets can reap the scale economies from large-scale national deployment. Large countries that can make use of the complementary nature of the two objectives should therefore seek to be green industrializers, reaping the various benefits of LCT deployment and the productivity gains from industrialization in a potential major growth sector. Smaller countries, which cannot make use of this complementary nature, may nonetheless seek to integrate their domestic markets through regional integration while also being more targeted on strategic sectors of LCT (for example, those with high levels of trade and integration into global value chains).

## **6. Alter policy mixes by national capability, with additional support needed for low-income countries**

Finally, developing countries should alter the policy mix according to their respective national capabilities. As this chapter has shown, national capability matters for determining outcomes in LCT (in terms of import, deployment, innovation, and export), but it varies significantly across developing countries. Poorer countries, in particular, face more and deeper market failures in technology while perversely having lower national capability to address those failures effectively (the “innovation paradox”; Cirera and Maloney 2017). Countries should therefore alter their policy mixes depending on national capability, in addition to other country- and technology-specific considerations.

Less capable middle-income countries should focus on derisking instruments while deepening national capabilities. These countries are simultaneously less able to attract FDI (for example, because of incomplete property rights or pervasive political risks) and less able to use domestic deployment of LCT to support endogenous innovation. Depending on national objectives for LCT (deployment, production, or both), derisking instruments may be especially necessary to attract FDI, whereas national capability-deepening efforts may need to be more strategic, with policy mixes avoiding certain demand-pull measures (for example, green public procurement) because of the risks of regulatory or political capture.

The situation is especially stark in low-income countries, which may be stuck in technology traps. This chapter has argued that climbing the technology-transfer staircase requires ever-deeper levels of national capability. Deepening these capabilities, in turn, requires state capabilities to enact strategic and effective policy mixes. For low-income countries—where national capability, state capabilities, and the ability to attract foreign technology through FDI, patents, or skilled foreign workers are all very low—these obstacles may be virtually insurmountable. Such countries may therefore remain perpetually in a “technology trap” (Fofack 2008), with capabilities far from the global technological frontier. This problem is significantly exacerbated in the context of LCT, which has a set of defining features (such as higher complexity and capital intensity) that make it more capability-intensive to deploy compared with other technologies. Low-income countries in technology traps are likely to be in even deeper LCT traps.

## CONCLUSION

Overall, this chapter has shown both the necessity and the opportunity of LCT transfer, providing recommendations to policy makers in developing countries seeking to deploy or produce LCT. Without transferring LCT to developing countries en masse, the world is unlikely to achieve the Paris Agreement's objectives. This mass deployment is also an opportunity: policies that help deploy LCT—especially carbon pricing—can help countries achieve economic and other development objectives, like improving human health, in addition to reducing GHGs. Additionally, LCT deployment offers an opportunity for countries seeking export-led growth: LCT tends to be more sophisticated with denser linkages along value chains than high-carbon technologies, and global deployment creates the potential for a huge and growing export market.

One particular challenge for global LCT deployment is that national capabilities matter for LCT, and those capabilities vary significantly from one developing country to another. The complementary inputs of human, organizational, institutional, and physical capital appear to matter for LCT transfer across countries. Within countries, human development is the strongest predictor of raising LCT transfer, as proxied by LCT trade intensity. This finding suggests that policies should be aligned with government objectives while raising necessary capabilities in countries. Policies should also be mixed depending on objectives and national capabilities.

That said, the topic of LCT transfer to developing countries is broad, and this chapter has not captured all of its complexities. For example, this chapter has not sought to elucidate in detail the dynamics of political economy, which necessarily constrain policy makers. A large literature exists on this topic, including on the political economy of carbon pricing (see, for example, Dolphin, Pollitt, and Newbery 2016), mitigation instruments (Jakob et al. 2014; Mathys and de Melo 2011), and environmental policies in general (Oates and Portney 2003), but the literature pays comparatively less attention to the political economy of innovation policies.

Finally, future research could more precisely match LCTs to specific developing countries and subnational regions, for instance under the rubric of “smart specialization” (Balland et al. 2018). Despite the plethora of projections for Paris-aligned emissions trajectories, surprisingly few analyses examine what those trajectories mean for trade in LCTs. More precise projections of which technologies are likely to surge in the coming decade, and what countries and regions are most well-placed to take advantage of them, would help provide more granularity on how countries can take advantage of opportunities presented by the low-carbon transition.

## NOTES

1. The definitions of “industrial” and “innovation” policies overlap significantly in the literature. Industrial policies have been defined as measures that encourage “restructuring, diversification, and technological dynamism beyond what market forces on their own would generate” (Rodrik 2004). Under the neoclassical paradigm, innovation policies tend to be framed as measures that remedy market failures, whereas the National Innovations Systems (NIS) literature discusses them as measures that enhance the interaction between governments, industry, and nonmarket institutions to generate new knowledge (Cirera and Maloney 2017).



More recently, “true industrial policy” has been explicitly equated with “technology and innovation policy” (Cherif and Hasanov 2019). This chapter will adopt a mixed and broad definition, referring to policies that aim to accelerate technological adoption and the generation of new knowledge as “innovation policies,” and measures that seek to promote the creation of new industries as “industrial policies,” noting that many policies could be defined as both.

2. There is a high degree of uncertainty on the 1.5°C goal at the 66 percent probability level. Lower levels of probability provide more certainty, but with higher implied thresholds of emissions. For example, to achieve below 1.5°C with a 50 percent probability level, GHG emissions cannot exceed roughly 37 GtCO<sub>2</sub>e, which is only 12 percent lower than the 2°C target with a 66 percent probability level.
3. The gap between the 2°C and 1.5°C targets and existing Nationally Determined Contributions (NDCs) is lower, because UNEP’s (2017) baseline case does not assume that NDCs are fully implemented. The gap between full implementation of NDCs and the 2°C goal is 11.0–13.5 GtCO<sub>2</sub>e for conditional and unconditional pledges, respectively. The emissions gap in the case of 1.5°C with 50 percent probability is 16–19 GtCO<sub>2</sub>e for conditional and unconditional NDCs, respectively.

5. Specifically, authors debate the possibility of reducing GHG emissions while raising economic output or employment (the “double dividend hypothesis”; see Freire-González 2018; Heine and Black 2019). Empirical evidence historically has been mixed. For developing countries, recent studies suggest that “tax shifting” environmental tax reforms (using taxes on carbon to fund reductions in labor taxes) can yield negative abatement costs in many developing countries (Bento, Jacobsen, and Liu 2018; Carson, Jacobsen, and Liu 2014).
6. Note that “co-harms” and trade-offs can also exist within certain mitigation policies. For instance, the installation of scrubbers in power plants to reduce sulfur dioxide emissions can reduce the plants’ efficiency, resulting in increased fossil fuel consumption and therefore GHG emissions. Such co-harms and trade-offs tend to be minor, however, compared with co-benefits (Rizzi et al. 2014).
7. In one cross-country study, a developing country’s having a donor-funded strategic plan for LCT was negatively associated with renewable deployment (Pfeiffer and Mulder 2013).
8. Note, however, that the steps are not mutually exclusive, and graduation from one stage to another does not entail leaving behind all previous stages. In reality, countries can be at different steps of the staircase at the same time. For example, collaborative innovation happens among firms in countries at the most advanced stages of technological development as well.

14. One somewhat concerning finding in regression 2, however, is that a growing per capita capital stock appears to also imply *lower* installed RE capacity per capita. This effect could indicate that existing capital-deepening efforts may not be very green, but the effect did not reemerge under non-fixed effects or random effects specifications, or when using an alternative measure to proxy for physical capital—changes in per capita productive capital stocks from the Changing Wealth of Nations dataset (Lange, Wodon, and Carey 2018).
15. Broadly defined as finance that supports mitigation or adaptation objectives (UNFCCC 2016).
16. Note, however, that early evidence suggests that national policies have less variation in terms of balance across instruments and more variation in terms of specificity of the technologies targeted (Schmidt and Sewerin 2018).
17. Although systematic frameworks for estimating the scale of technology market failures do not exist at present, this conceptualization is similar to how binding constraints are to economic

- growth, as described in the “growth diagnostics” literature (Hausmann, Rodrik, and Velasco 2008). Theoretically, one could envisage technology market failure diagnostics, which examine the relative strengths of technology market failures, adopting similar methods.

  20. Given the variability of production from renewable sources (especially wind and solar), storage is required to allow deeper renewable penetration into the power sector. Possible storage technologies include pumped hydro, compressed air, thermal, flywheel, superconducting magnetic, electric double layer, and electrochemical energy storage systems. Flow or “redox-flow” batteries (RFB) are rechargeable batteries where rechargeability is provided by two chemicals dissolved in liquid and separated by a membrane; they allow for almost instant recharging (Winsberg et al. 2017).

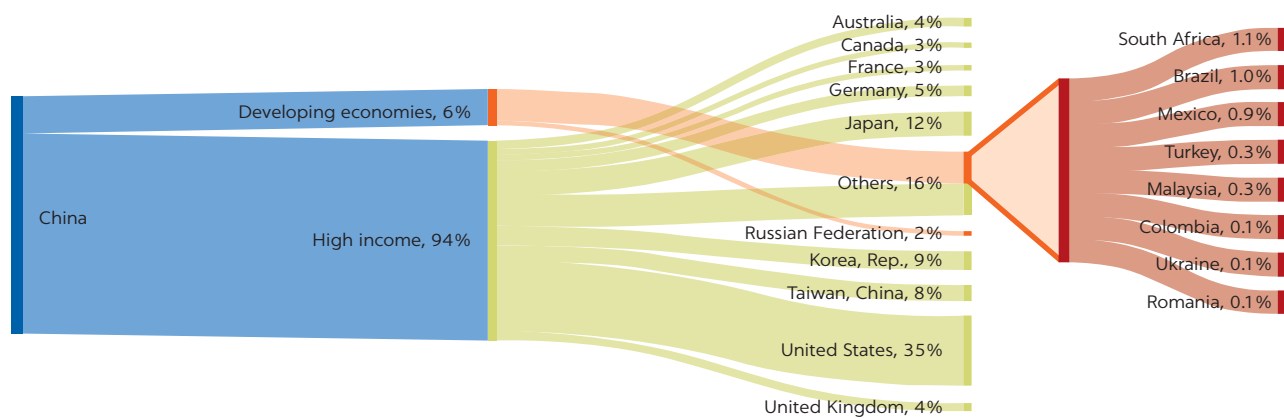

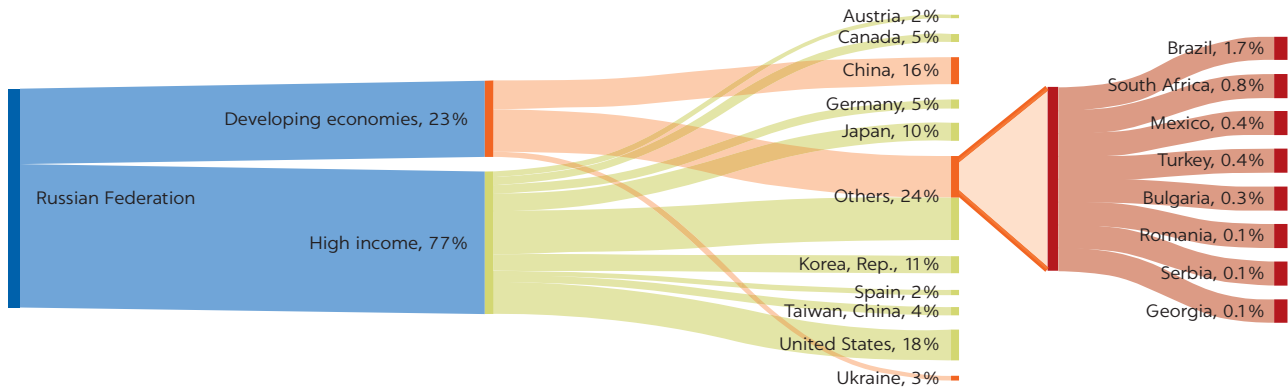
**Distribution of China's outbound LCT patents, 2010–15**

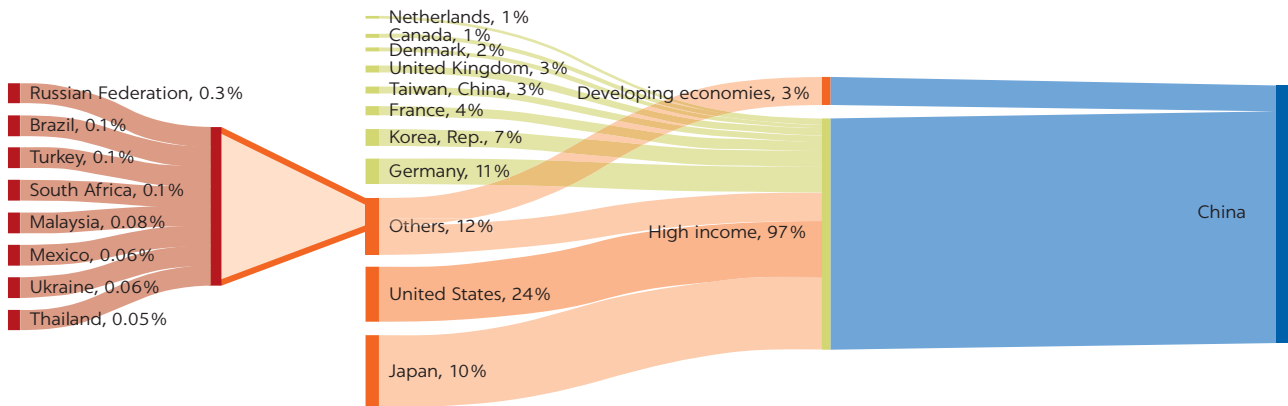

**Distribution of the Russian Federation’s outbound LCT patents, 2010–15**



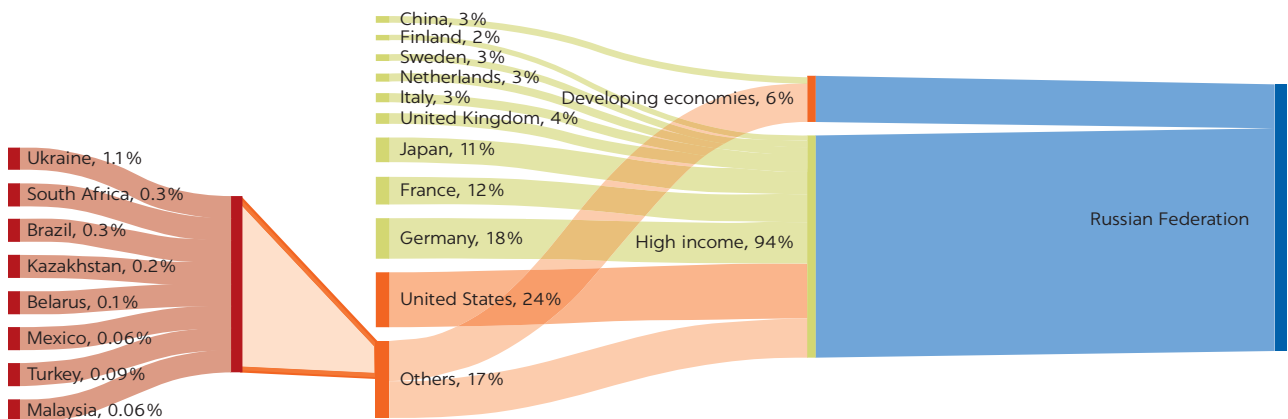

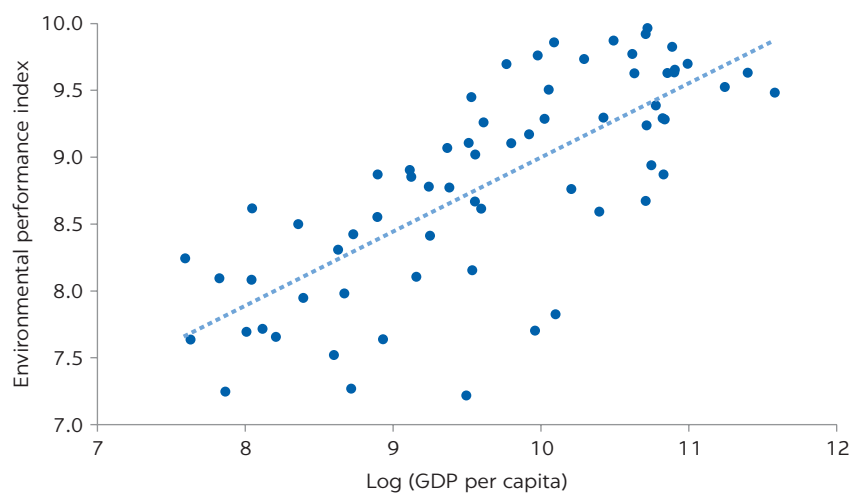

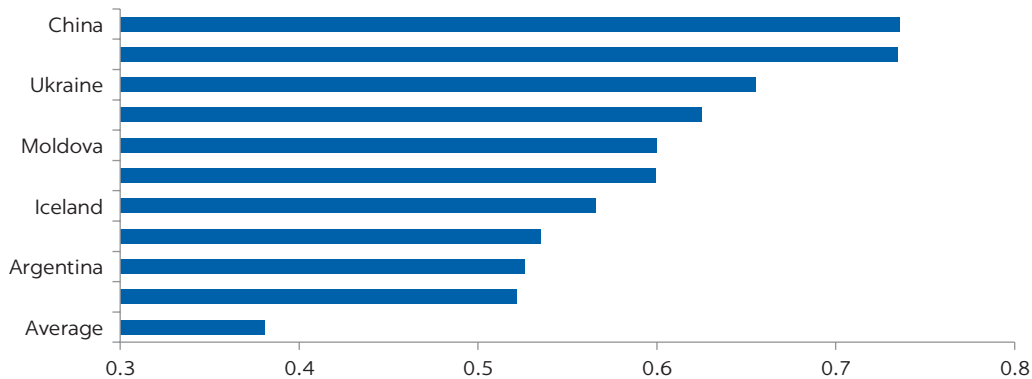

**Environmental performance index and GDP per capita**



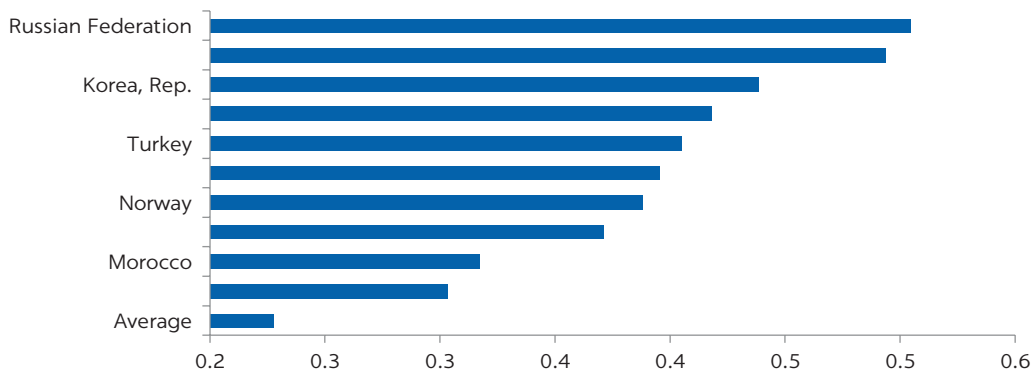

**Countries with the highest levels of FDI controls**



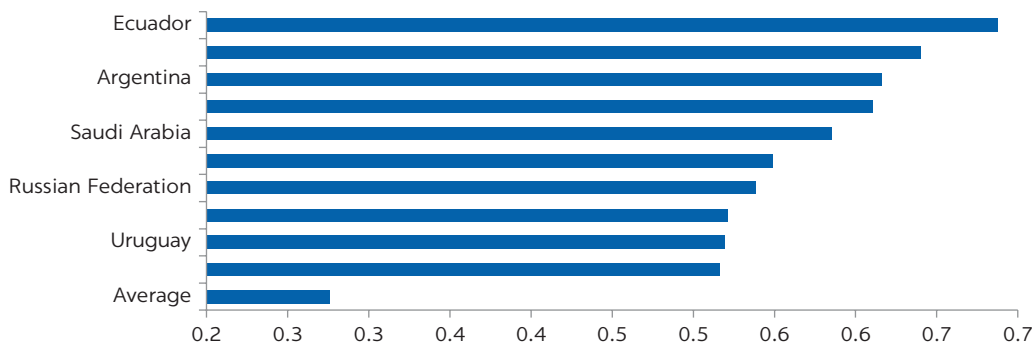

## APPENDIX D

# Low-Carbon Technology in Emerging Countries

### THE REPUBLIC OF KOREA'S APPROACH TO DEVELOPING NEW ENERGY TECHNOLOGIES

Like many economies, the Republic of Korea began focusing on the development of new energy technologies in response to the global oil crises of the 1970s. Korea has very few energy resources beyond some modest reserves of anthracite coal, and with rapid industrialization came the major policy challenge of accommodating an ever-growing demand for electricity by firms and consumers. In the 1970s, Korea was still very much a developing economy, and large-scale investment in the energy sector—for both infrastructure and research and development (R&D)—remained almost exclusively within the purview of the public sector.

Throughout the 1970s and 1980s, successive administrations prioritized energy security. The government elaborated and revised the laws and regulations governing the energy sector, created supportive tax and tariff codes, expanded financial support to build generation and distribution capacity, and implemented technology development and education programs. The 1979 Energy Use Rationalization Act has been continuously revised and updated, steadily increasing the government's financial support for energy conservation and the development of new energy technologies. These policies have helped create demand for new energy technologies, spurring complementary private investment in energy-technology R&D.

Decades of investment and sustained government support ultimately enabled Korea to become an exporter of energy technologies to the global market. The country's success reflects a steady focus on institutional, economic, and technical capacity building to manage the risks involved in technology development and dissemination. Although the public sector has played a key role in this process, rising private sector interest and investment in energy technologies have been vital to the sustainability of energy R&D. The benefits of reducing firms' exposure to volatile oil prices drove much of the early private investment in new energy technology, but new energy technologies were increasingly incorporated into the business-diversification strategies of large conglomerates such as Chaebol. Although initial public support for new energy technology was motivated by oil prices, by the 2000s a growing body of evidence on the role of carbon in climate change became a major force behind public investment in the energy sector.<sup>1</sup>

Korea's approach to developing new energy technologies is not without its drawbacks, however. For example, the government-led project selection process has focused more on the application of existing technology rather than

original research, and Korea's innovation output is relatively low compared to that of Japan. Limited domestic innovation capacity could inhibit Korea's ability to develop state-of-the-art technologies in the future. In addition, the rigid structure of the energy industry, which is dominated by public utilities such as KEPCO and KOGAS, combined with excessively burdensome regulations and non-market-based pricing policies and business practices has slowed private investment in the development and dissemination of new energy technologies.

Energy storage systems (ESSs) are critical to energy efficiency, because technical limitations on the storage and retrieval of excess power are a major source of energy losses. ESSs include batteries and other devices, either chemical or mechanical, that can help overcome the time difference between energy production and consumption. ESS functions can be divided into three main areas: frequency adjustments to stabilize power-supply systems, the stabilization of output from inherently variable energy sources such as wind and solar power, and the storage of excess power for home and commercial use and its retrieval during periods of peak demand.<sup>2</sup>

The wide and expanding range of ESS technologies includes electrochemical storage methods such as a lithium-ion batteries, lead-acid batteries, and hydrogen fuel cells as well as physical storage mechanisms such as flywheel systems and pumped hydropower reserves. Modern lithium-ion batteries are a large-capacity version of the batteries used in smartphones and other consumer electronics. Although the concept of ESS may bring to mind this type of chemical battery, physical storage mechanisms are also an important ESS technology, especially at large scales. For example, pumped hydropower reserves are reservoirs of water filled by pumps powered by excess electricity; to retrieve the stored mechanical energy, these reserves are run through hydropower dams.<sup>3</sup> Hydrogen fuel cells are an emerging ESS technology and are currently being tested for use in small-scale smart grids.

The rapid growth of the global ESS market is driving increased demand for ESS technology in Korea. Korea's ESS capacity grew from 265 megawatt-hours in 2016 to 1.2 gigawatt-hours (GWh) in 2017 and reached nearly 4.8 GWh in 2018. Remarkably, Korea's ESS industry now accounts for nearly 50 percent of the global ESS market. In 2018, Samsung SDI and LG Chem are expected to account for 43 and 37 percent of the global ESS market, respectively—a combined global market share of 80 percent. By contrast, in 2014 these two companies had a combined global market share of 59 percent.

Korea's lithium-ion battery industry has benefitted from significant government support, both directly and as a result of support to precursor industries. Beginning in the 1990s, the authorities strategically fostered the growth of semiconductor, computer, and mobile-device manufacturing. As large firms such as Samsung and LG began to mass produce semiconductors and smartphones, the public and private sectors increasingly focused on the development and mass production of lithium-ion batteries, which are critical to cost competitiveness in the semiconductor and smartphone industries.

The government's response to climate change and the expansion of the smart grid have greatly contributed to the growing demand for ESSs, and public support played a major role in mitigating the risks involved in new ESS projects. New ESS technologies have been installed at a rapid pace since January 2017, when the government introduced a special fare system for ESS, created various financial incentives, and mandated the use of ESS technologies

in public buildings. In part because of these policies, Korea now has 4.8 GWh of installed ESS capacity, roughly equivalent to the output of four nuclear power plants.

In addition to public support, a range of factors contributed to the growth of the Korean ESS industry. Korean firms were able to draw on existing international technologies to develop their first-generation lithium-ion batteries, and their capacity to absorb inbound technology transfer reduced the need for domestic investment in R&D. In addition, Korea has a large number of small firms that can produce ESS components, and competition between these firms has helped to keep costs low.

Despite its impressive progress, Korea's ESS industry faces significant challenges. They include the establishment of model codes and interoperability safety standards, which are vital to enter global markets. Recent accidents involving installed ESS technologies underscore the importance of reinforcing safety measures before deploying these technologies on a large scale.

Korea's experience with ESS development yields three important lessons. First, forward and backward linkages between existing industries and new ESS technologies are crucial, because investments in ESSs are subject to large sunk costs, long lead times, and high levels of market risk. Small-scale investment modalities, such as venture capital, are not well suited to the ESS industry, and the intrinsic costs and risks involved can only be mitigated by backward linkages to ESS-intensive industries such as smartphone manufacturing. Second, the public and private sectors must avoid implementing ambitious projects without first imposing adequate technical verification requirements and safety standards at the manufacturing, transportation, installation, and operation stages. Prioritizing short-term performance over regulatory integrity can lead to serious liability issues. Third, after an initial period of robust public investment the government should scale back its role to focus on creating an enabling policy environment, expanding the ESS market through deregulation and privatization, and mitigating business risks by providing technology and financial support to strengthen the competitiveness of the ESS industry.

## EXAMPLES OF SOUTH-SOUTH TECHNOLOGY TRANSFER

Korea's experience highlights some of the most important challenges involved in LCT transfer. Korea, as well as a few emerging countries in the South, has been a pioneer in South-South collaboration. Do South-South exchanges of knowledge, technical assistance, and technology transfer differ and, if so, in what way from North-South exchanges? This appendix provides a few, illuminating examples of these issues.

Huh and Kim (2018) discuss two projects, the introduction of carbon-capture-and-utilization technology to Bantayan Island in the Philippines and a waste-to-energy project in the city of Santiago in the Dominican Republic. Both projects were implemented by Korea's Green Technology Center between June 2014 and May 2016, in collaboration with domestic and international partners. Both projects failed to successfully transfer their respective technologies, but the experience proved instructive, because it revealed the risks posed by what the study termed "uninformed transfer." The projects were undermined by a lack of cooperation between national and local governments within the target countries, reflecting varying levels of commitment among stakeholder groups.

The analysis found that technology transfer must be informed by a comprehensive understanding of the recipient country's social, political, and economic context, because uneven levels of local ownership can prove as serious a threat to a project's success as any technical difficulty it may encounter.

China's experience with building dams in developing countries sheds light on several important challenges involved in South–South technology transfer. Dam projects are often controversial. They require large amounts of financing, which can have adverse implications for debt sustainability; they entail serious risks to ecosystems and communities; and they are usually driven by a combination of business interests and geopolitical considerations. China's construction of the Bui Dam in Ghana and the Kamchay Dam in Cambodia illustrates the importance of these issues—even for a world leader in the construction of dams in developing economies such as China.

Commissioned in 2013, the Bui Dam was built by the Chinese firm Sinohydro as a turnkey project funded by China EximBank. Sinohydro employed about 3,000 largely unskilled Ghanaian workers, but it provided no additional training or employment assistance after the end of the construction phase. Chinese staff held most of the highly skilled positions, even though the Ghanaian workforce has significant experience in hydraulic engineering. Although the Ghanaian government did not adhere to the requirements of the resettlement planning framework, Sinohydro also failed to respect the construction management plan laid out in the environmental and social impact assessment. Similarly, China EximBank followed its own environmental guidelines, not Ghana's, and it did so in form only (Hensengert 2018).

The Kamchay Dam in Cambodia was also financed by China EximBank and constructed by Sinohydro. The project was based on a build-operate-transfer arrangement under which Sinohydro would build the dam and manage it for 44 years before transferring ownership to the Cambodian government in 2050. Technology transfer via the project was essentially limited to capital goods and equipment, and the project imparted very little in the way of skills, knowledge, or expertise that would enable the Cambodian workforce to independently operate and maintain the dam or to implement similar projects in the future (Urban 2018; Urban et al. 2016). The preconstruction consultation process was incomplete, and it involved little participation from local stakeholders. The dam was successfully installed, but the limited transfer of complementary knowledge and expertise reflected an inadequate supply of workforce skills and organizational competencies in Cambodia, as well as the project's lack of investment in building these capabilities.

A more recent study (Chen 2018) compares two wind power projects in Ethiopia, one by a Chinese firm and another by a French firm, to identify differences between South–South and North–South technology transfer. The two projects are the Adama Wind Farm constructed by HydroChina and the Ashegoda Wind Farm constructed by the French firm Vergnet. The study evaluates three dimensions of technology transfer: (i) the transfer of capital goods and equipment, (ii) the direct and indirect transfer of skills, and (iii) the transfer of knowledge and expertise. Through interviews with key stakeholders and a detailed analysis of the negotiation and construction processes for both projects, the study found that, although HydroChina shared a greater degree of knowledge and expertise with local engineers and university scholars during the construction phase, Vergnet formed stronger long-term links with local universities and employed a larger share of local workers. The study highlights the important

role of the Ethiopian government in negotiating how the technology was transferred and in maximizing its impact. The differing demands and expectations of the Ethiopian government relative to the two foreign firms were primarily responsible for the observed differences in the scope and sustainability of technology transfer that occurred via the two projects.

## NOTES

1. Korea has also benefitted from technological cooperation with Japan, which was further along in the industrialization process for much of the 20th century.
2. ESS technologies typically consist of four parts, a power-conversion unit (PCU), a battery, a battery-management system (BMS), and an operating system. The PCU transfers power to and from the battery; the BMS monitors voltage, temperature, storage capacity, and battery life; and the operating system communicates information between the PCU, the PMS, and the user.
3. Norway is a leader in pumped hydropower storage, because its geography is naturally suited to the technology.

**T**echnological revolutions have increased the world's wealth to a level that was once unimaginable. They have done so unevenly, however, and in ways that have accelerated climate change. *Technology Transfer and Innovation for Low-Carbon Development* argues that most of the emissions reductions required to achieve the Paris Agreement goals can be reached through the global deployment of existing and commercially proven low-carbon technologies (LCTs).

Deploying LCTs from high-income countries—which account for 80 percent of all LCT innovations and 70 percent of all LCT exports—to developing countries, where they are needed most, will not be easy; but the evidence is clear that it can be done. Transferring LCTs is not only necessary to meet the climate targets, but it is also an opportunity to achieve development goals. The policies needed to deploy LCTs to developing countries could raise output and employment while yielding welfare benefits, such as reduced air and water pollution. Moreover, adopting LCT offers an opportunity for countries to benefit from participation in global value chains and to become LCT producers and exporters.
